LOCATION

Amicable House occupies a prominent position on the North side of Union Street, Aberdeen's principal commercial thoroughfare, within the established city centre office corridor. The subjects are well positioned to benefit from significant public and private sector investment associated with Aberdeen City Centre including the ongoing Union Street regeneration project. The property is within walking distance of Aberdeen railway station and more convenient transportation links.

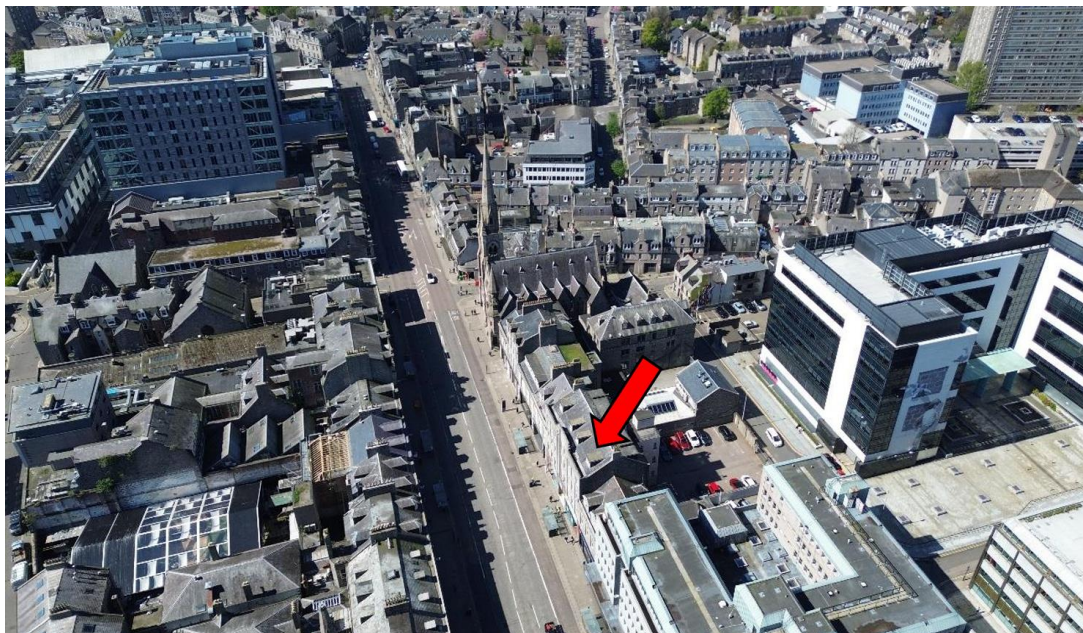
DESCRIPTION

The available accommodation is located on the first floor of Amicable House which is a traditional mid-terraced building arranged over ground, first, second, third and attic floors. The subject comprises of granite construction under a pitched slated roof with secure parking to the rear. Access to the first is given by internal staircase and lift and the property benefits from male, female and disabled toilet facilities on each level.

Internally, the subjects comprise of refurbished, predominantly open plan accommodation. These are carpeted raised access floors, suspended ceilings, incorporating comfort cooling cassettes and Cat 2 lighting. The subjects benefit from timber framed double glazed windows and are decorated to a modern standard.

CAR PARKING

The first floor comes with 5 designated car parking spaces. They are located to the rear of Amicable house accessible from Union Row

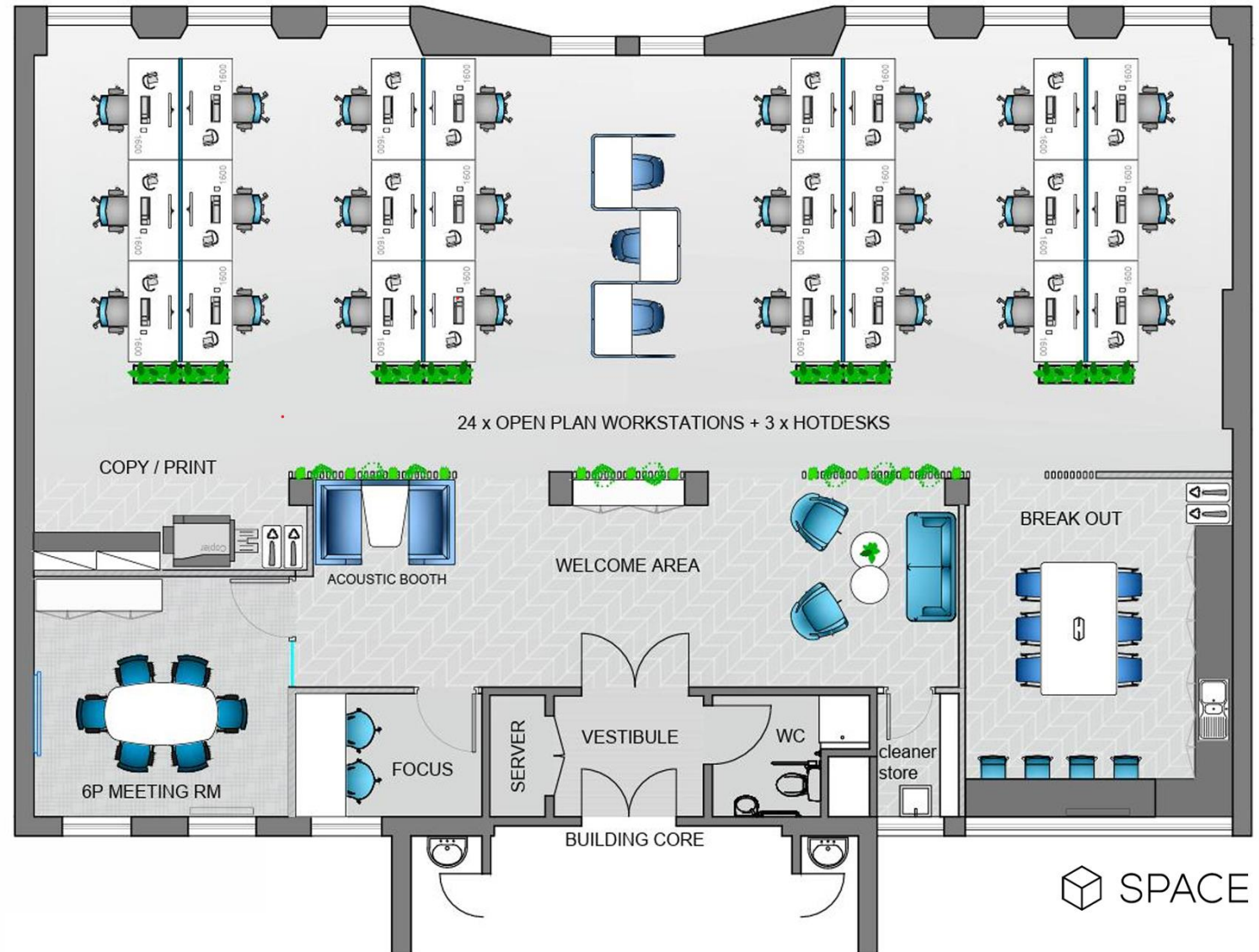

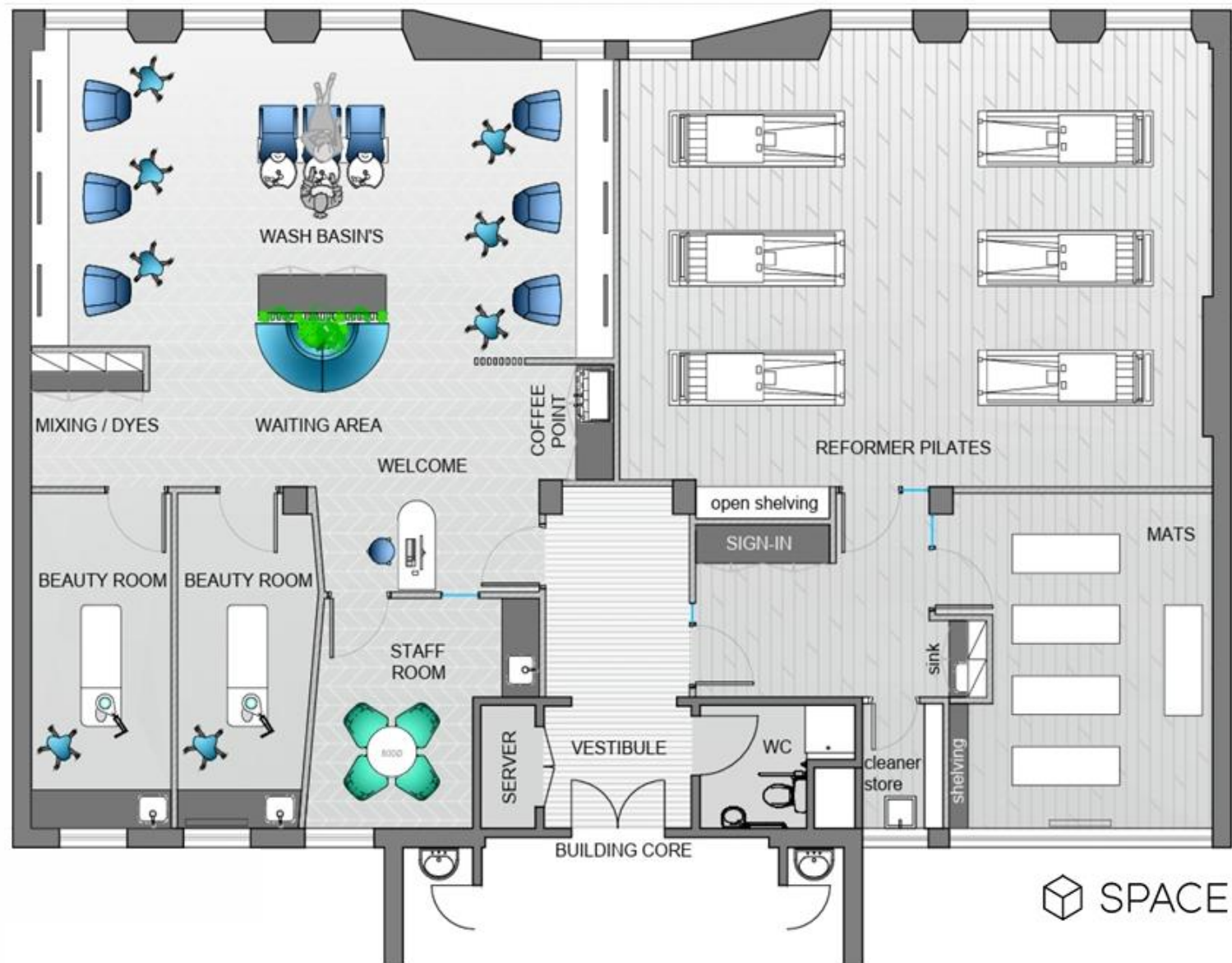
