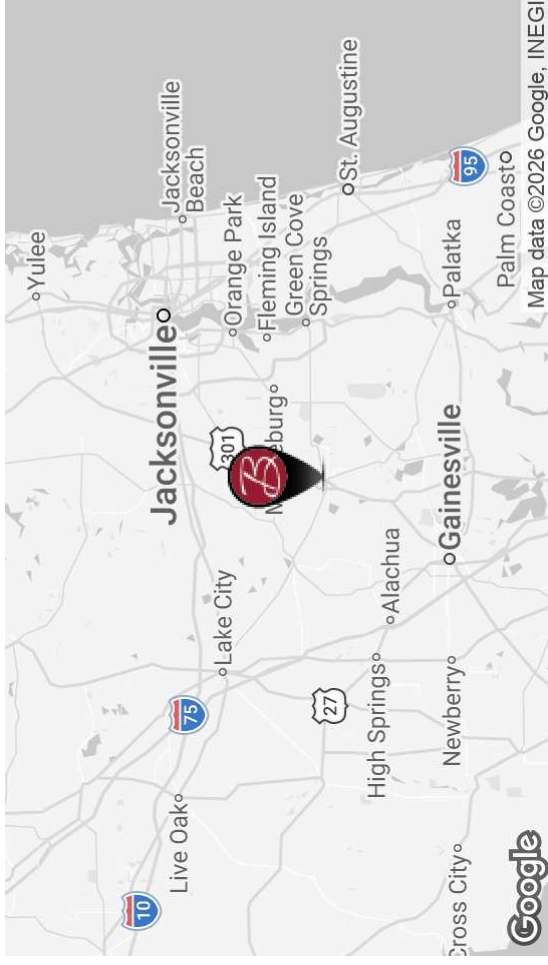

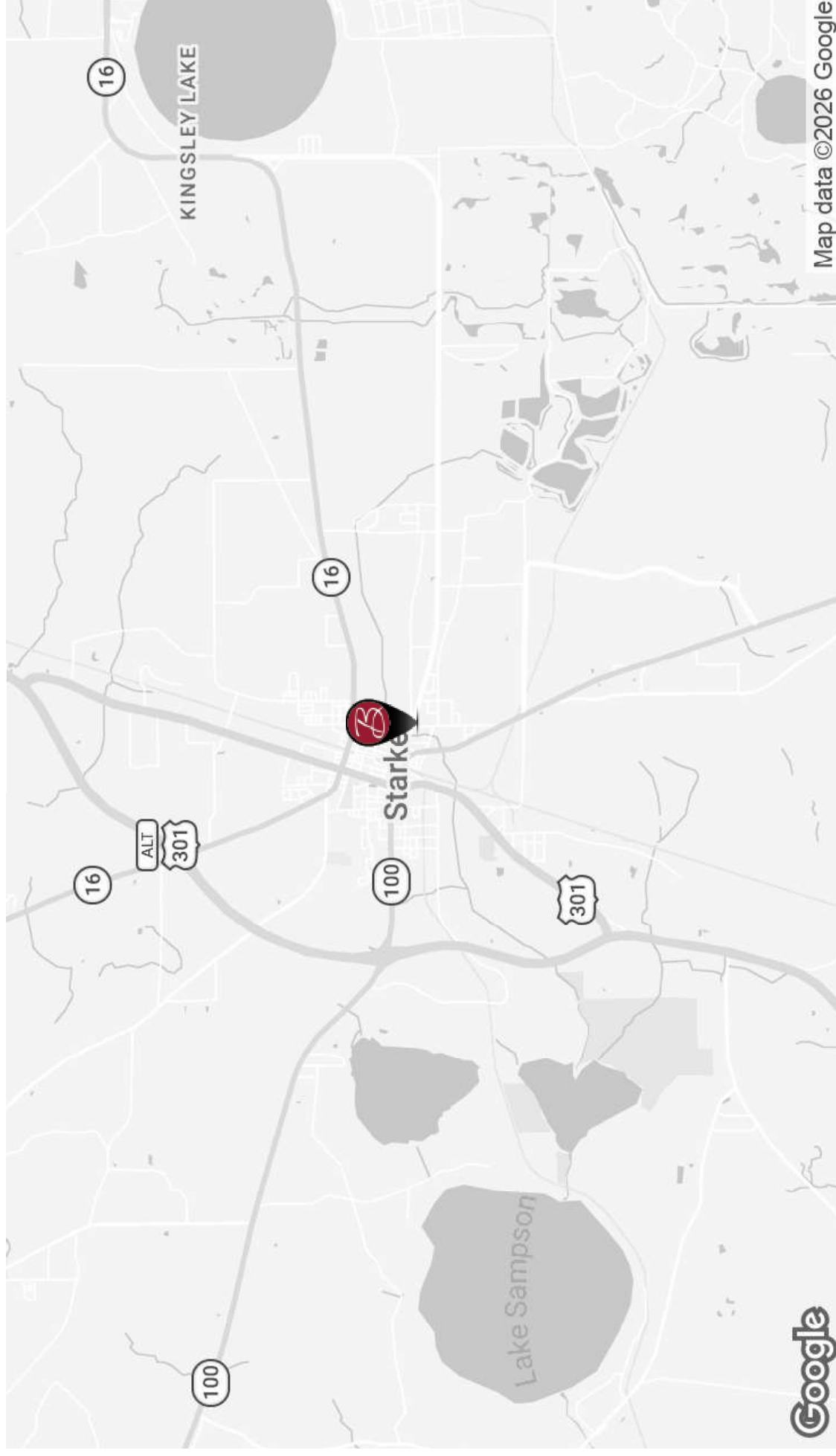

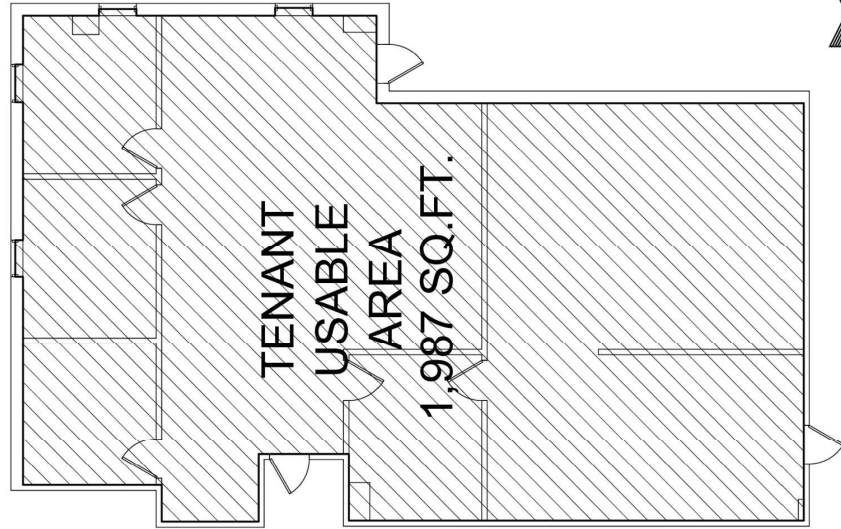

FLOOR PLANS

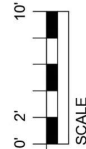

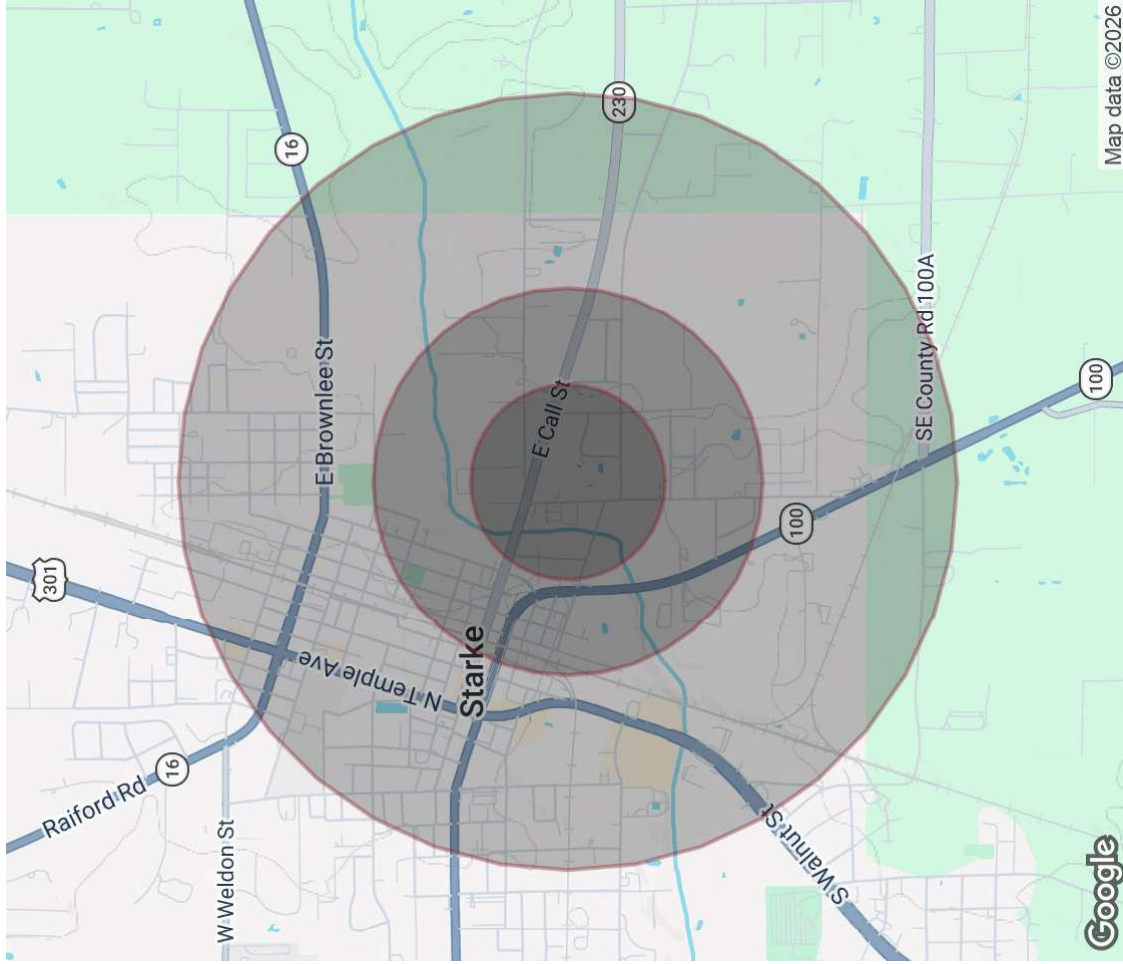
