



**Signature Homes by Adashun Jones**  
**Affiliated Arrangement Business Disclosure**



This is to give you notice that Adashun Jones, Inc. (which does business as Adashun Jones Real Estate and Adashun Jones Commercial Real Estate) and its affiliated company of Signature Homes by Adashun Jones, Inc. and/or shareholders or owners of Adashun Jones, Inc. or other entities, have a business and/or ownership relationship with Schmitt Title, LLC, Green Lake Title, LLC along with others (collectively, the "Companies"). Because of this relationship and ownership interests, referrals may provide Adashun Jones, Inc. and/or its shareholders, a financial or other benefit.

The Companies will likely have estimated charges of \$150 to \$3,500 depending on the price of the property being sold, whether the policy is a new or reissue policy, the amount of the mortgage, and other factors. Total fees will often vary depending on the nature of the transaction, the existence and type of loan involved, prepayment terms and penalty provisions, mortgage insurance requirements, and the type of property. These variances in fee totals are typical in the industry and not connected to the Companies' relationship with Adashun Jones, Inc.

Likewise, should a buyer's purchase be for cash, not involving a mortgage, or should it involve a land contract, the Companies have a customary fee of \$100 to \$500 as a closing fee to the buyer. The Companies may also be retained to collect necessary information (e.g. mortgage payoffs, tax prorations, etc.) and to prepare a closing statement. The Companies may charge \$50 to \$150 for this service.
