SITUATION AND DESCRIPTION

The property is centrally located with ease of access to the remainder of the Town and the beaches and railway station. Dawlish is located approximately 10 miles south of Exeter, 9 miles West of Newton Abbot and 2 miles North of Teignmouth. Road access to Dawlish is principally via the A379 which forms the picturesque coastal route from Exeter to Newton Abbot and onto Torbay. Access to the M5 motorway is available at junction 30 approximately 10 miles away with Exeter offering a wider range of amenities.

The property offers an unusual opportunity to acquire a prominent town centre premises fronting this main road, with the potential to either occupy the premises or let the premises. The shop is arranged as a spacious retail unit at the front leading through to a further showroom at the rear with an Office/ workshop and toilet. The property is suitable for a variety of Retail users, taking advantage of its size and high visibility location, subject to any necessary consents.

The tenants will contribute 33.3% towards the costs of the maintenance of the premises and the buildings insurance, plus £475 every 6 months towards a sinking fund for future expenditure and buildings insurance.

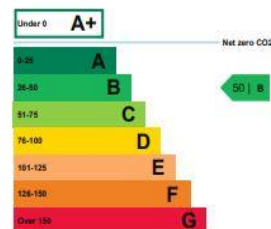

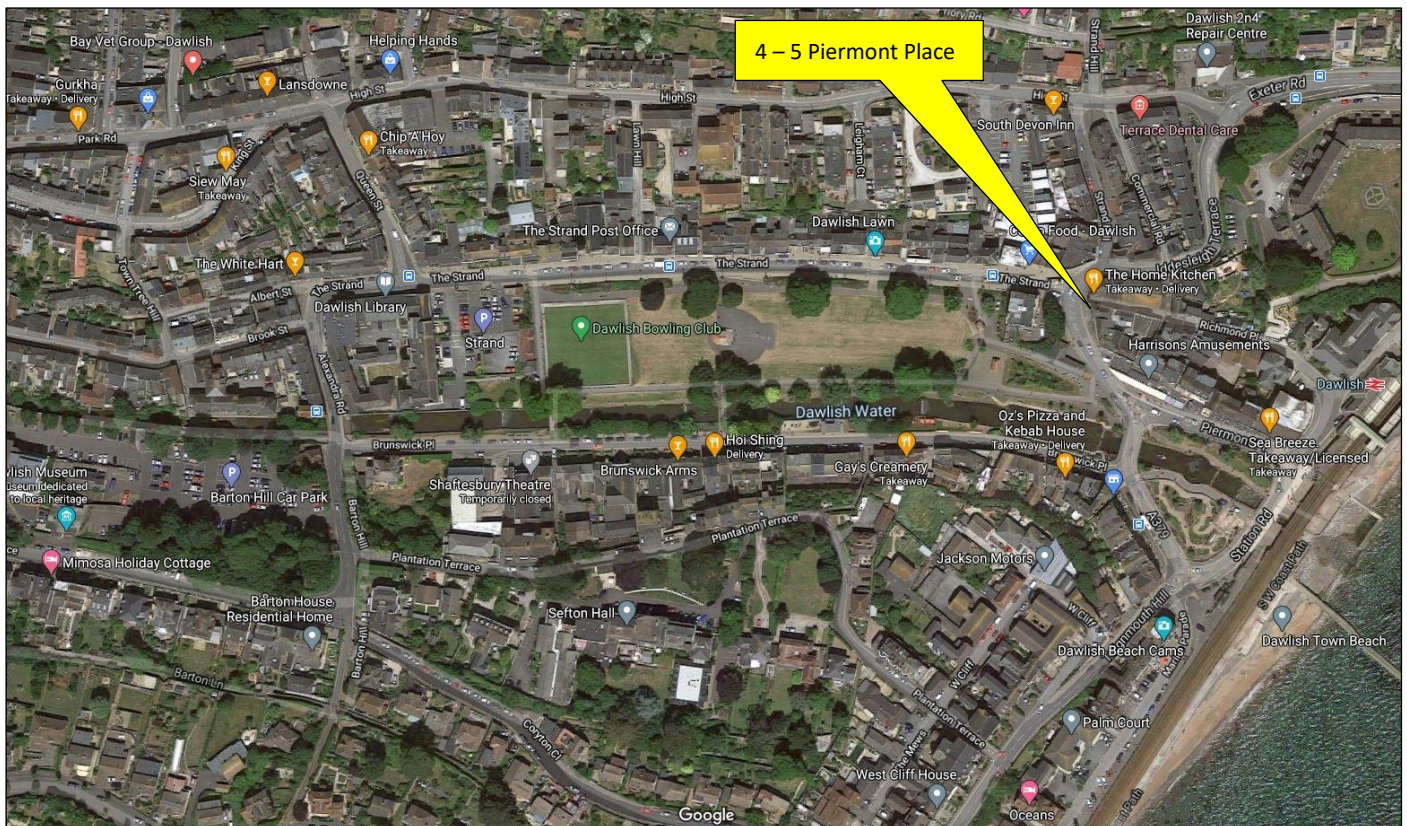
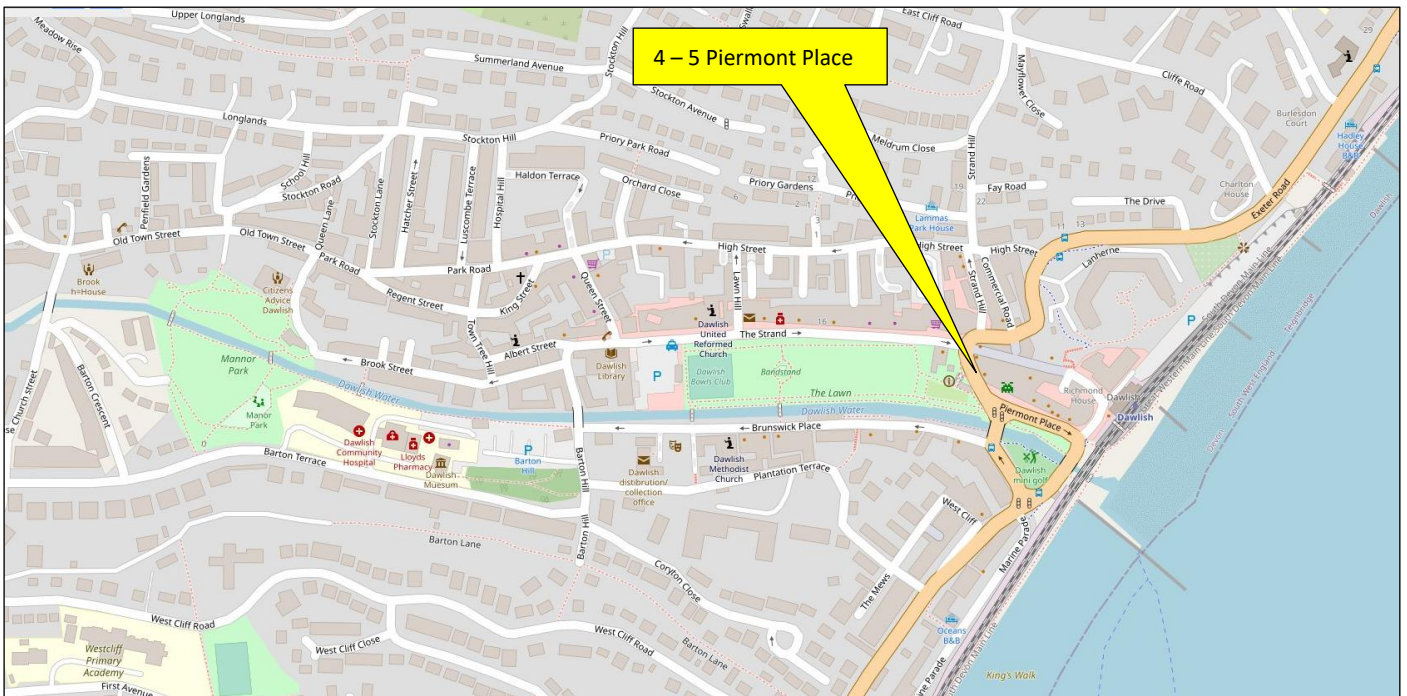
