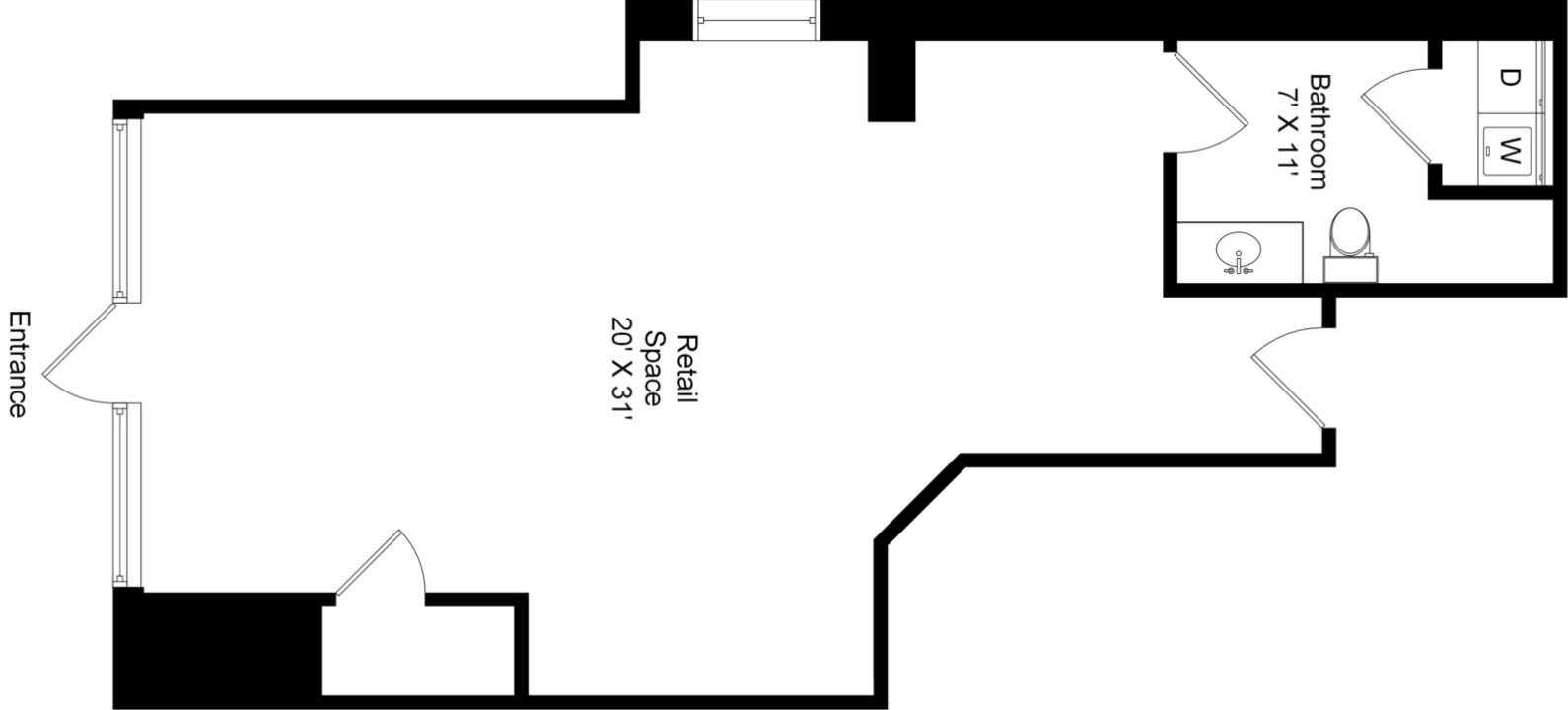

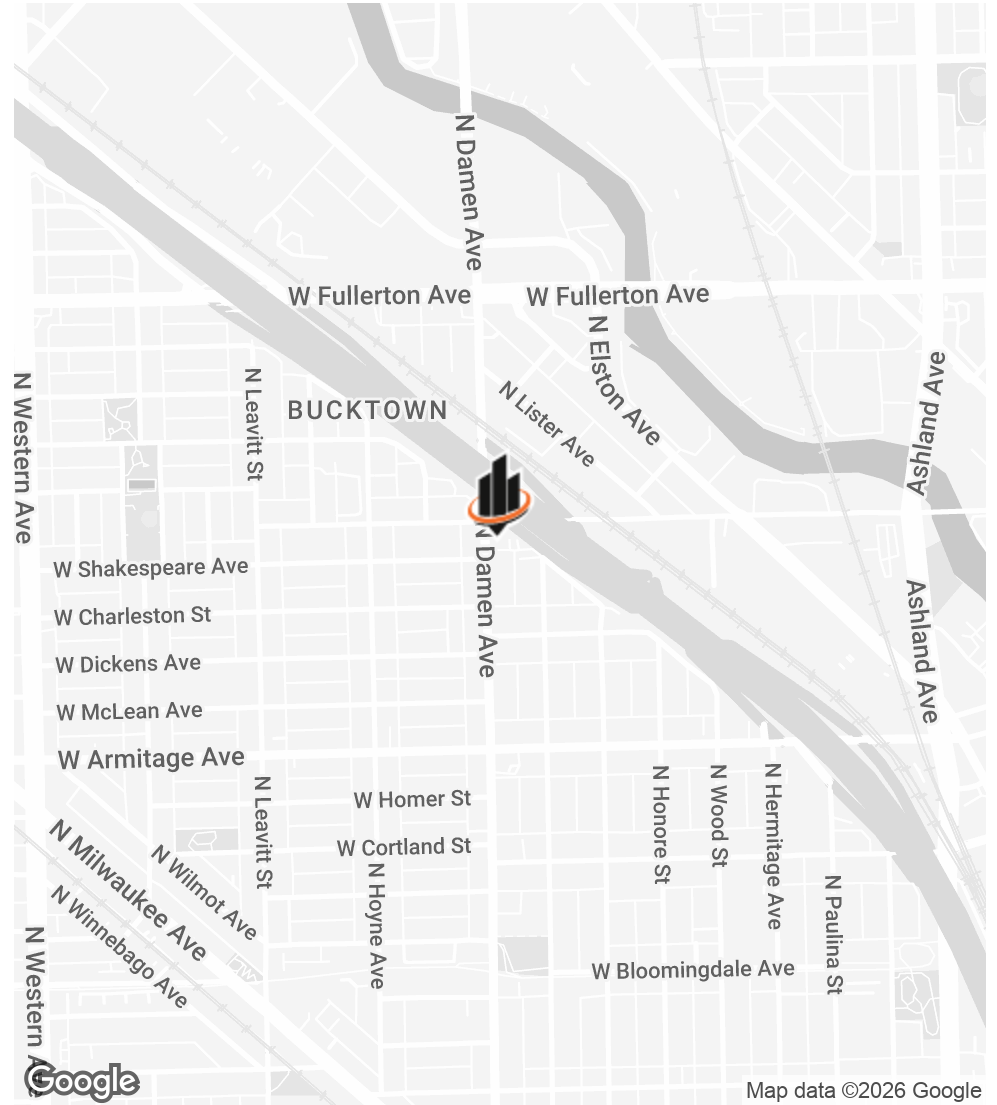
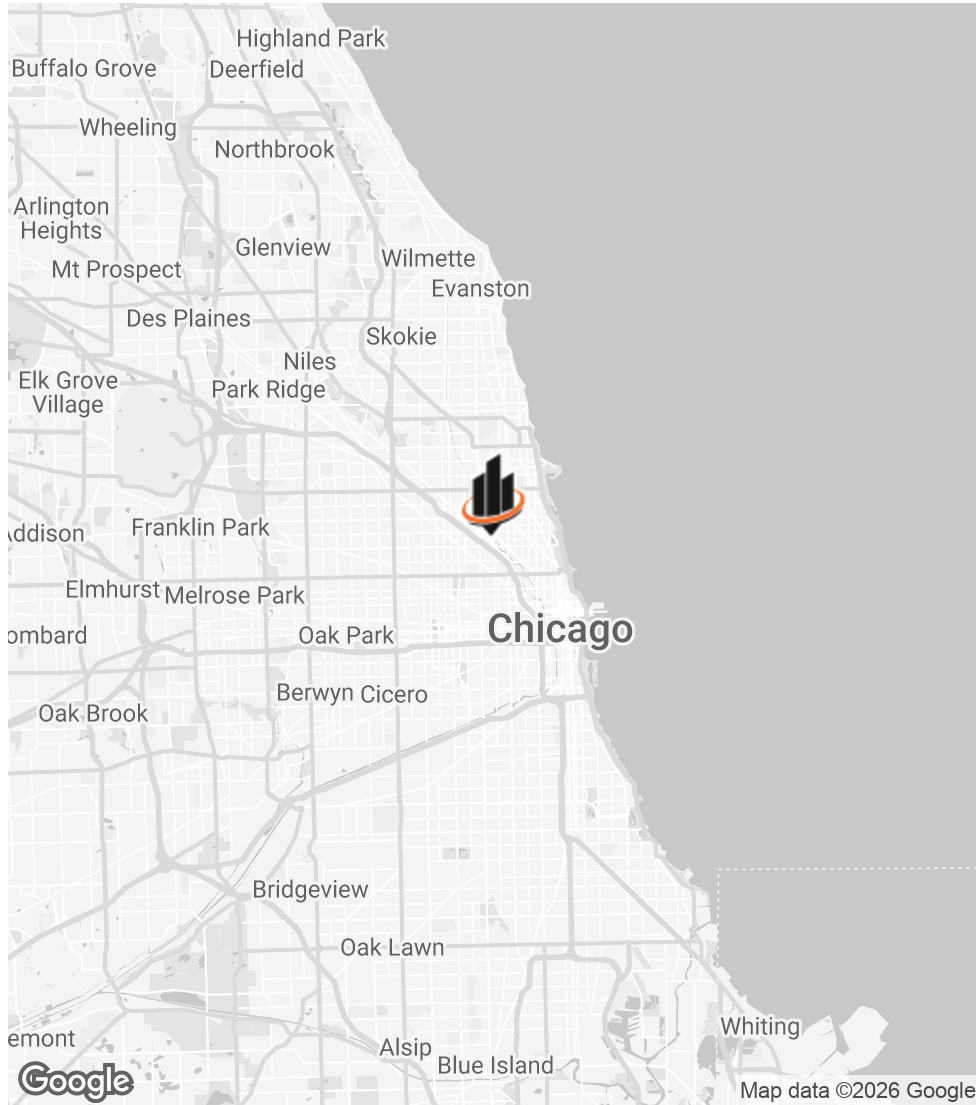
BIRDS EYE AERIAL
