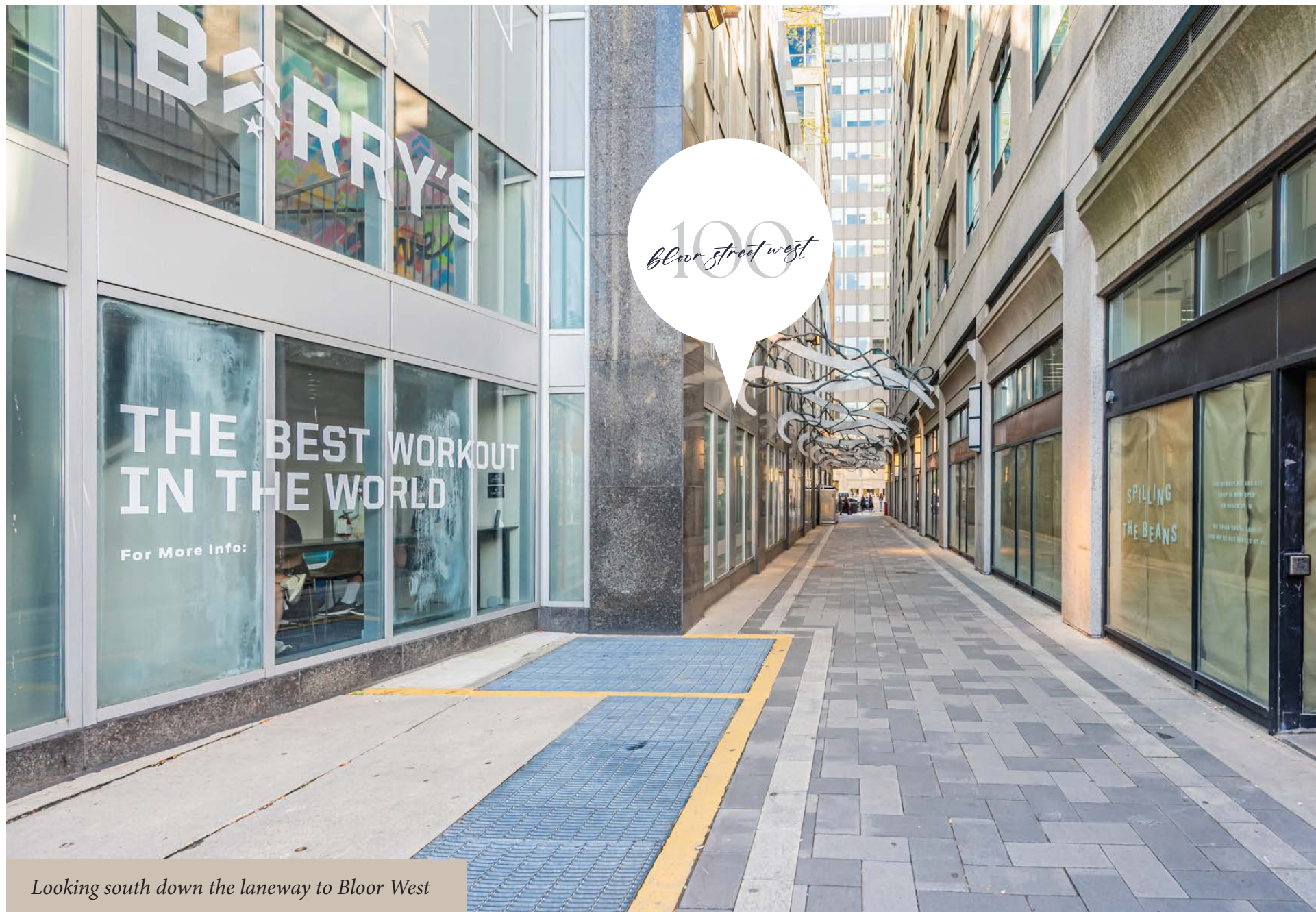


WEST ELEVATION

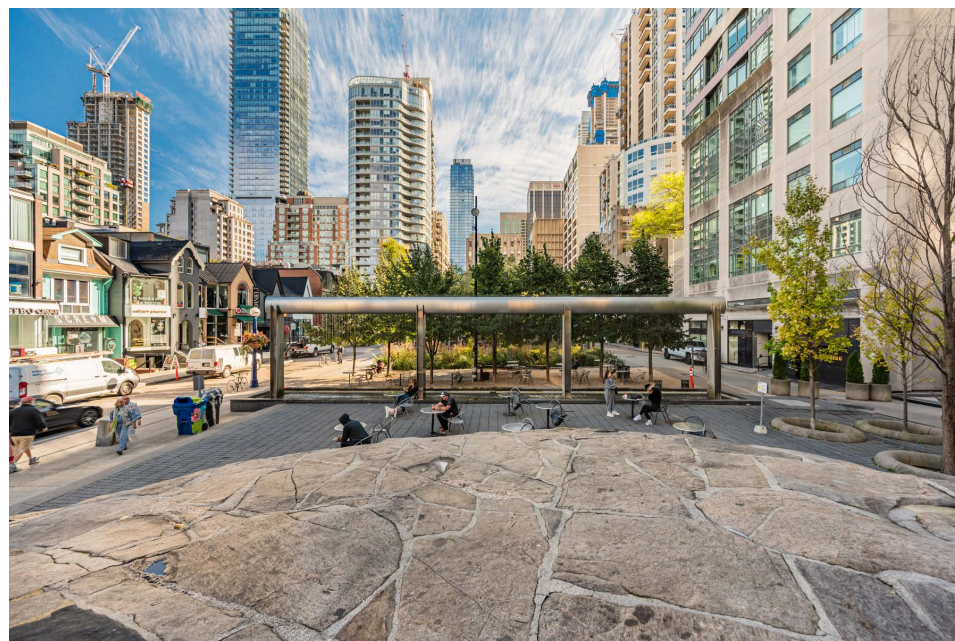

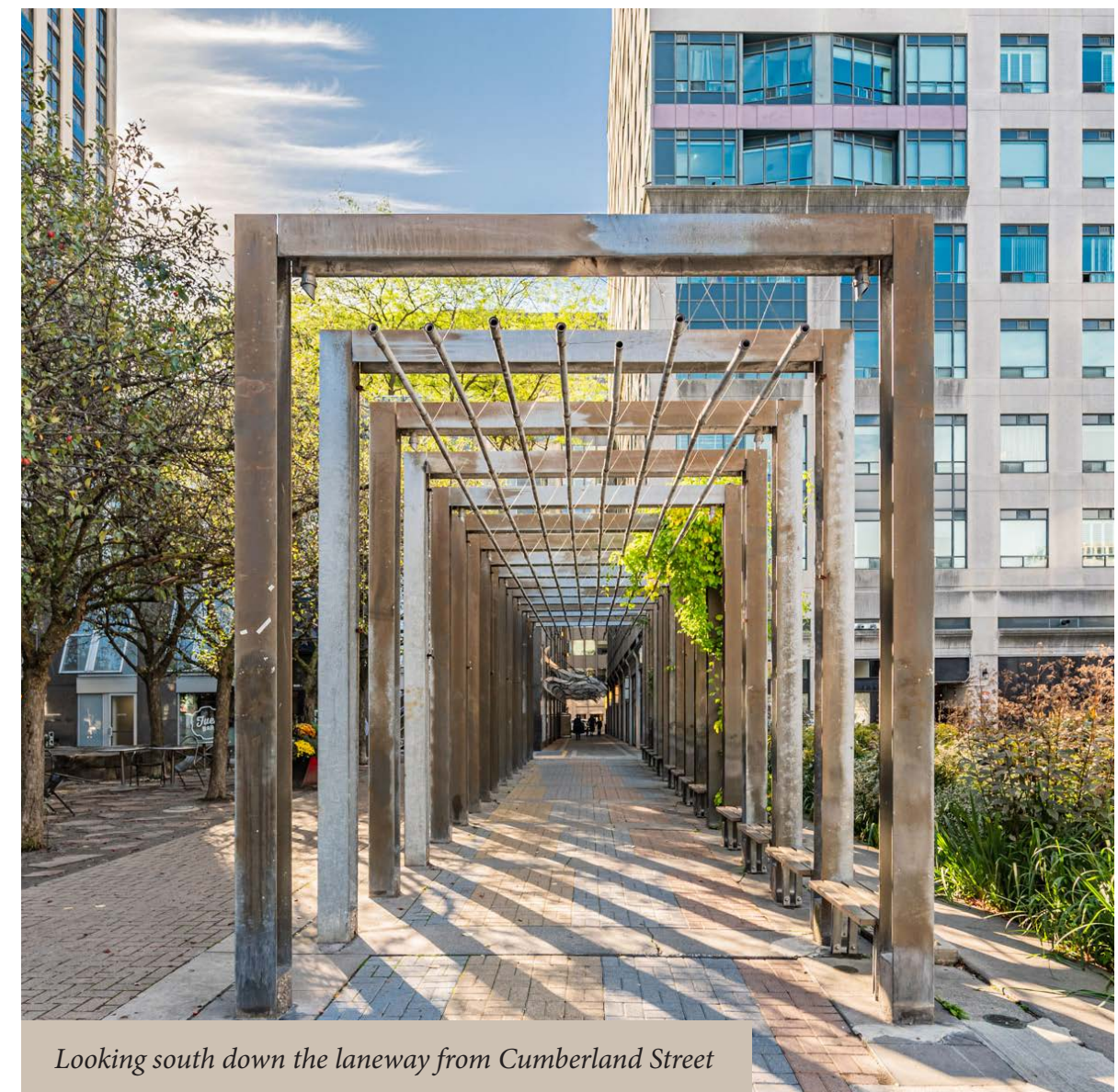

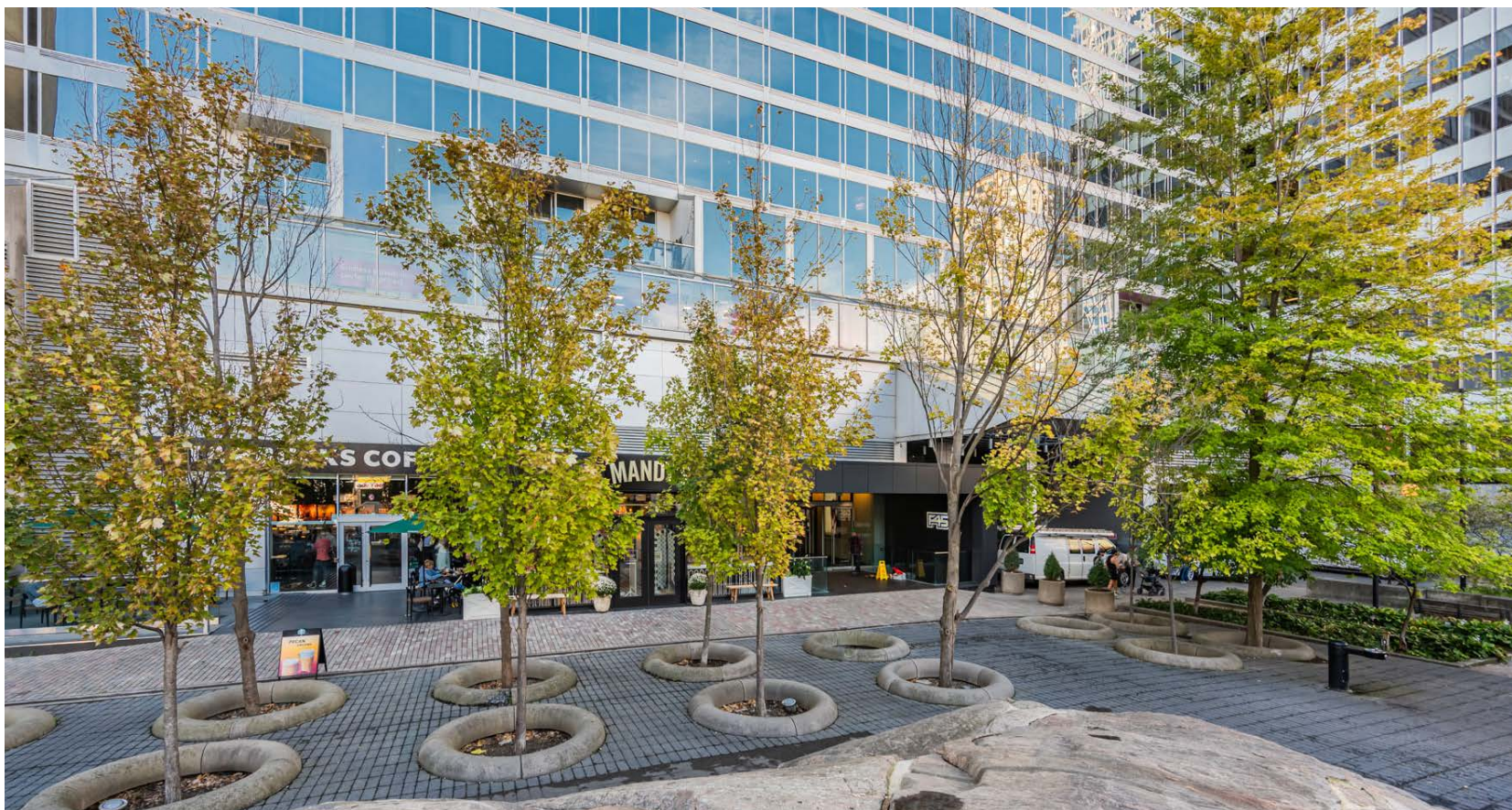
