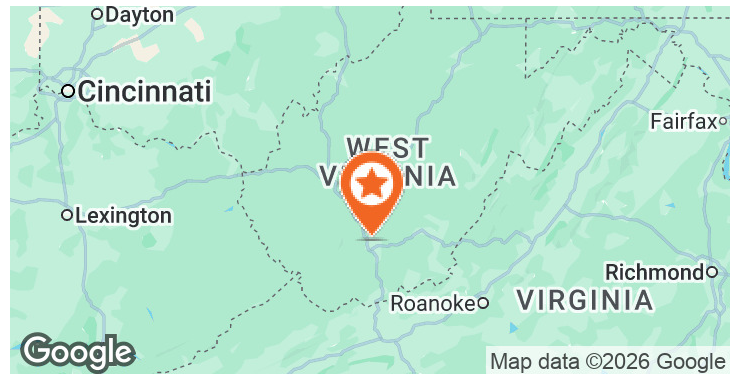


LOCATION DESCRIPTION

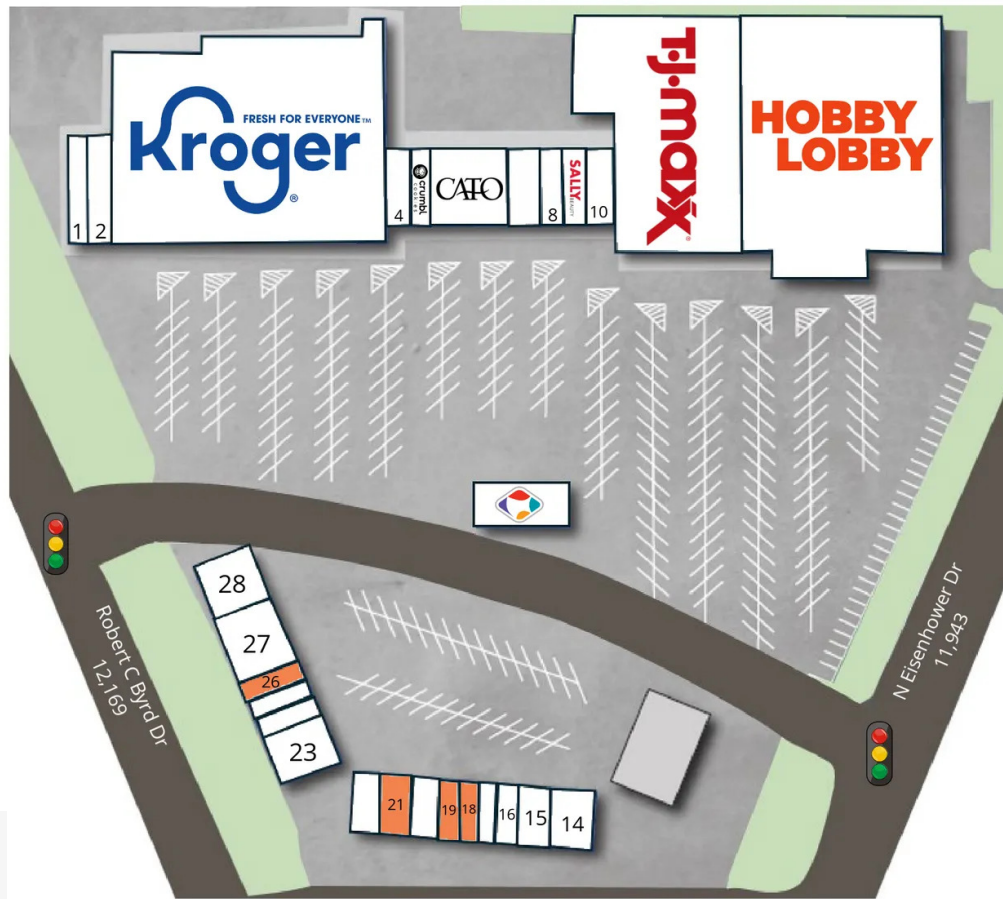
