As exclusive agents, Urban Group Real Estate is pleased to present 655 & 621A Del Ganado Road, San Rafael, CA for purchase.

The property consists of two restaurant buildings totaling approximately 4,780 square feet on a $\pm 14,000$ square foot parcel, with 11 dedicated parking stalls and access to a larger shared lot within the retail center (254 total spaces).

655 Del Ganado Road ($\pm 4,080$ SF) is a completely improved, full-service restaurant space. The property presents a rare opportunity for an owner-user to acquire a ready to go built-out restaurant building, with furniture, fixtures, and equipment in place for new owner.

The space features a large dining room, mezzanine-level seating, and a $\pm 1,000$ SF outdoor patio with capacity for up to 200 guests. Interior improvements include a 30-handle bar, four ADA restrooms, dedicated office, dry storage, two walk-in refrigeration units, and a fully equipped kitchen with a 22-foot hood. With over \$1.1 million in leasehold improvements and FF&E in place, the asset provides substantial existing infrastructure supporting an efficient transition to a new restaurant concept.

621A Del Ganado Road (± 700 SF) is a quick-service kiosk-style restaurant with outdoor seating, currently operating as Lou's Takeaway—lease term through May 2027. The space is well suited for fast-casual, grab-and-go, or complementary food and beverage concepts that can integrate into or enhance the overall site activation.

Located within a strong neighborhood retail center with consistent foot traffic and a community-oriented tenant mix, the property offers a rare combination of infrastructure, scale, and flexibility. For operators, this is an opportunity to step directly into a fully realized hospitality setting and execute a new or evolved concept with immediate operational capability.
