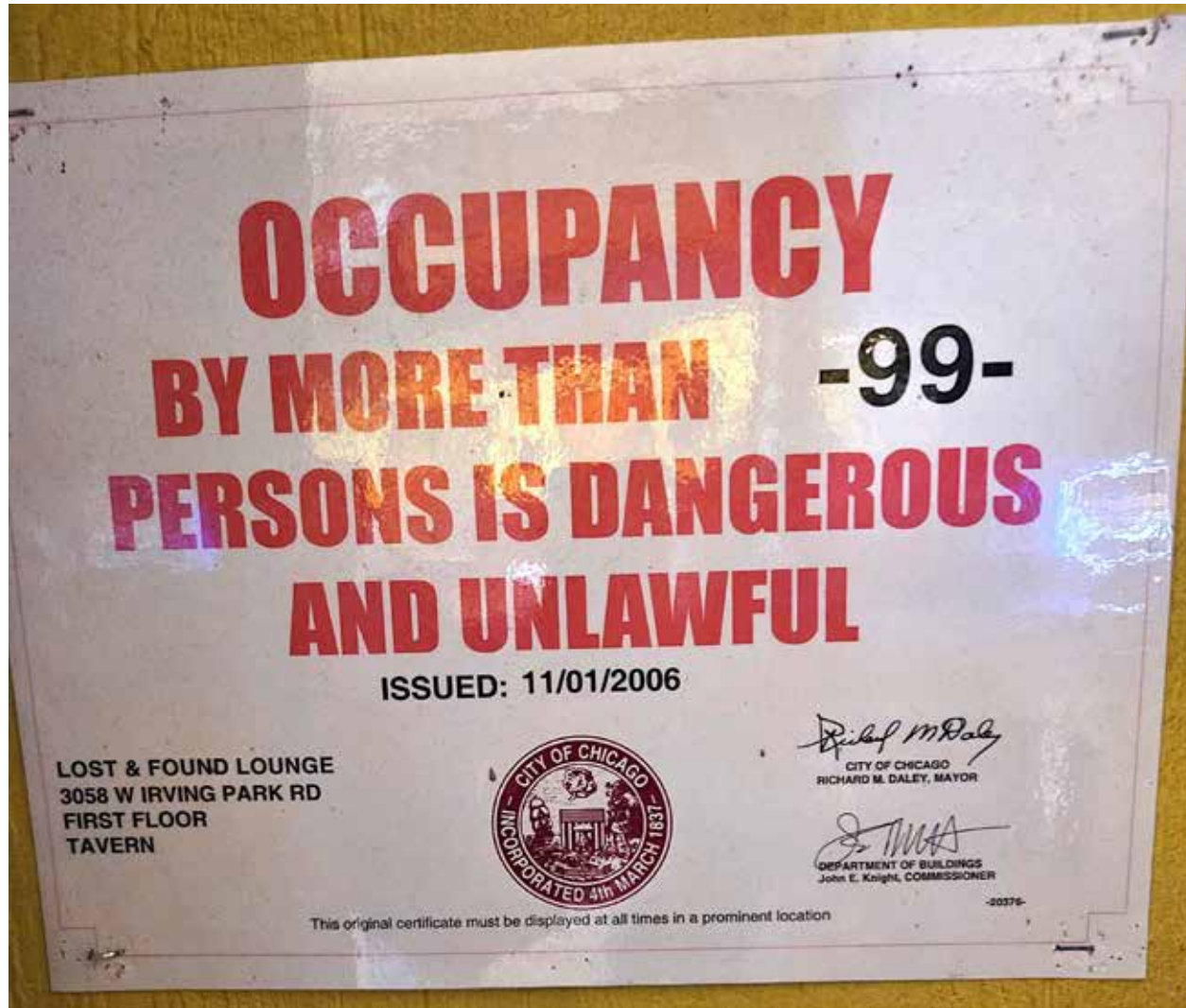

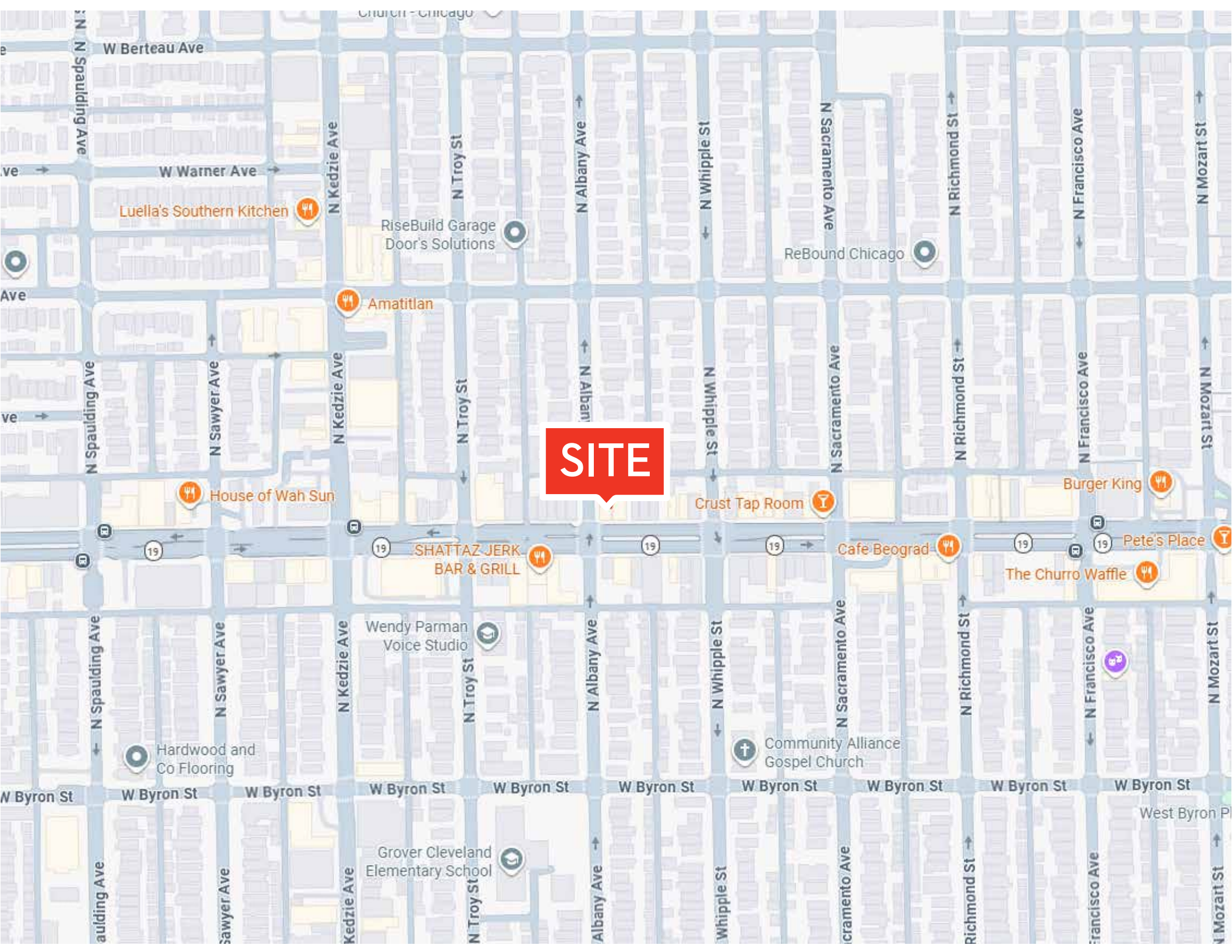

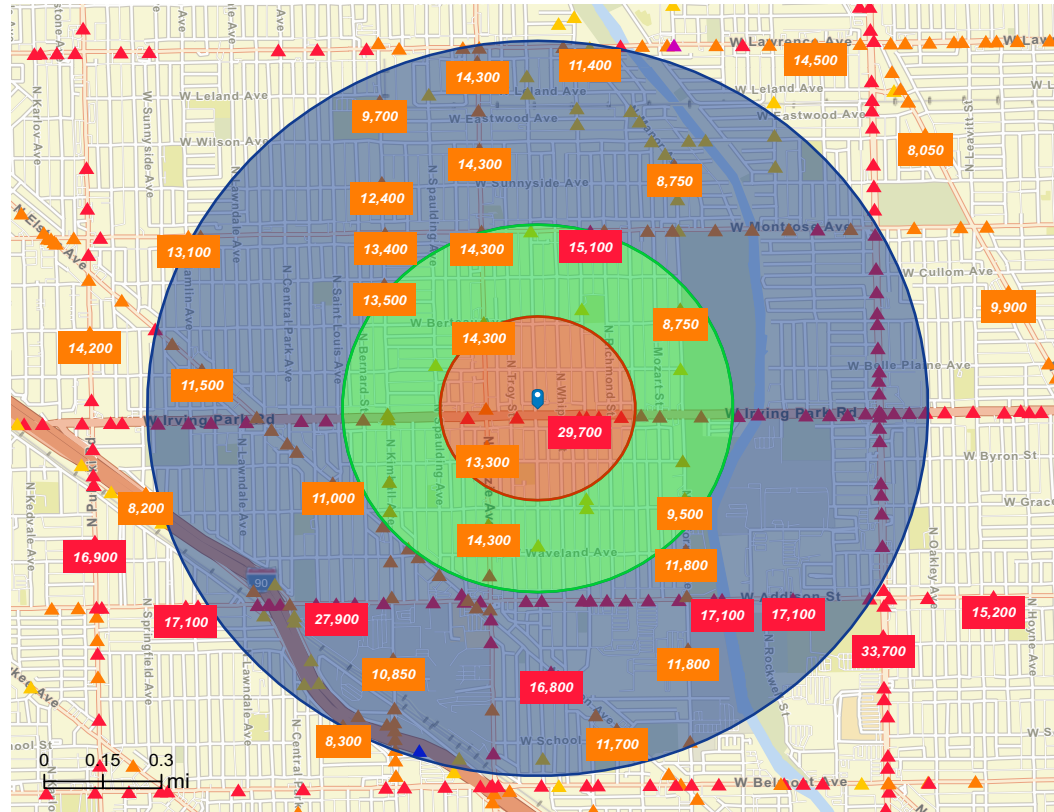

Traffic Count Map

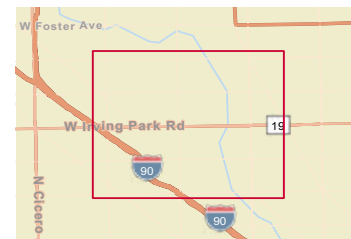

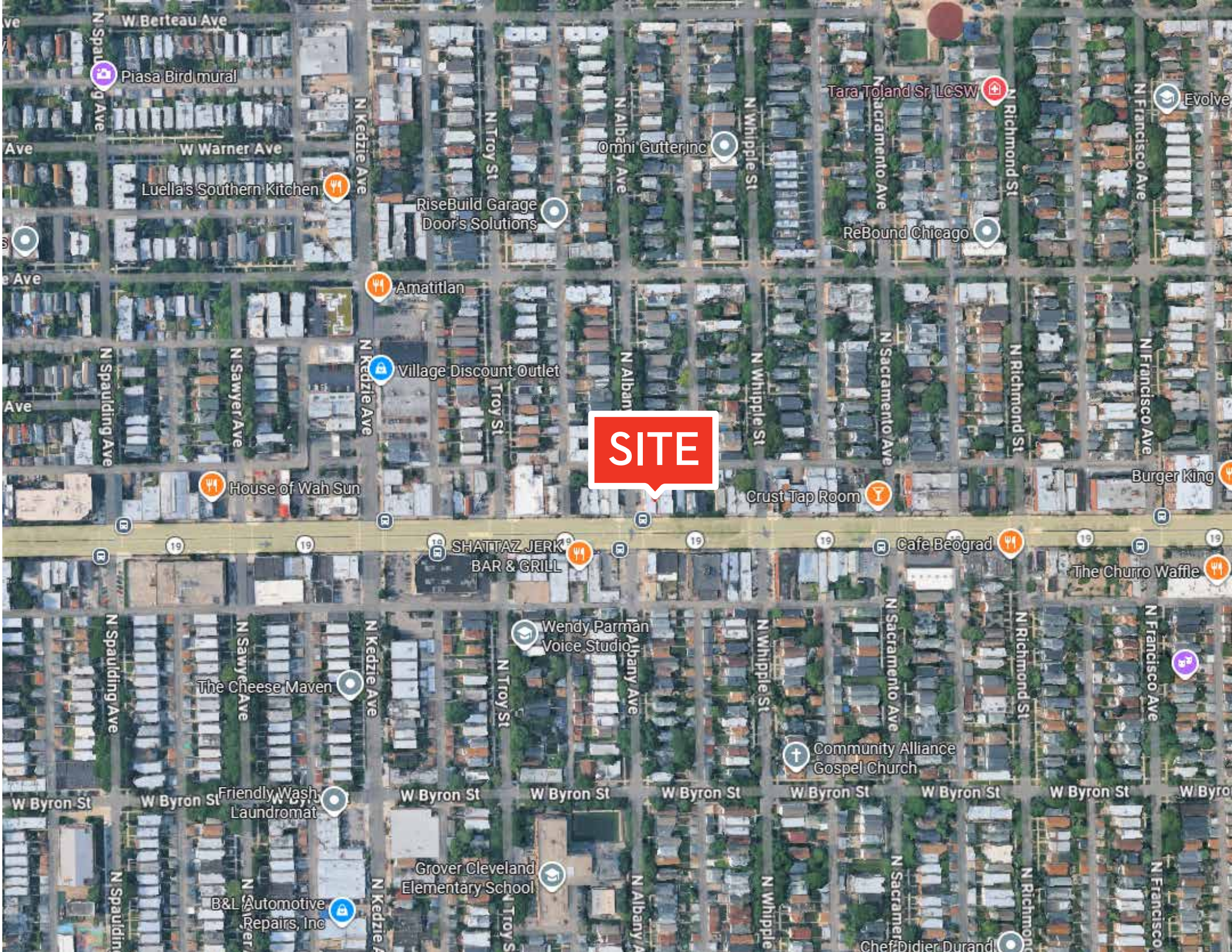

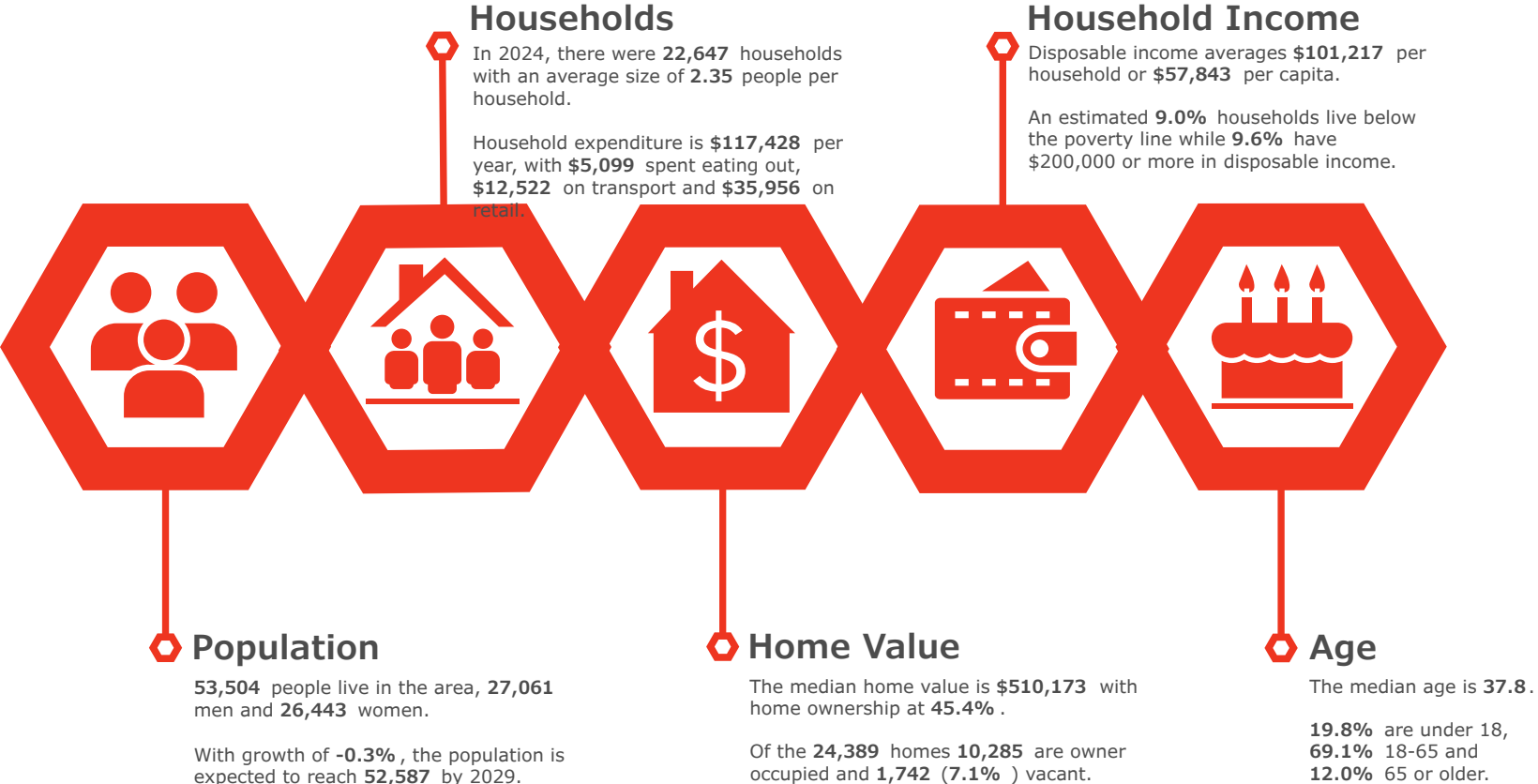
MARKET OVERVIEW
