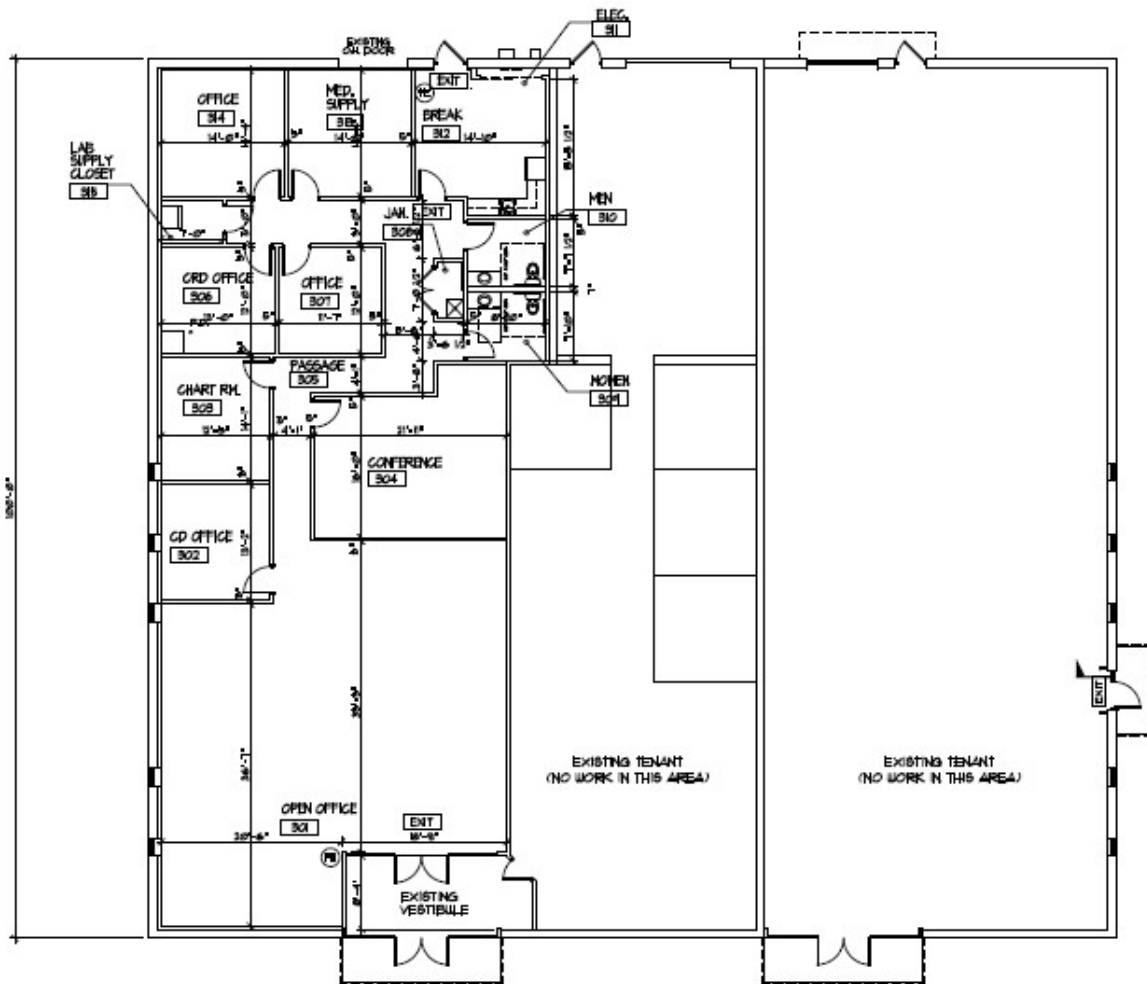

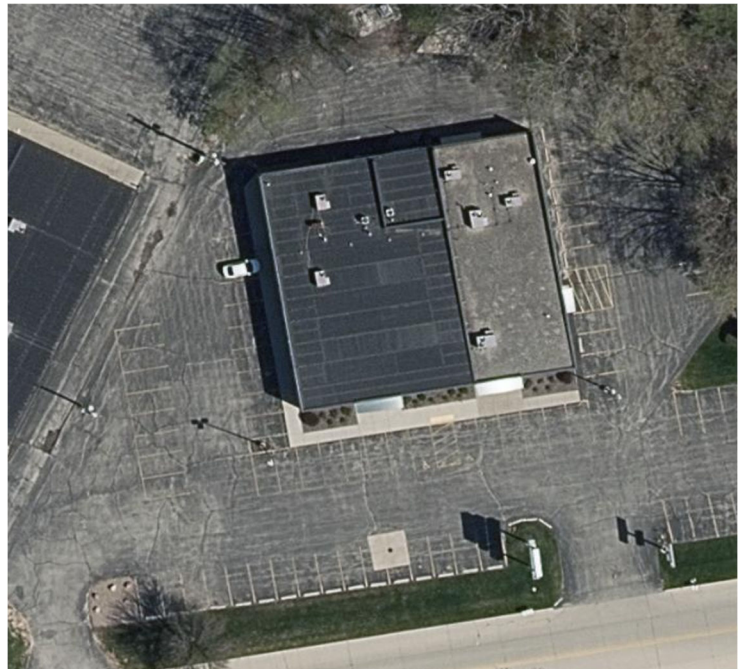

#### STATE OF WISCONSIN BROKER DISCLOSURE
