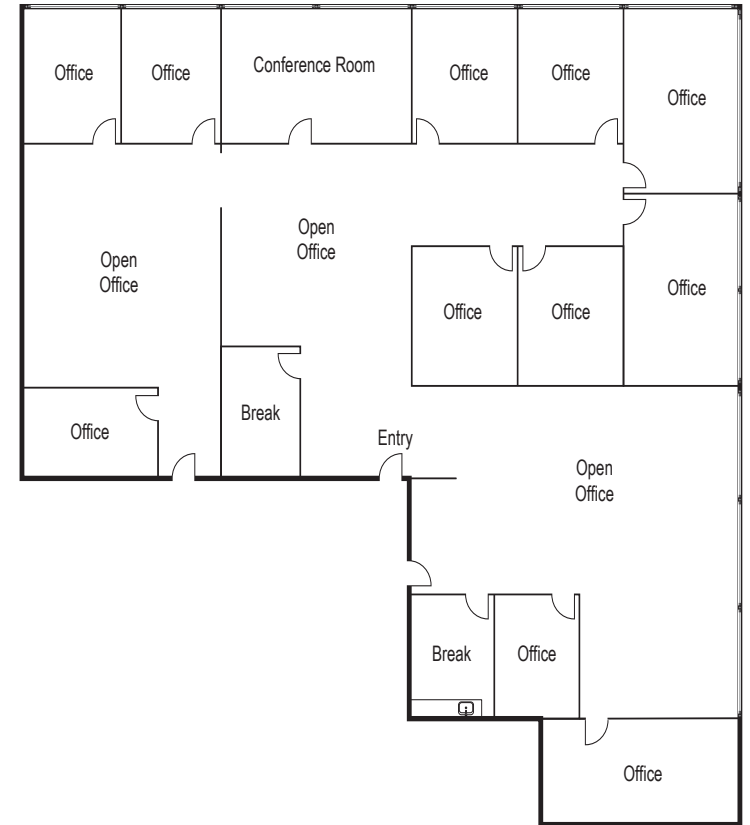


FLOOR PLAN

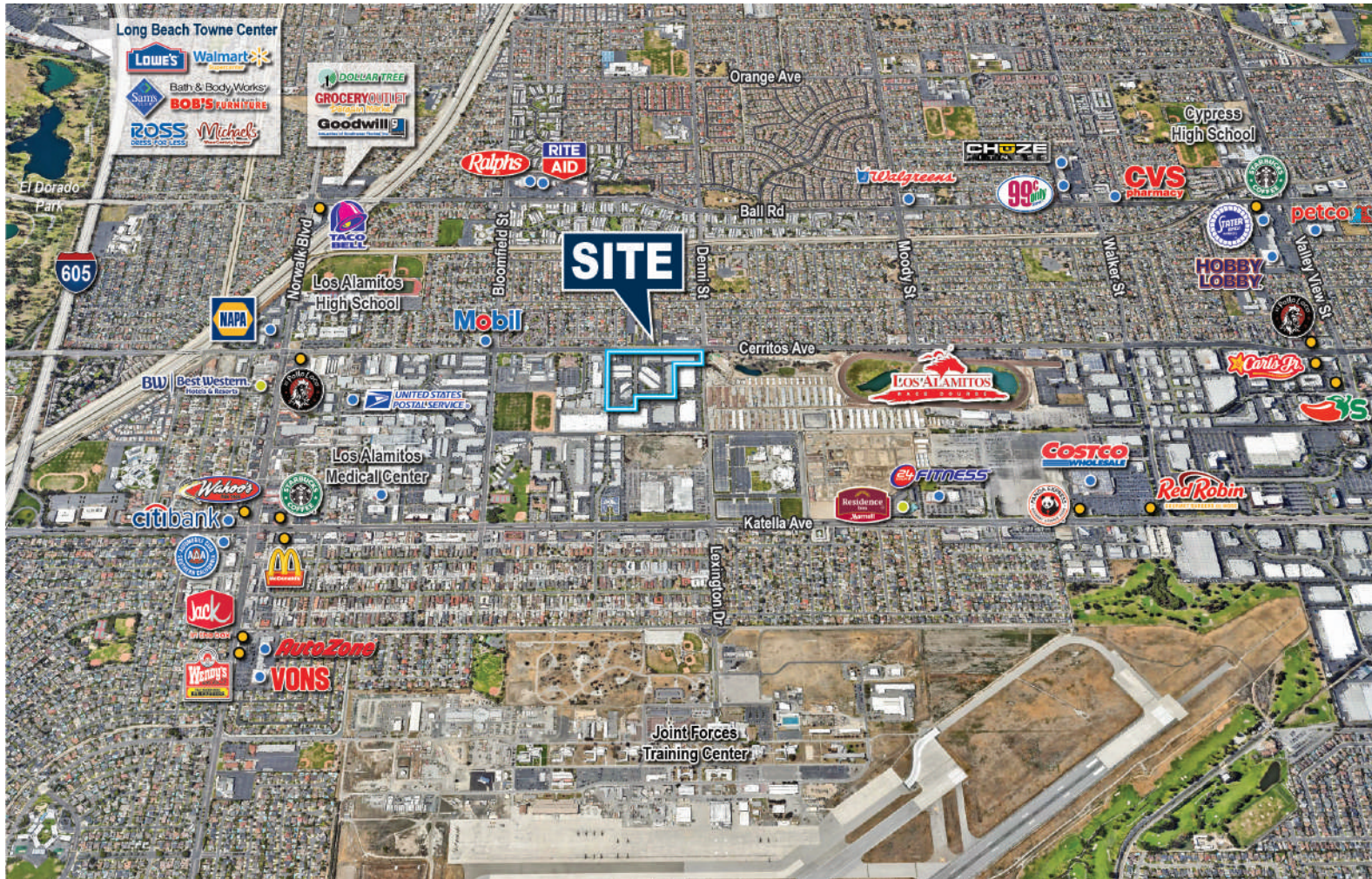
