- Multi-tenant Strip Building: A 15,260-SF building currently 100% occupied. Tenants include Retro Donuts, Inland Northwest Ballet, Jonathan's Nail & Spa, and The Beauty Spot Salon & Spa. It also serves as a strategic hub for government-backed offices, including the WA Army National Guard and the U.S. Armed Forces Recruiting center.
