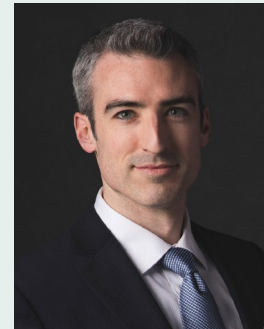

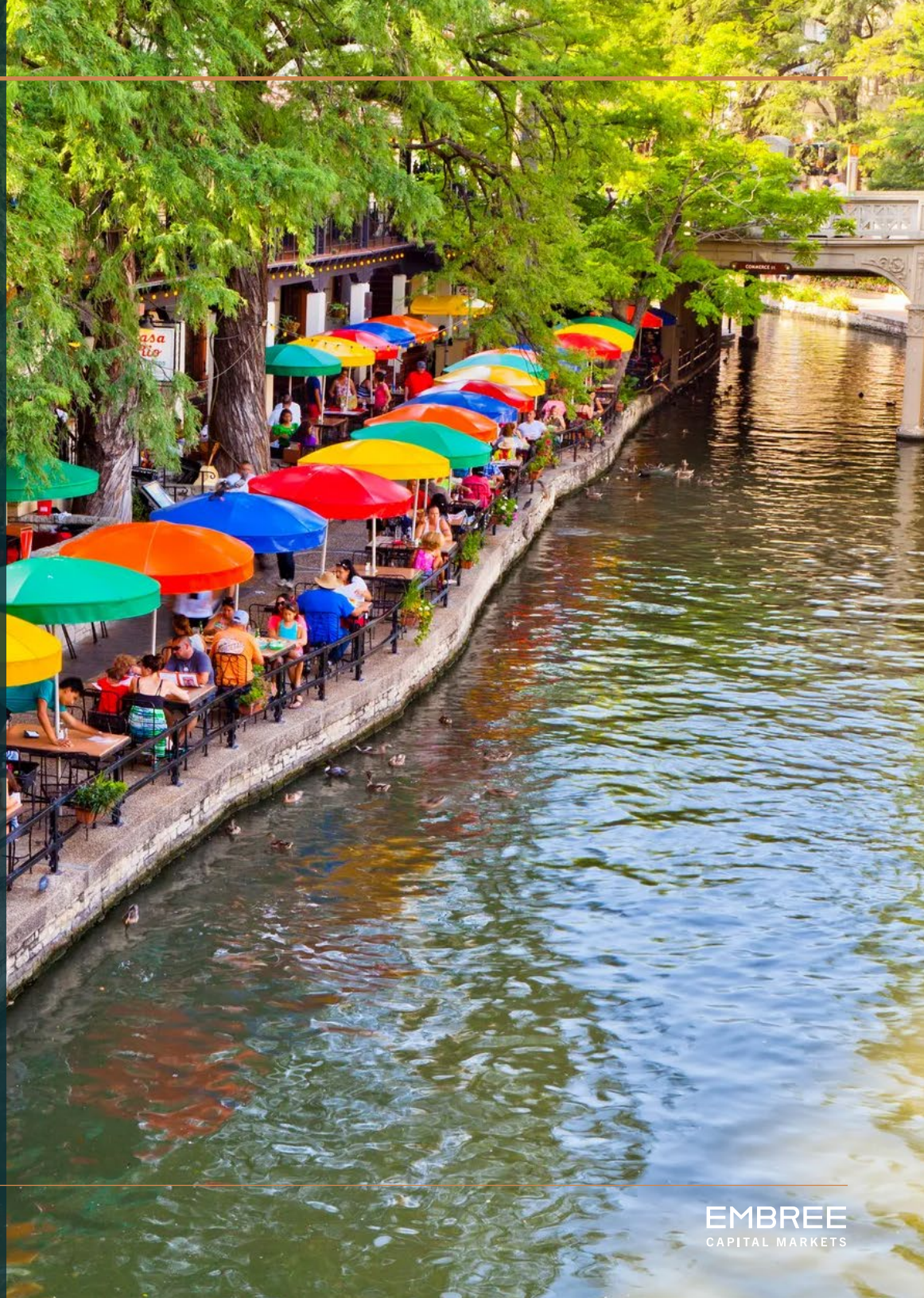
AREA OVERVIEW

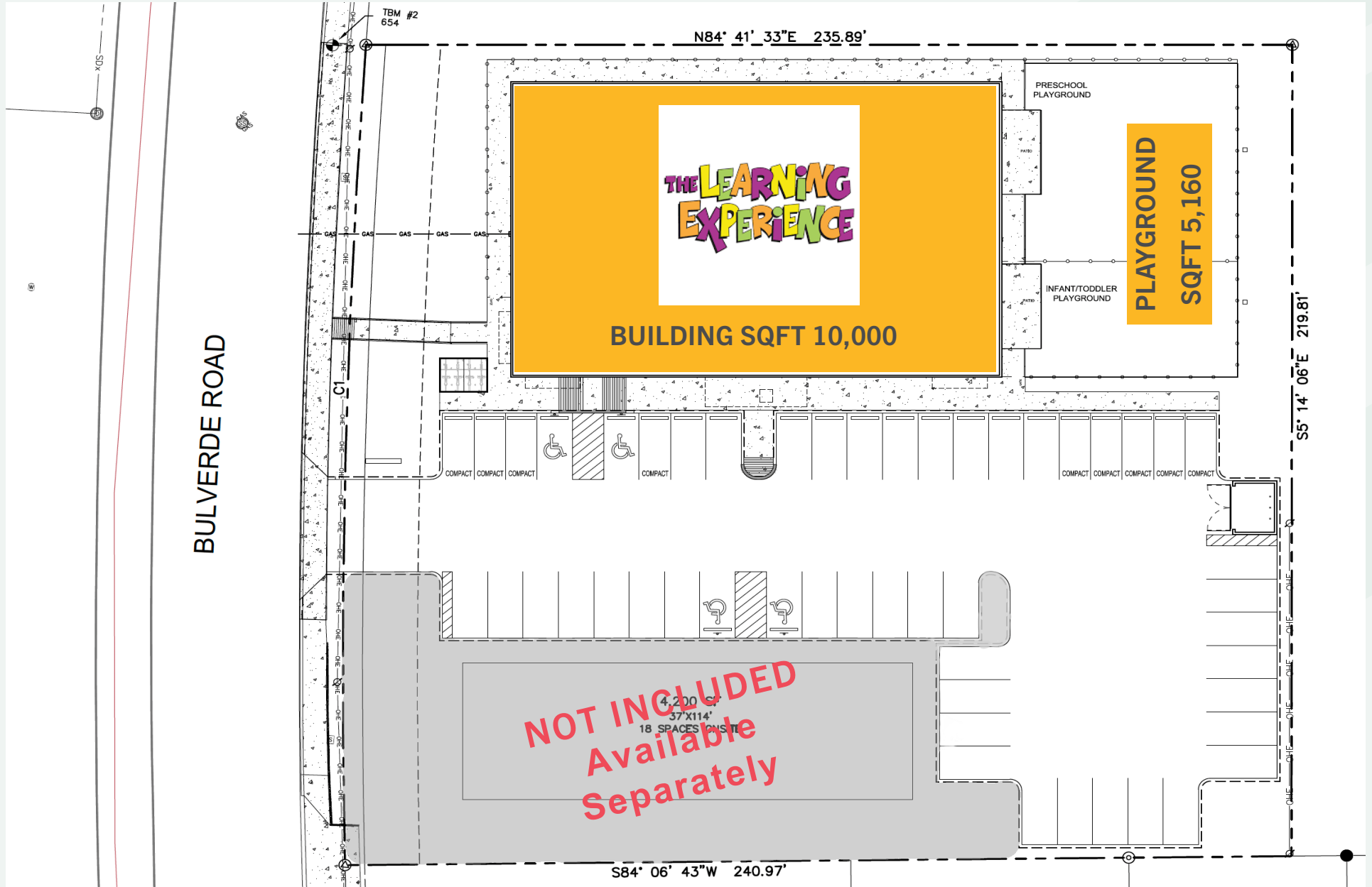

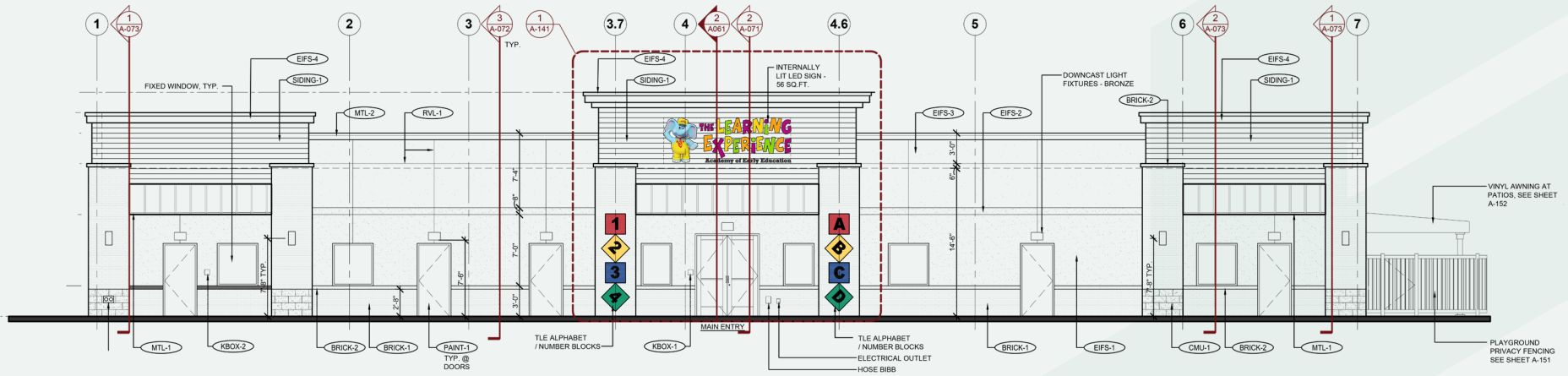

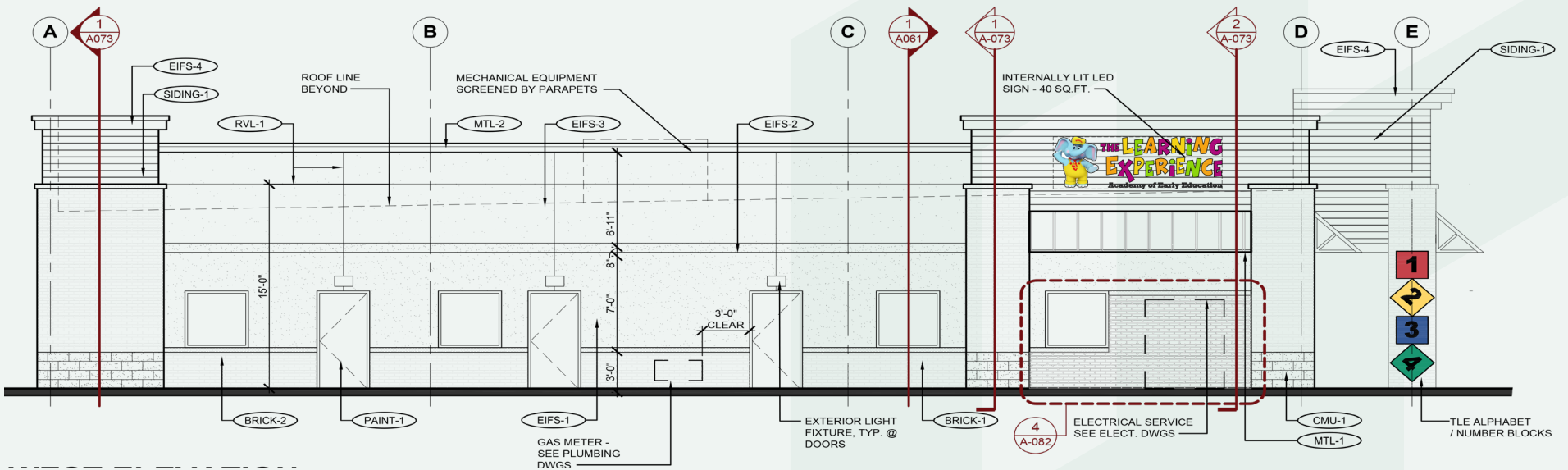

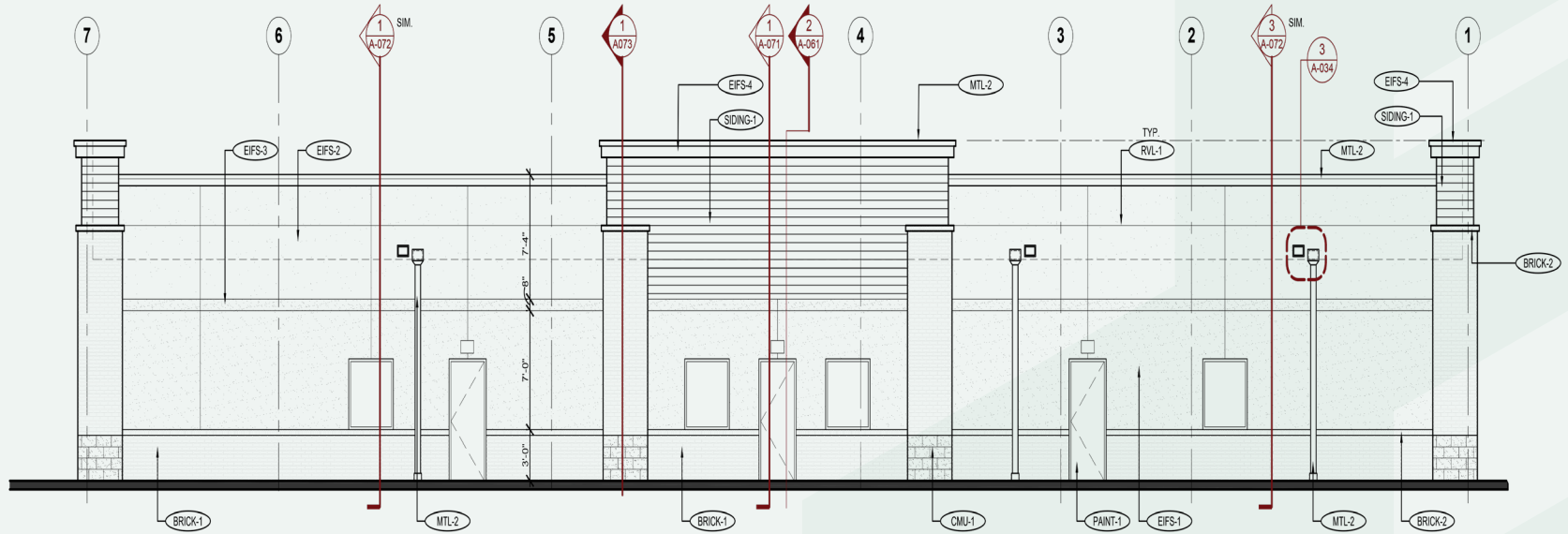


SOUTH ELEVATION

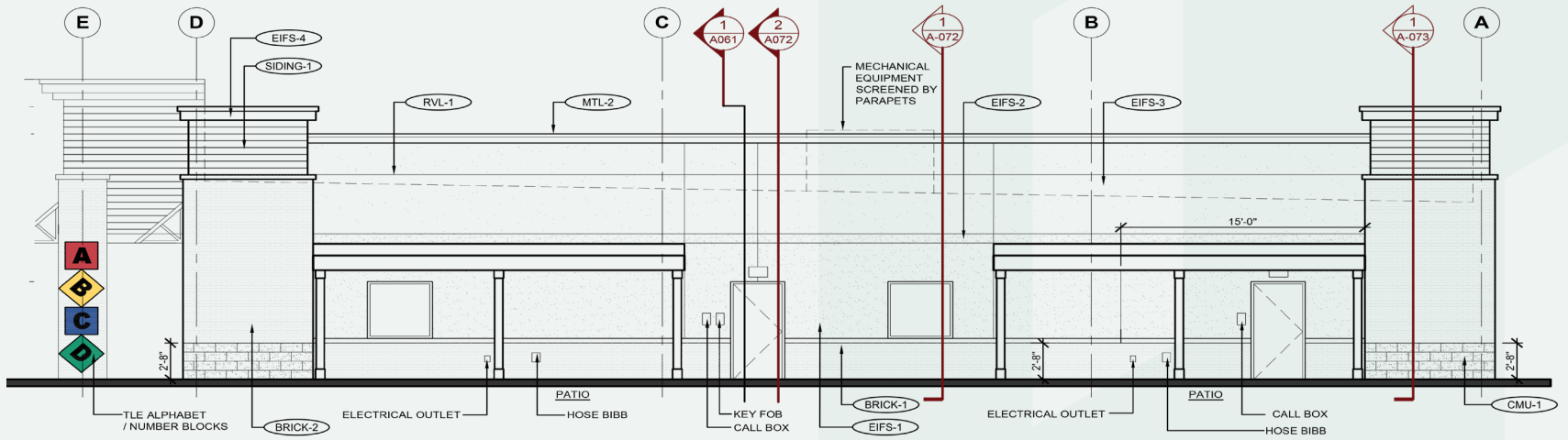
