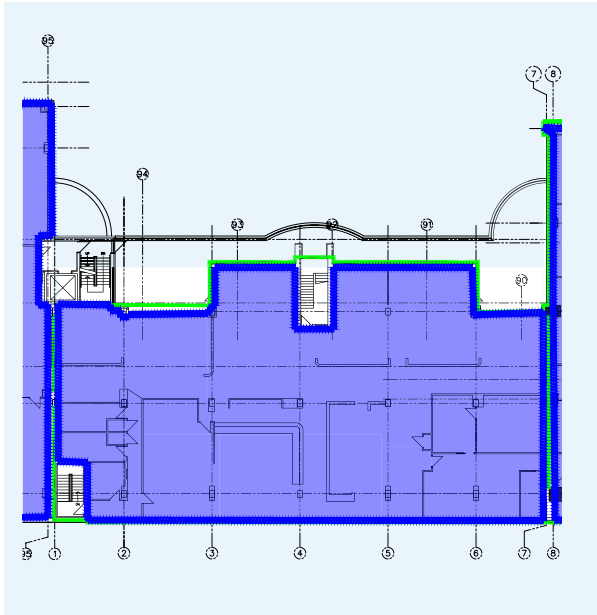

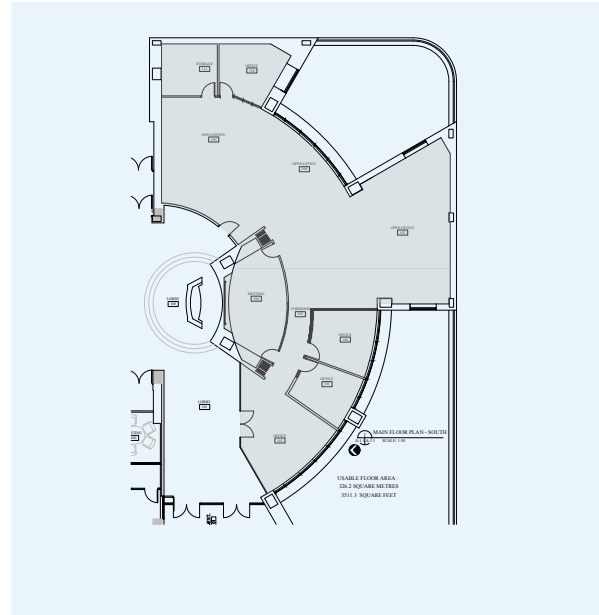

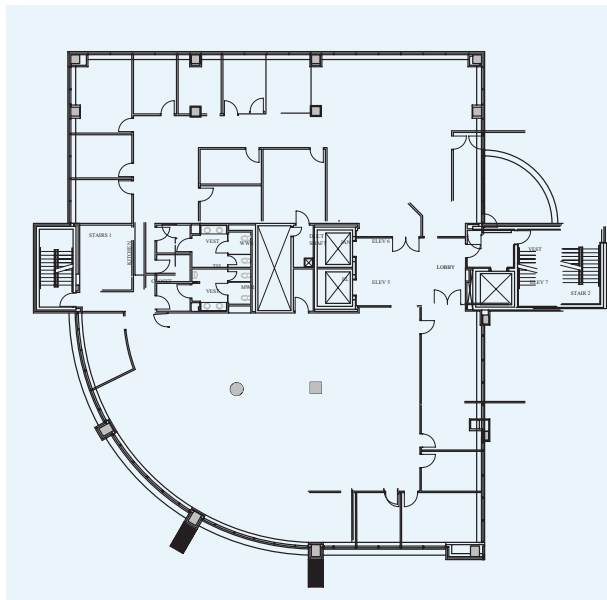
FLOOR PLAN - SECOND FLOOR (LINK)



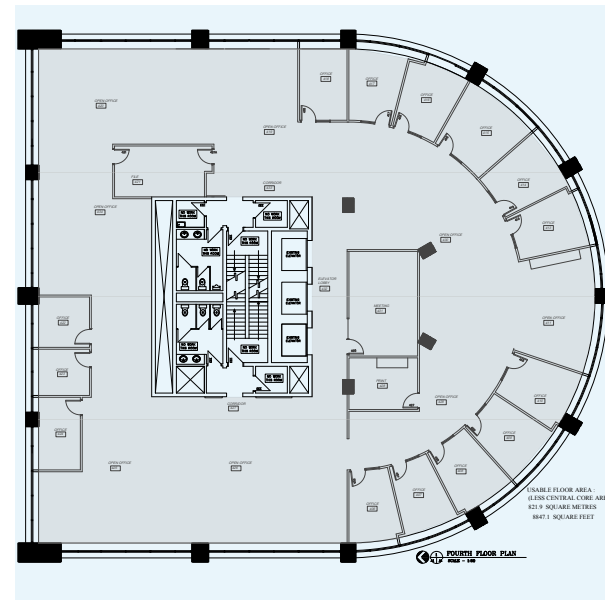
FLOOR PLAN - MAIN FLOOR (SOUTH)

The health and safety of all people who work in our facility is a constant priority to Credit Union Centre and we greatly appreciate this recognition of our efforts.

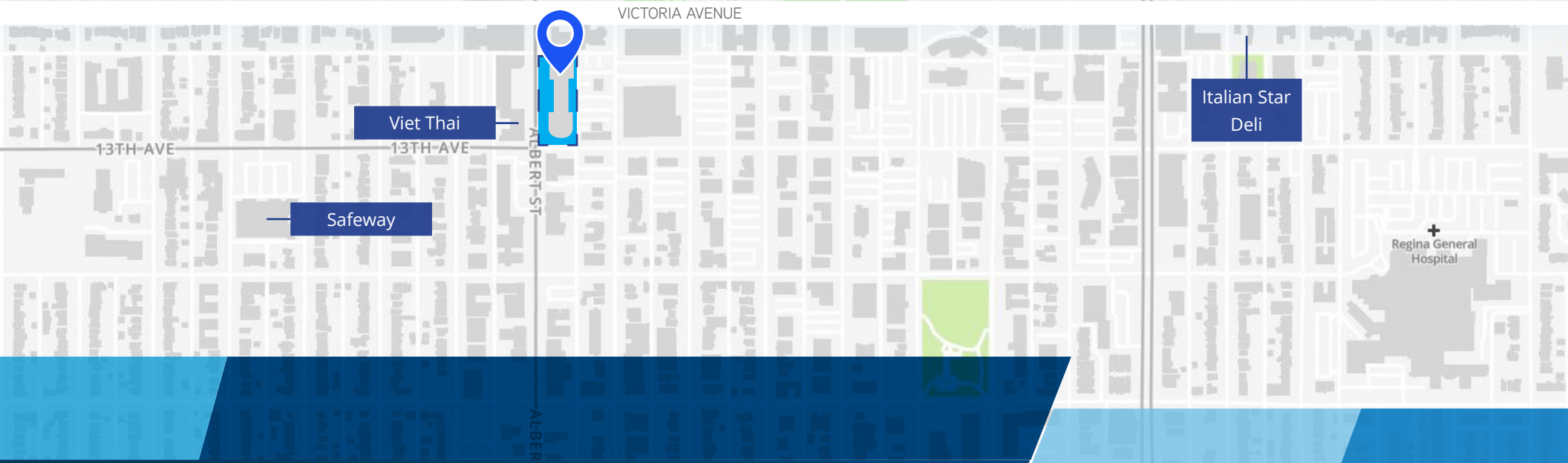
In determining award recipients, key categories considered by NAFA include sustainability, economic benefits and innovation.
