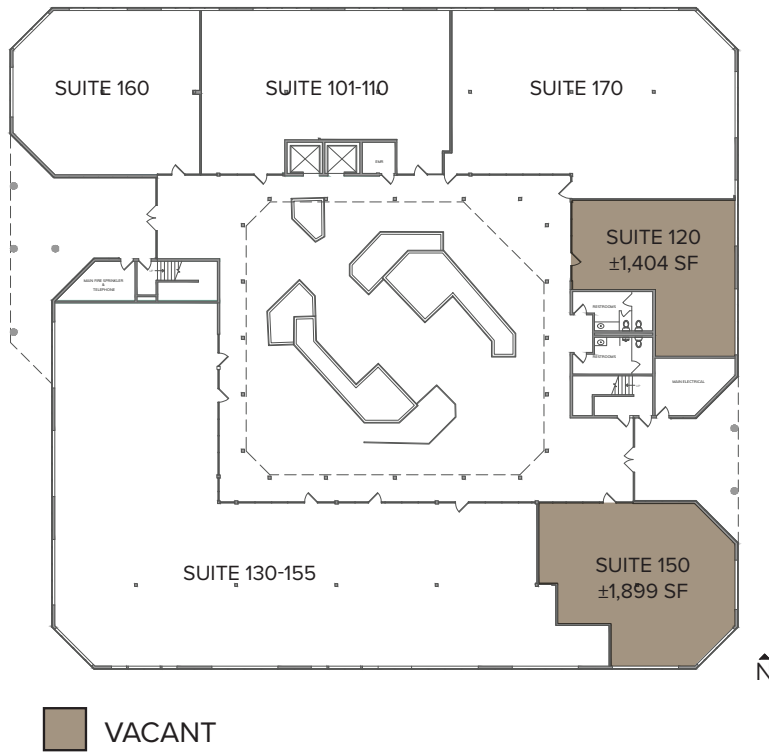

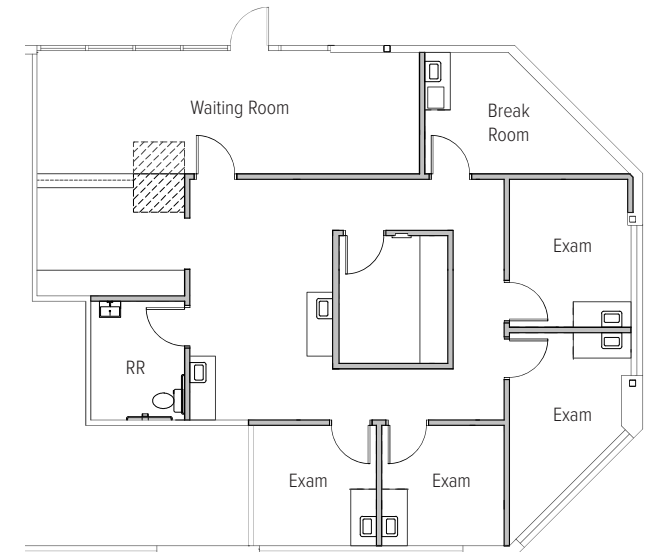
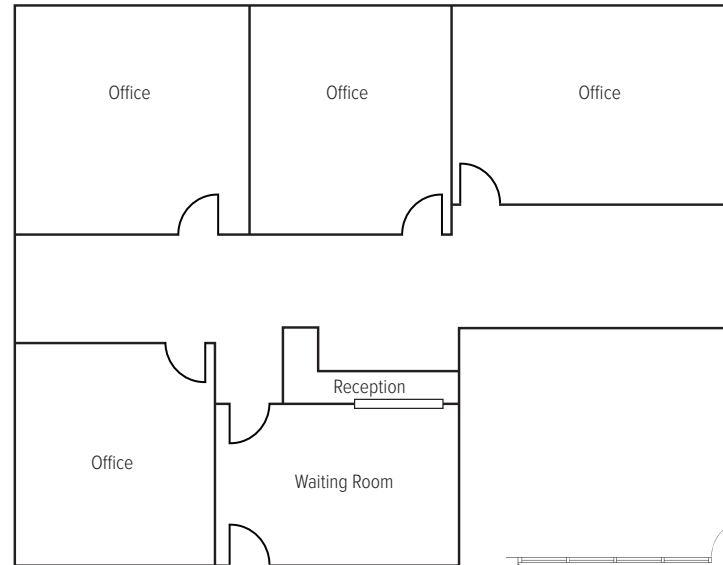

SUITE 150 | ±1,899 SQ. FT.

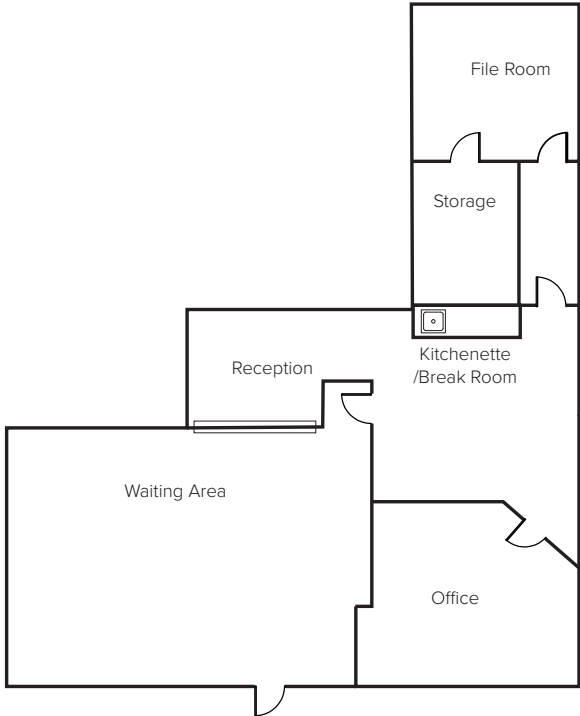
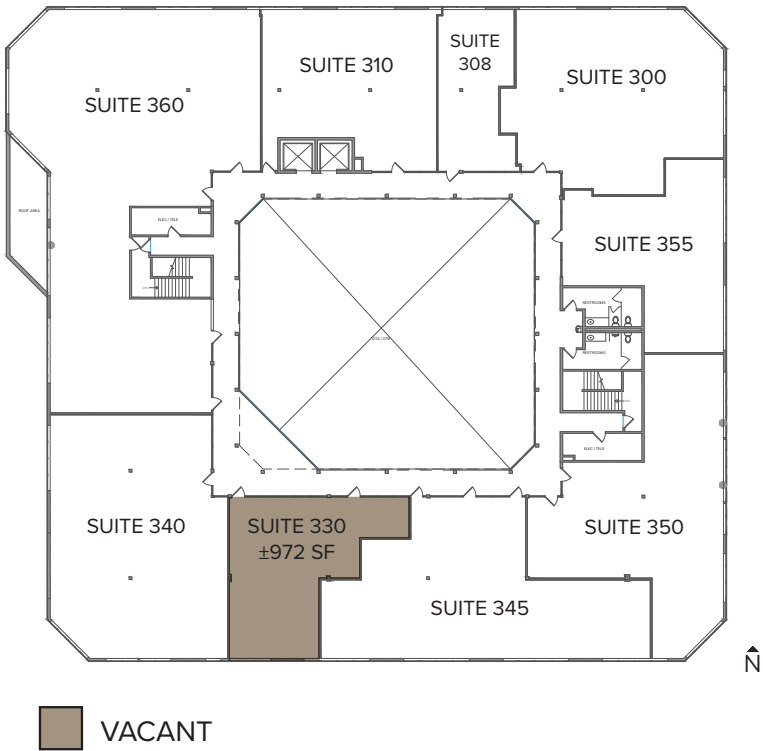
