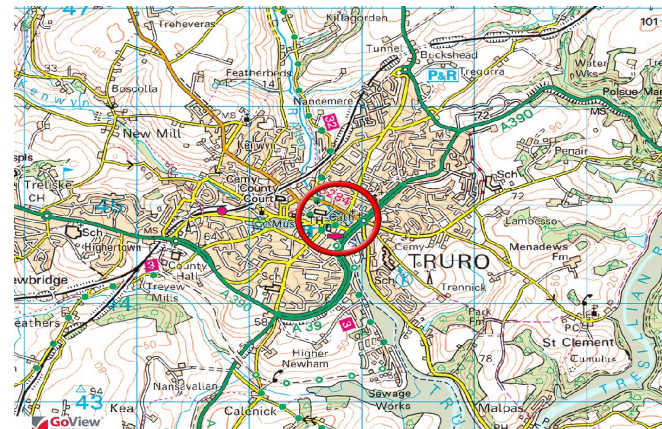

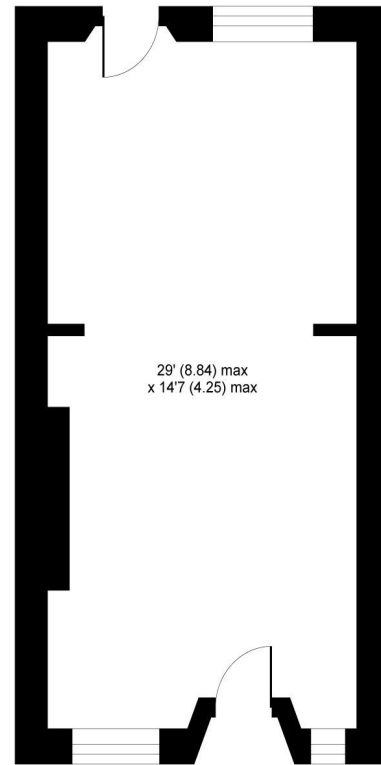




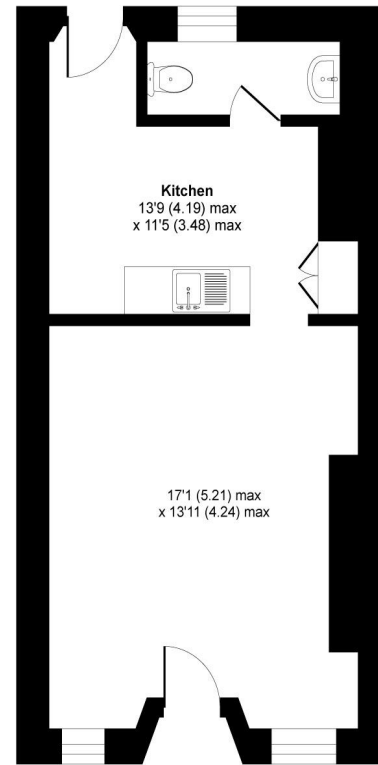
## 14A And 14B New Bridge Street, Truro, TR1 2AA

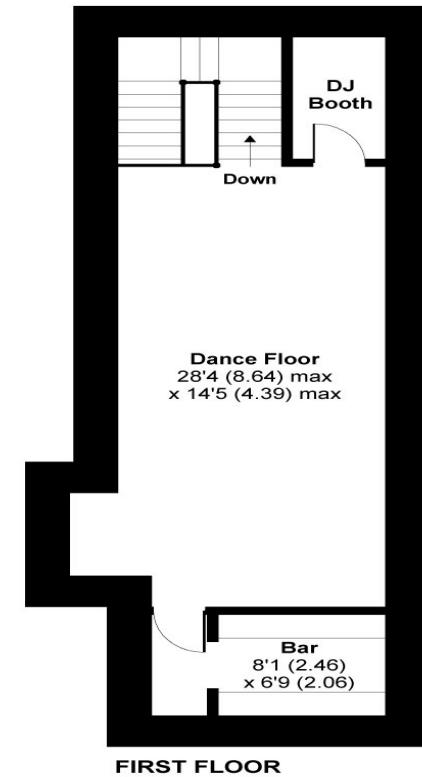
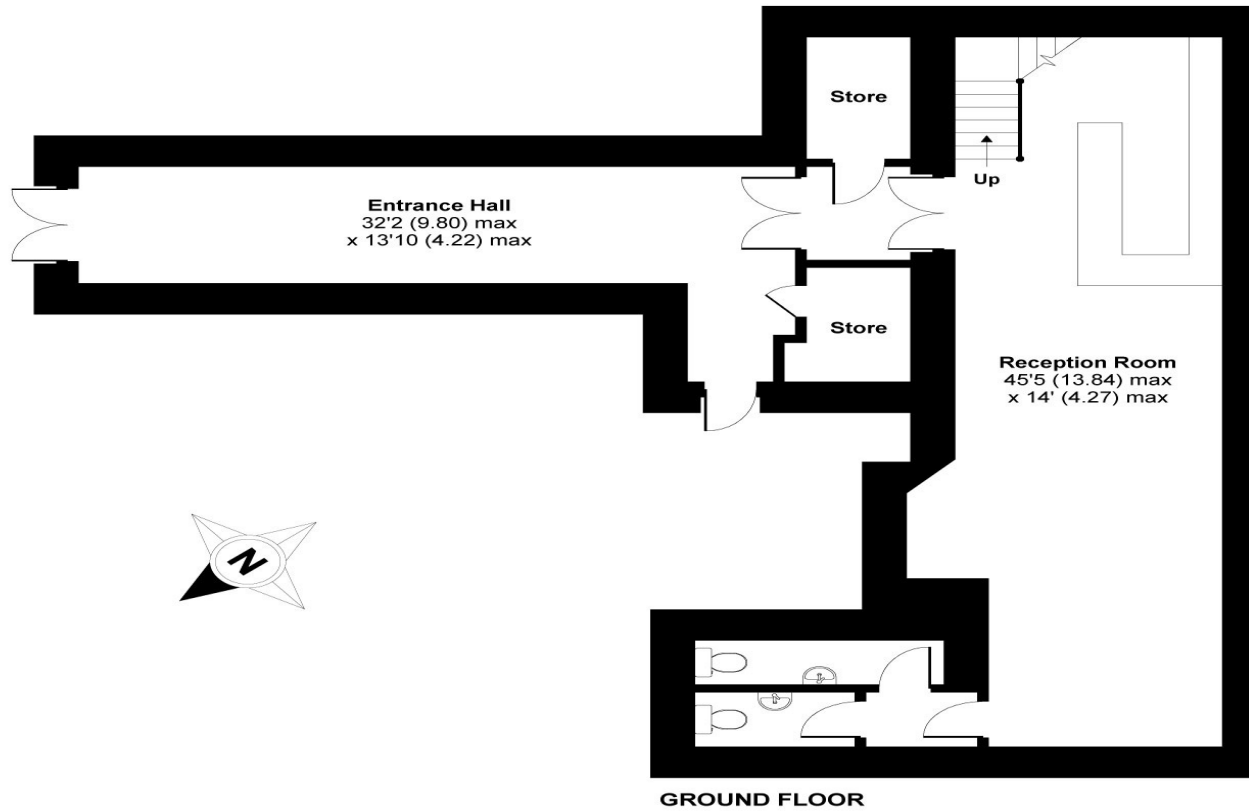
