TRI-TEMP DISTRIBUTION FACILITY (COLD STORAGE)

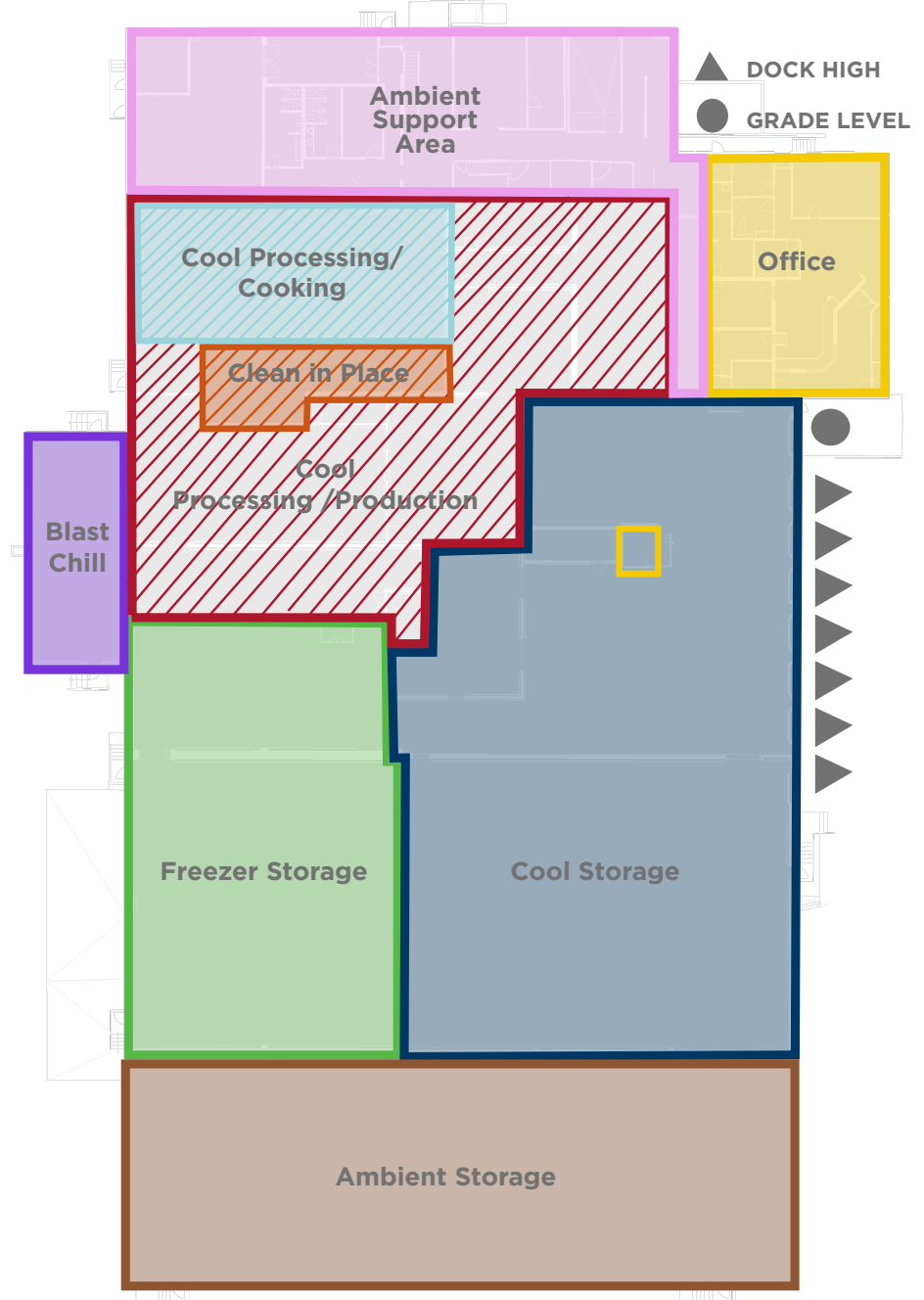
