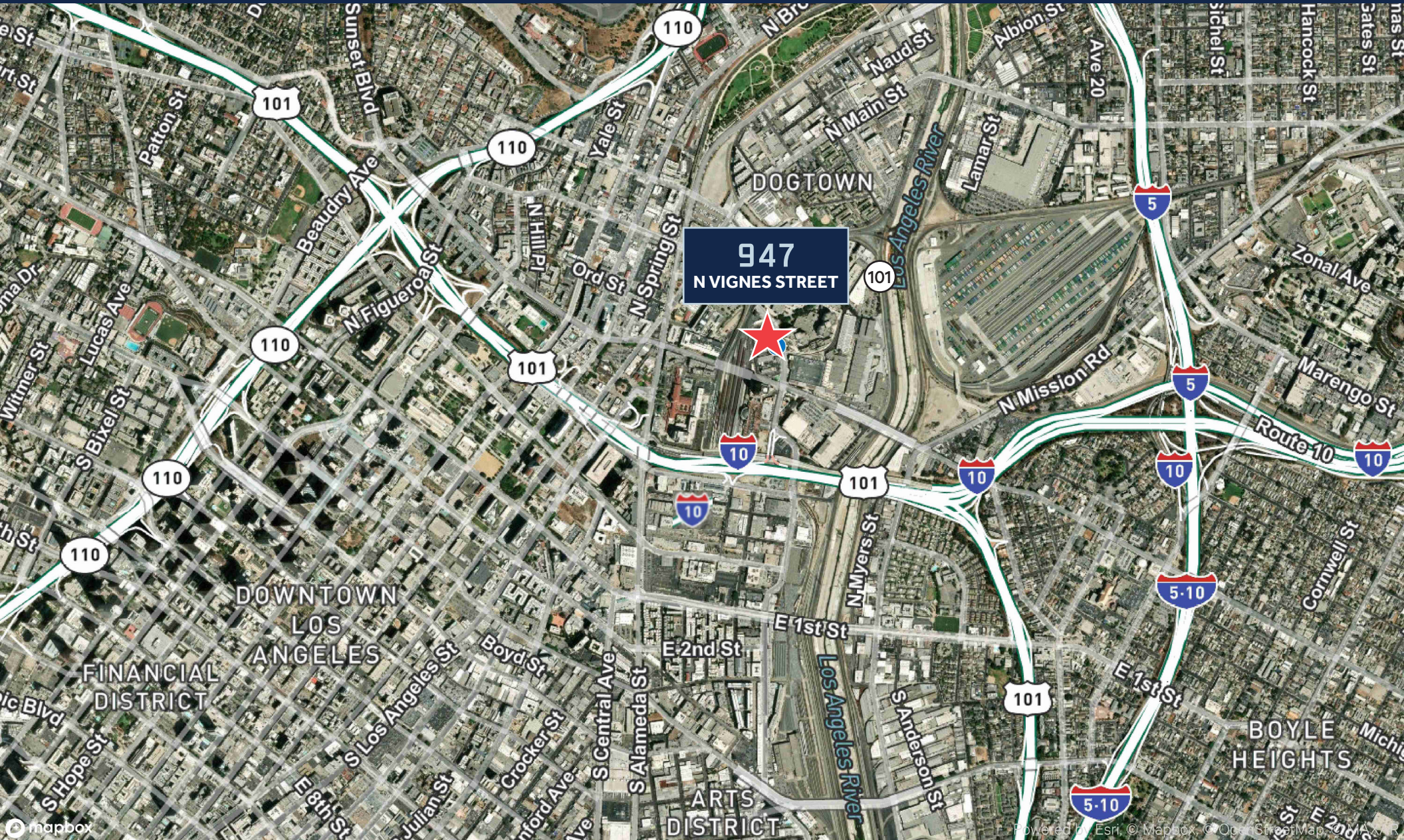


Location Map
