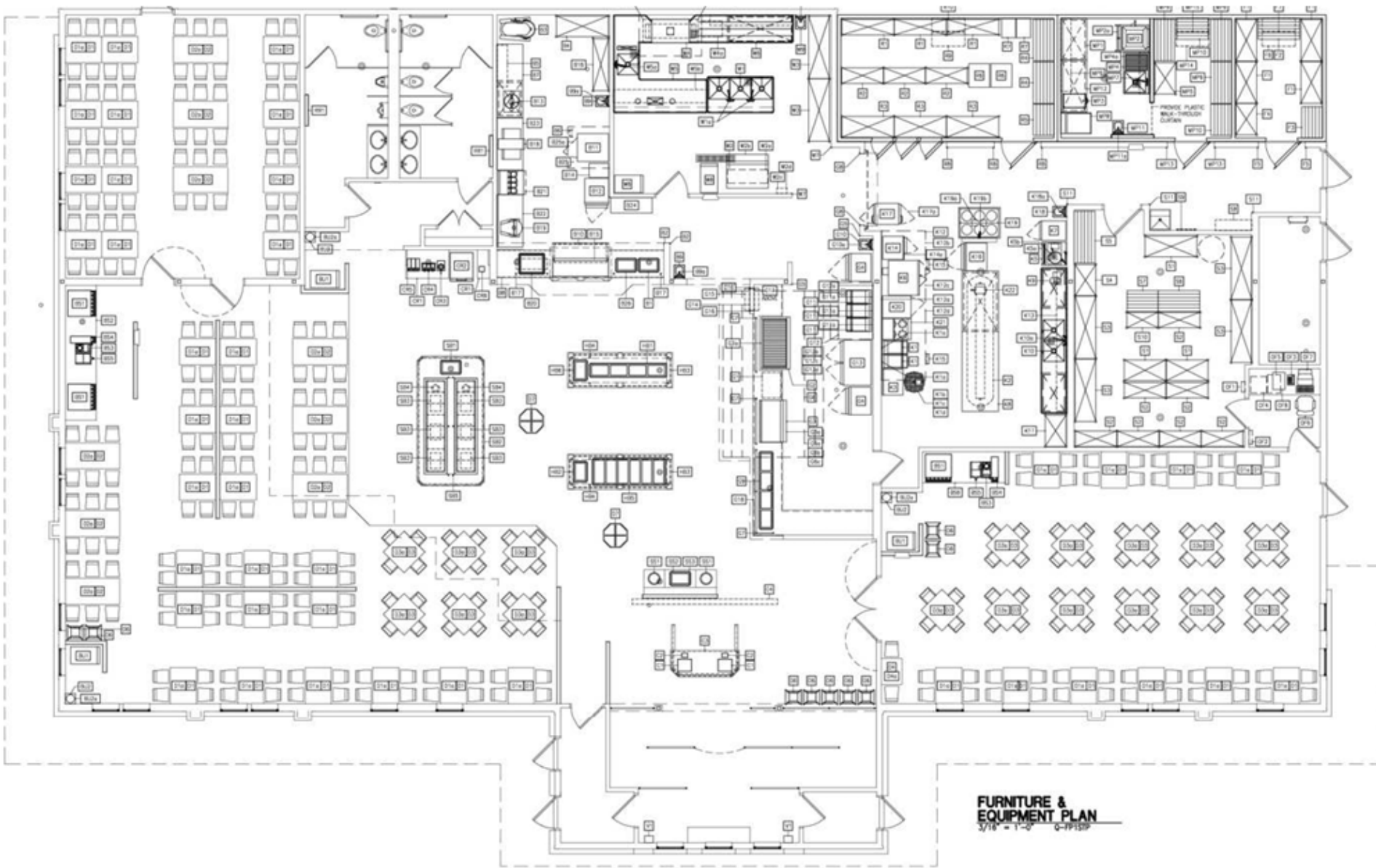

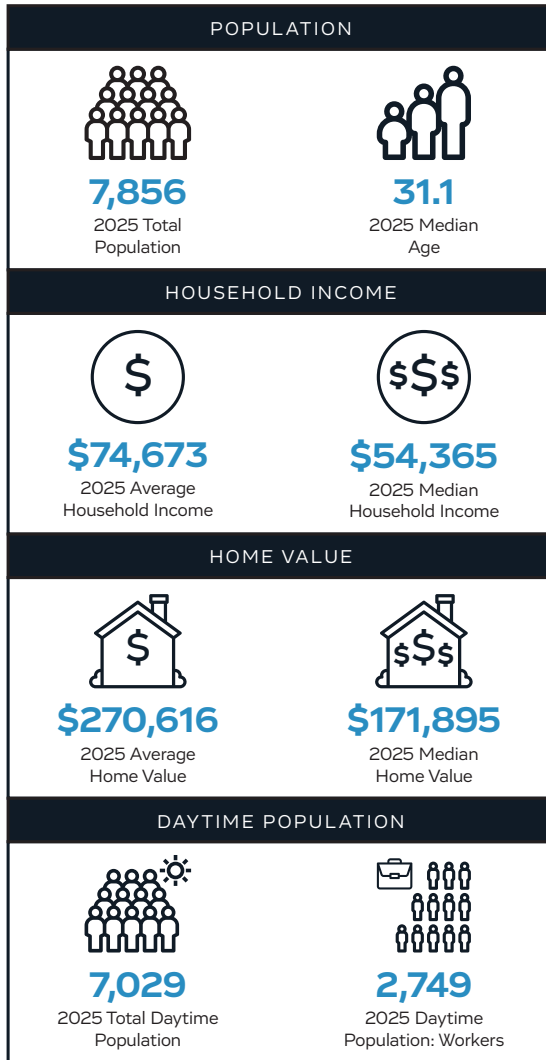

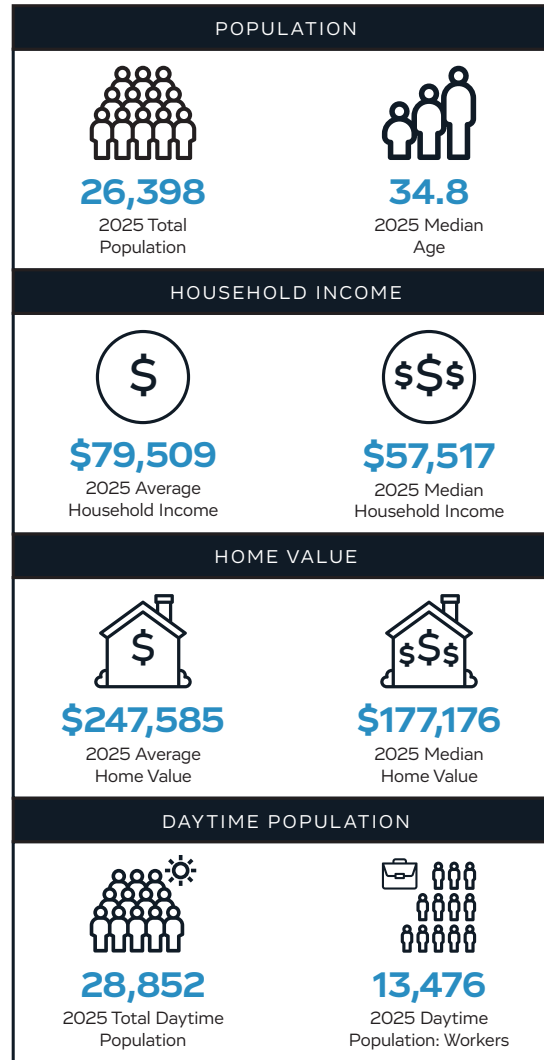

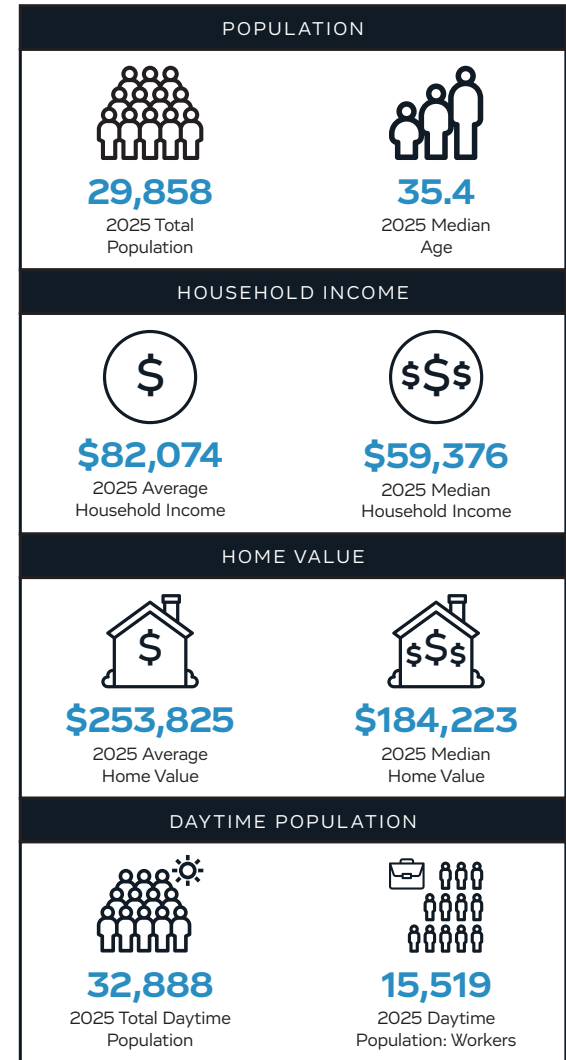

instructs the broker in writing not to disclose, unless required to do so by law.
