PROPERTY DESCRIPTION

A fully occupied, single-tenant commercial/industrial investment at 4030 Commercial Drive in Janesville's established Commercial Drive corridor. The 9,000 SF building is leased to Dawg Zone through August 2029 under a modified gross structure with 2% annual escalations, generating \$70,077 in current gross annual rent and \$60,077 NOI. With 3.3 years of lease term remaining and a local tenant in a growing service category, this is a clean, low-management asset with income in place and rent growth built in.

PROPERTY HIGHLIGHTS

- Fully occupied through August 2029 with 2% annual rent escalations baked in, so your NOI grows without renegotiation
- Six comp average across the Janesville submarket sits at \$89.67/SF validating the ask for a stabilized, income-producing asset
- Tenant pays CAM (lawn care and snow plowing); landlord expense load is limited to taxes and insurance
- The 2% annual escalation schedule pushes income-supported value closer to the comp set with every passing year
- Small industrial park setting, single tenant, no complex lease structure

BROKER DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS

- The duty to protect your confidentiality. Unless the law requires it, the Firm and its Agents will not disclose your confidential information or the confidential information of other parties (see "Confidentiality Notice to Customers" below).
- The duty to safeguard trust funds and other property held by the Firm or its Agents.
- The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.
