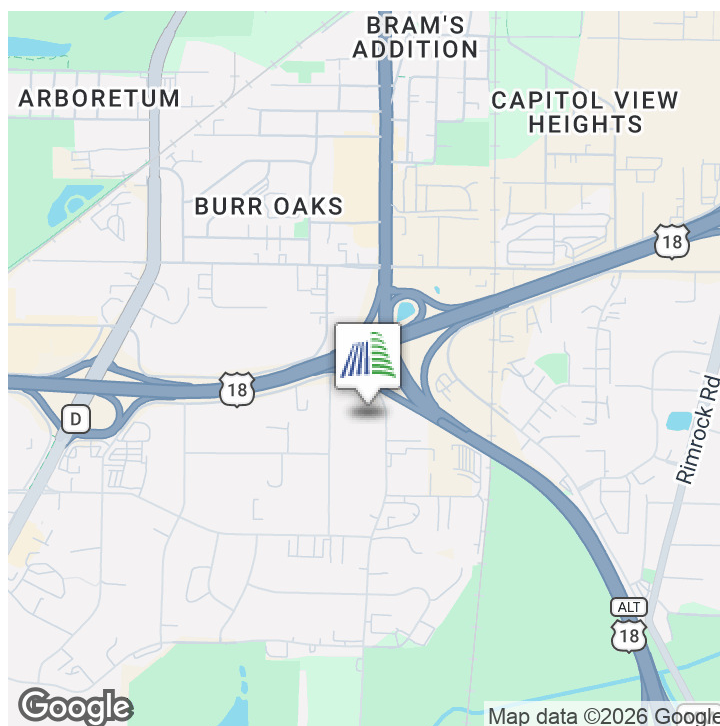

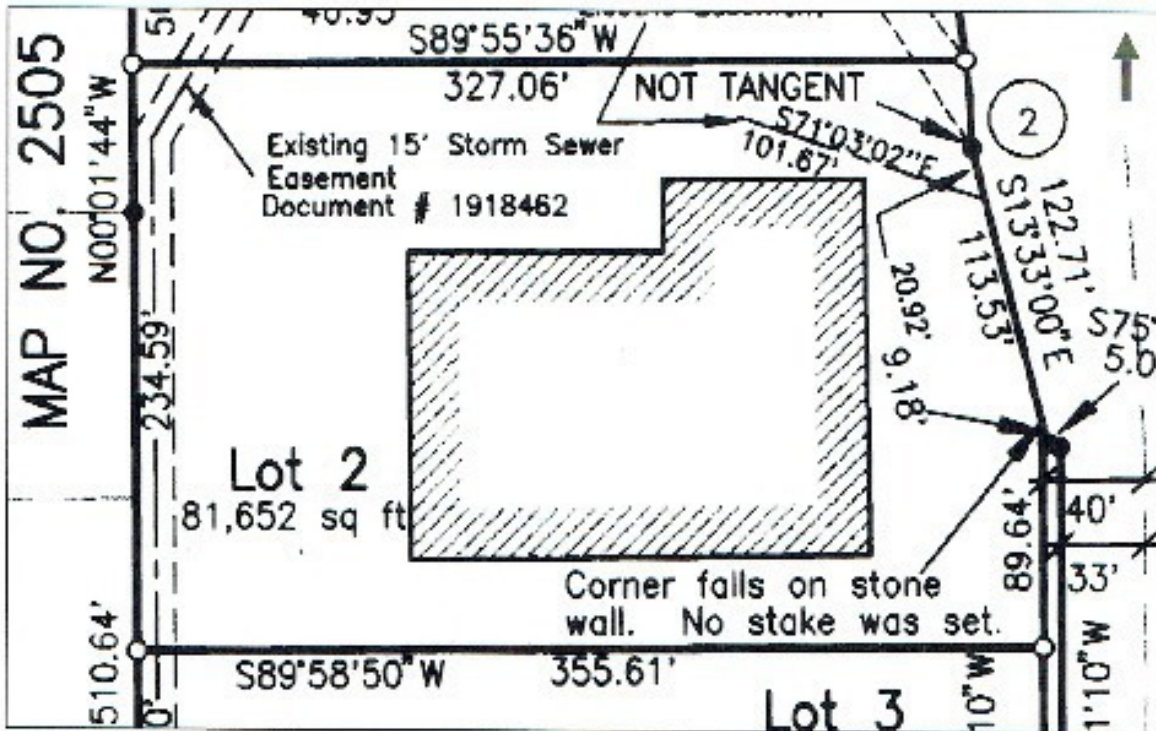

The site slopes downward from east to west about 10 feet.

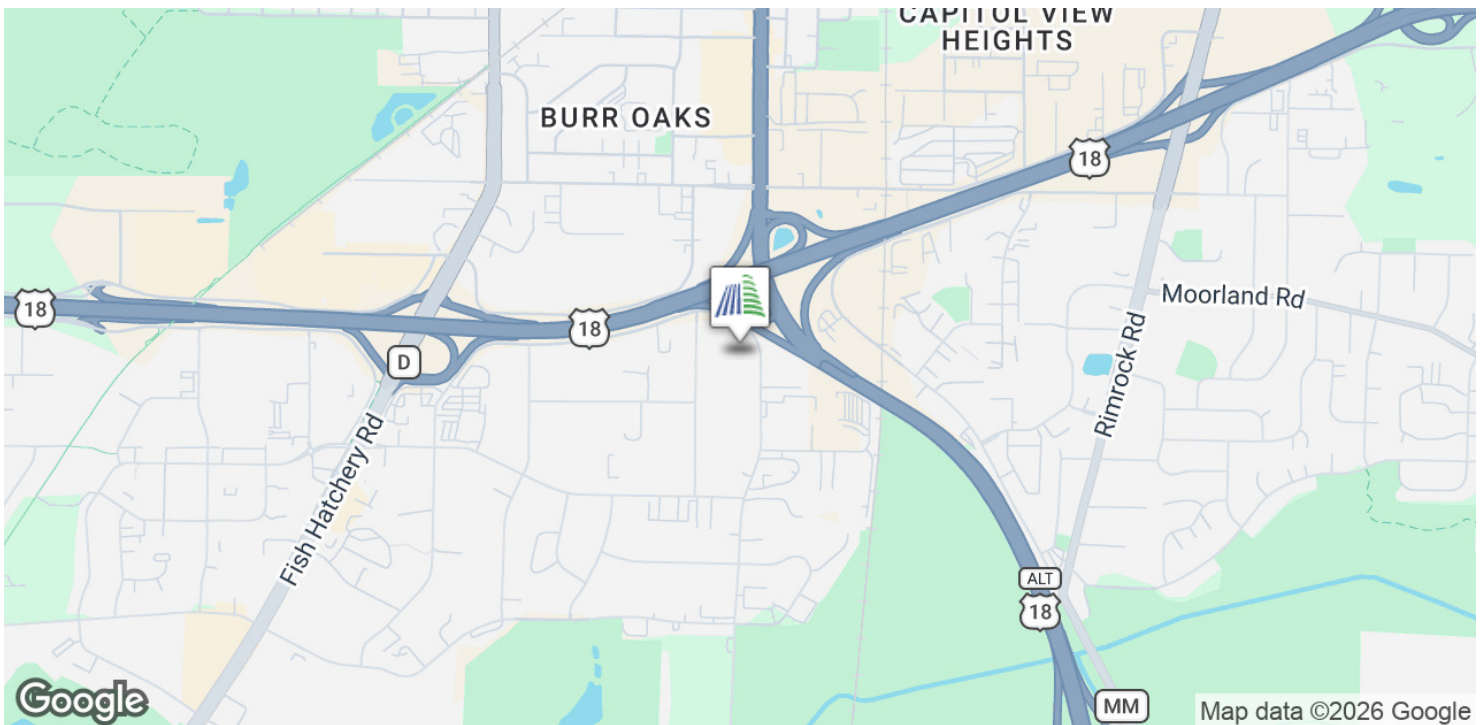
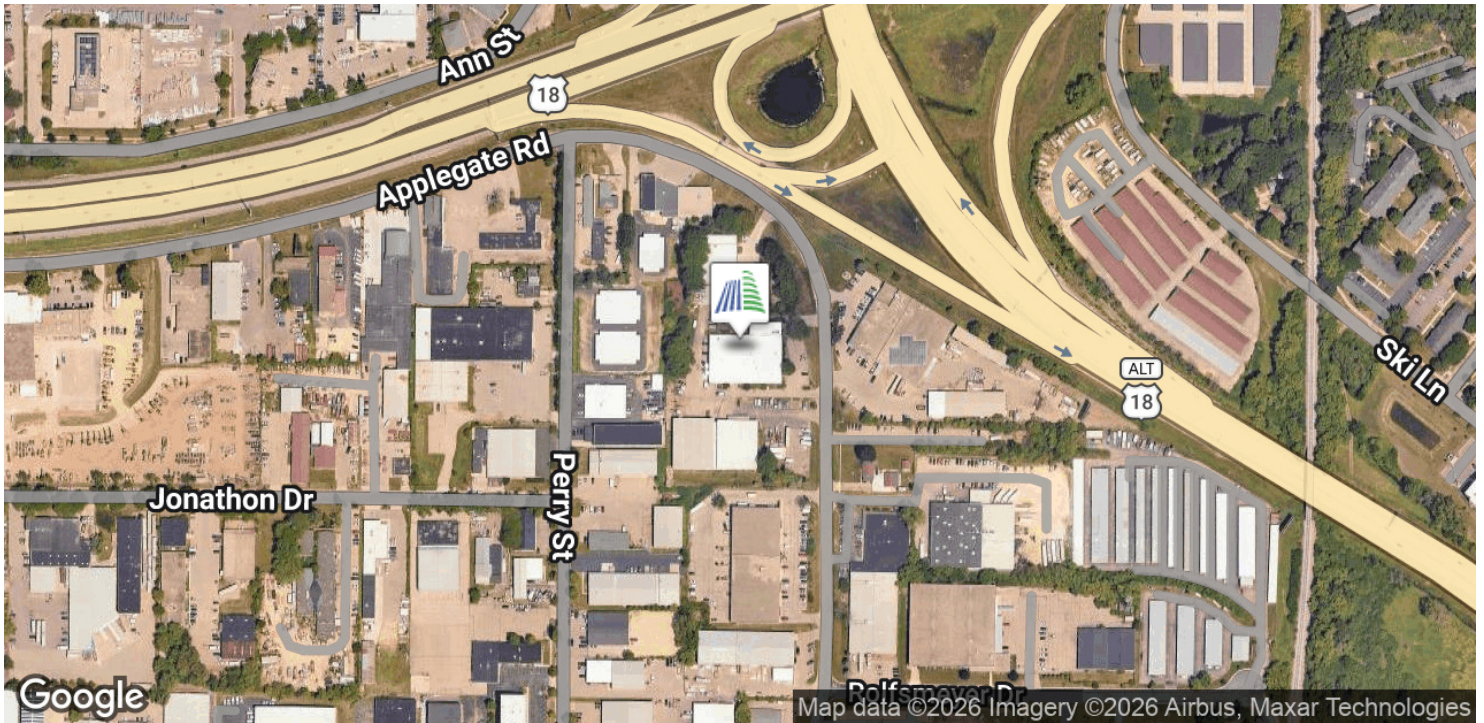
