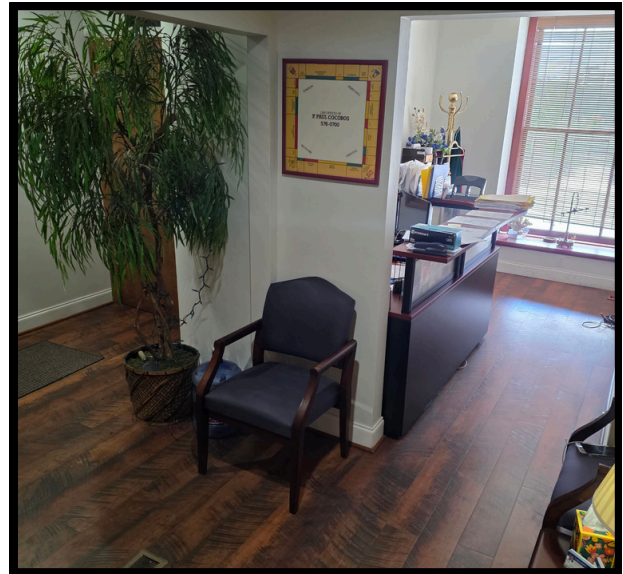

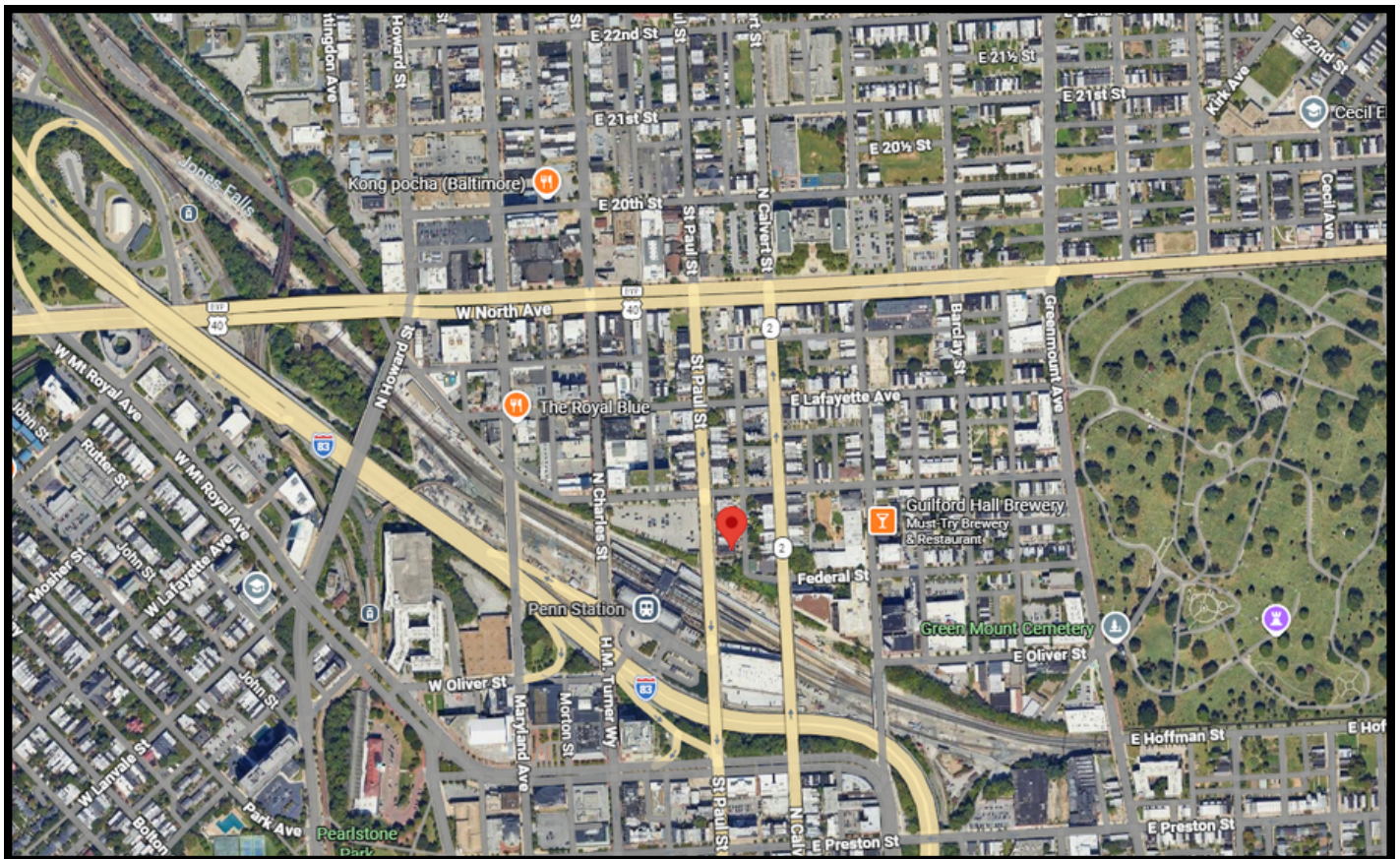

Map



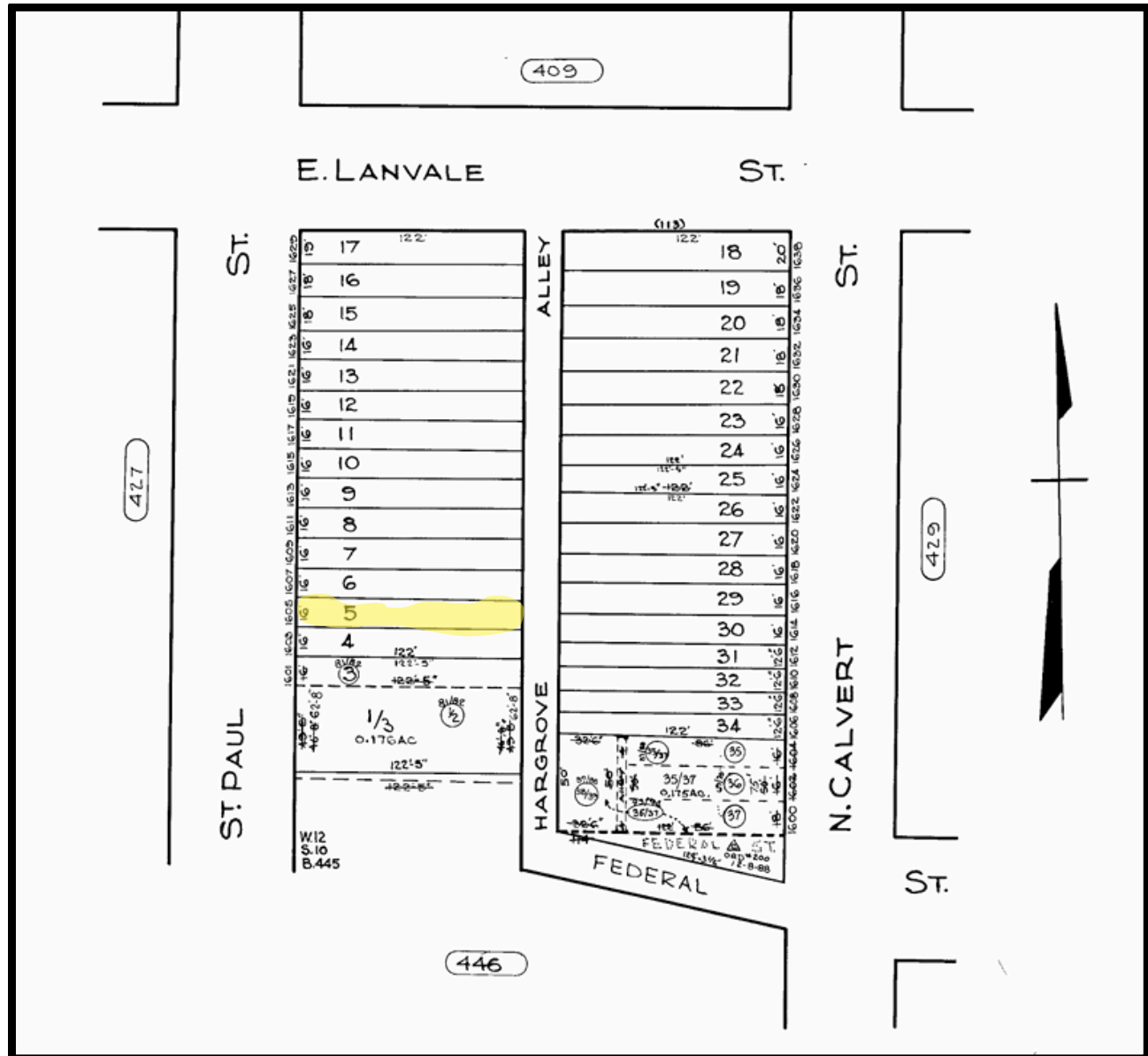
