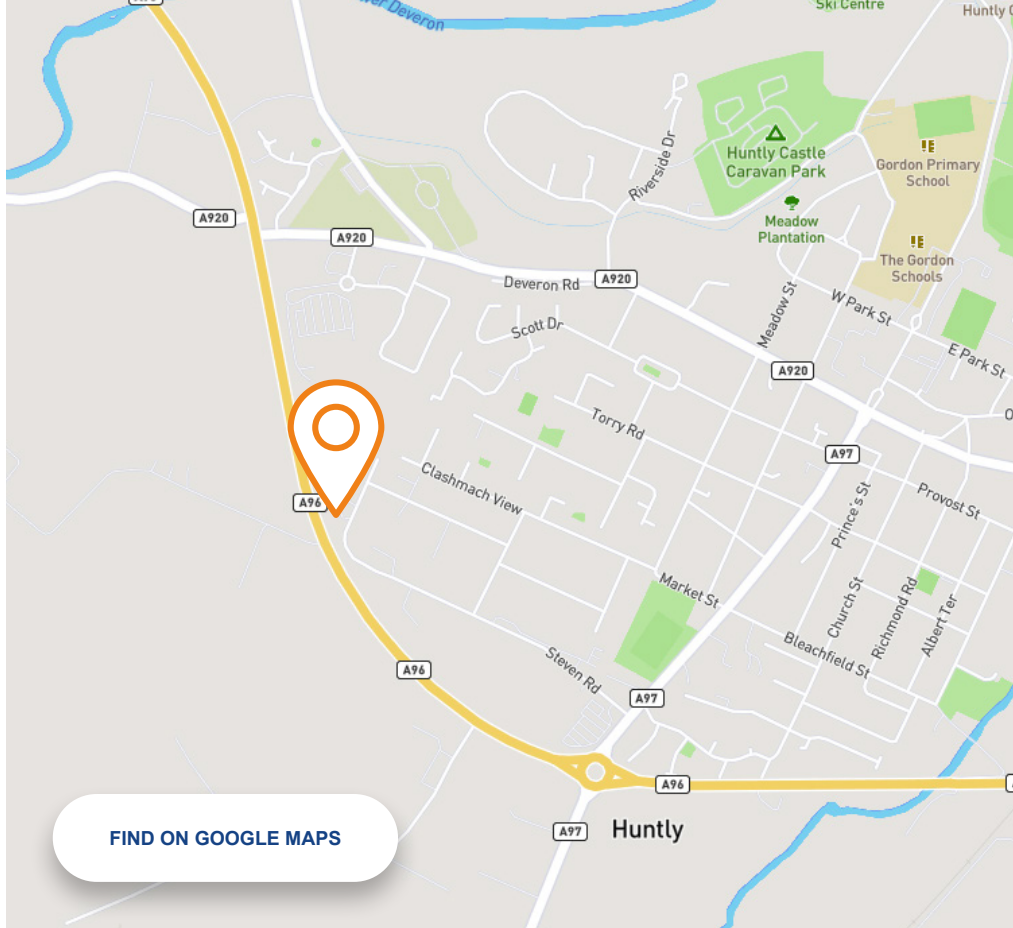

## LOCATION

The subjects are situated on Steven Road on the western most periphery of the Huntly Industrial Estate, which in turn lies a short distance north of the A96 Aberdeen-Inverness trunk road. Huntly lies 39 miles north-west of Aberdeen, with a population of approximately 4,300 and is the main service and employment centre to the north area of Marr within Aberdeenshire. Surrounding occupiers include Deans of Huntly, ASDA, Rizza's of Huntly, Jewson Building Merchants & Huntly Auto Services.

## DESCRIPTION

The subjects comprise a detached single storey office building with associated car parking. Externally the subject is of blockwork construction with render under a pitched, tiled roof. Internally, the subjects provide an open plan reception area with adjacent meeting rooms alongside a number of private offices as well as kitchen and WC facilities. The subjects are primarily carpeted throughout and heating is by way of electric panel heaters. There is a car park providing 20 car parking spaces. The perimeter is laid to lawn.

The property is offered on Full Repairing Insuring (FRI) terms. Any medium or long term lease will incorporate periodic rent reviews. Short term leases will be considered.

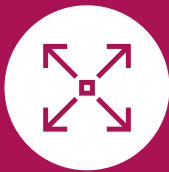
## EPC

The building has a current Energy Performance Certificate of TBC.

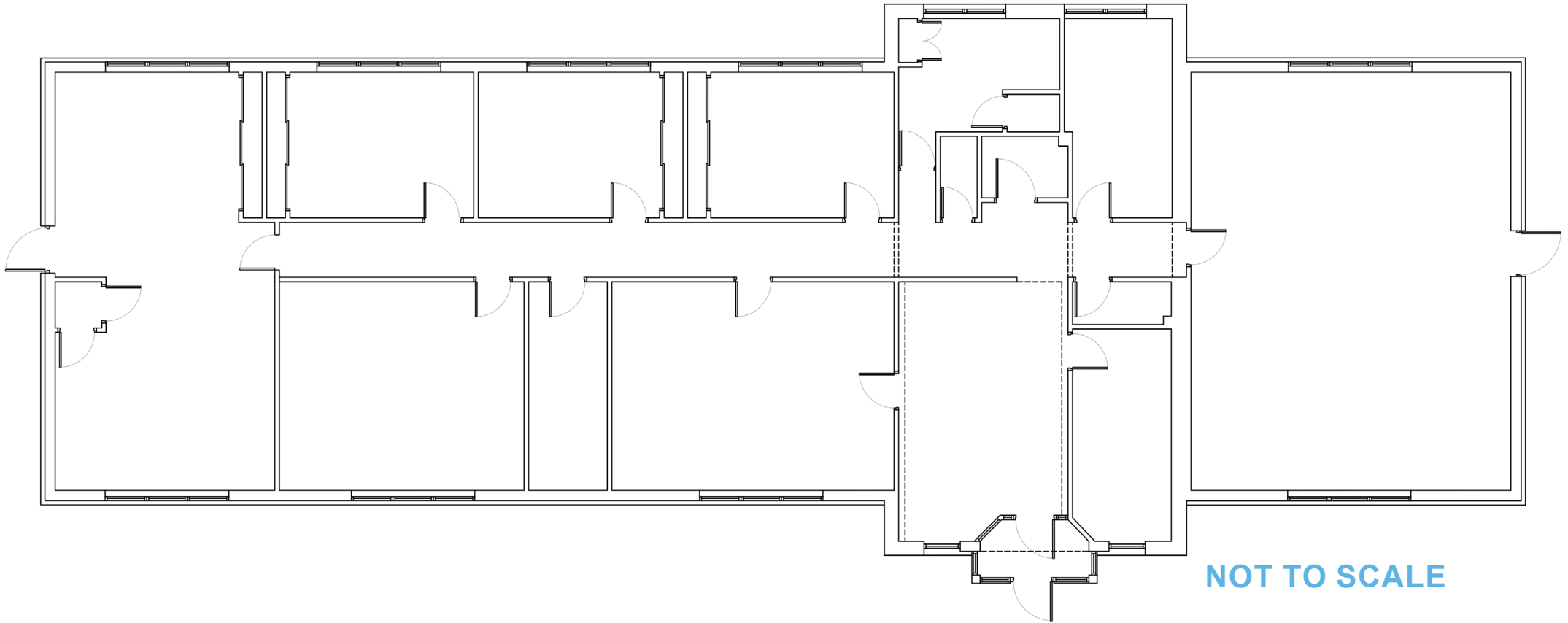
## LEGAL COSTS
