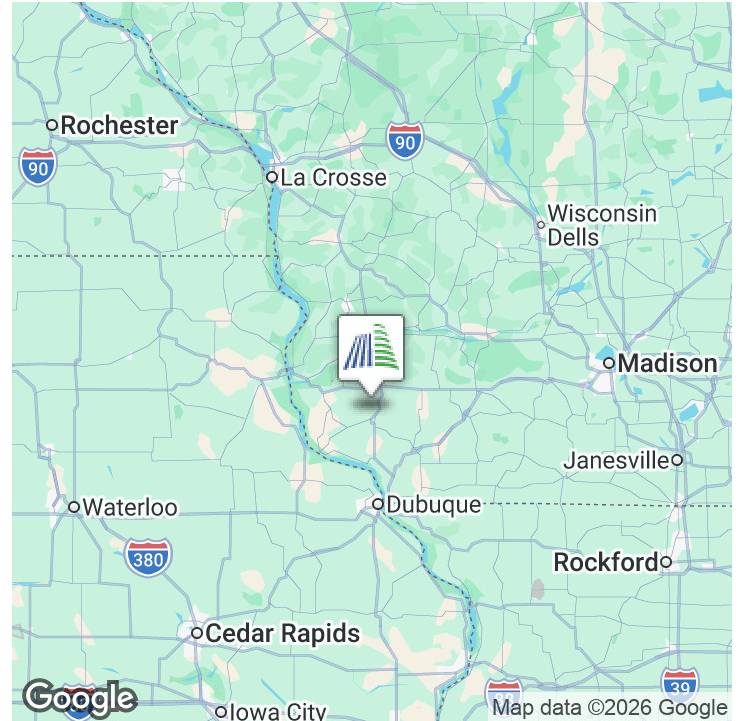

## PROPERTY OVERVIEW

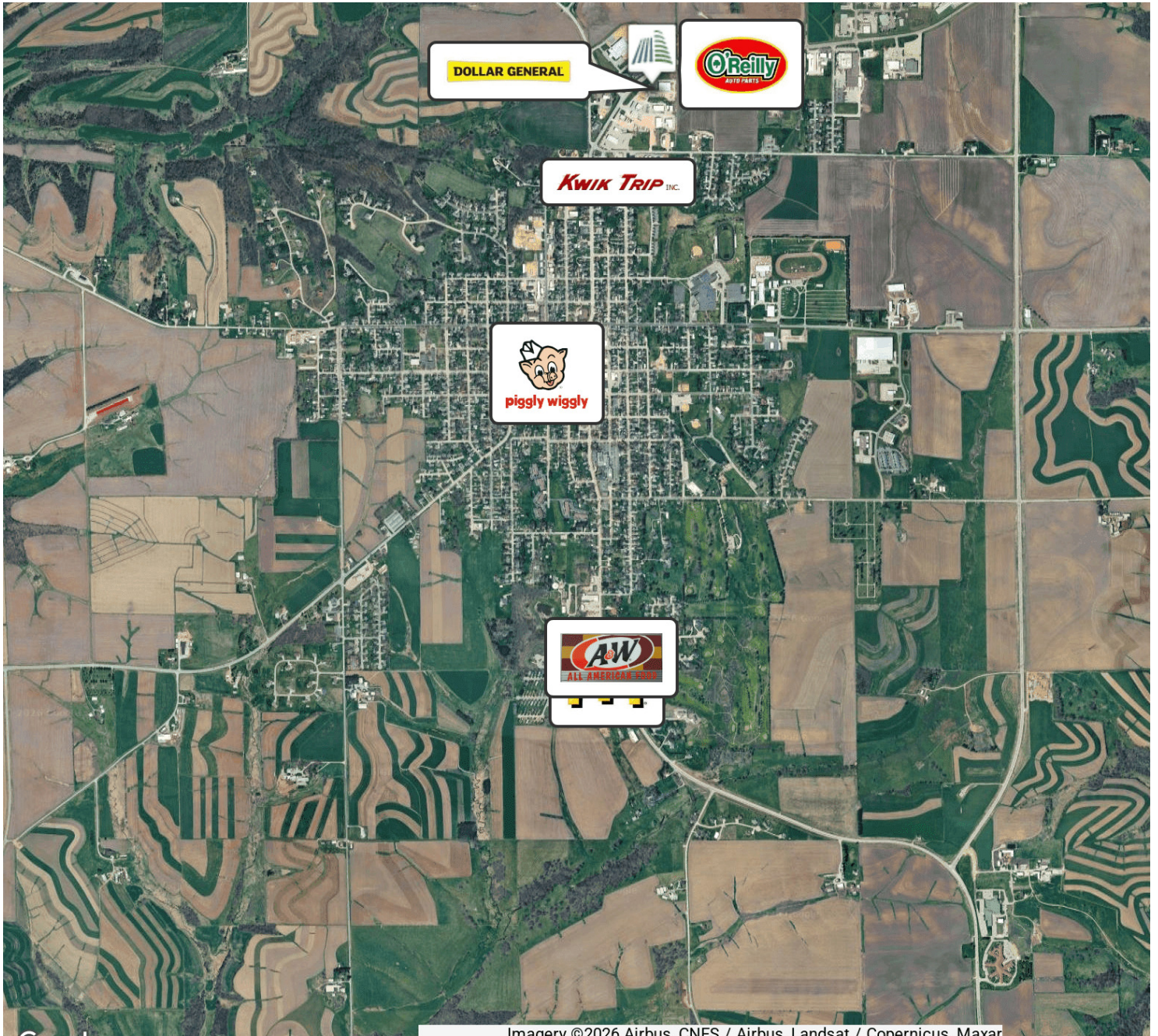

**Landlord Responsibilities:**

- HVAC, Plumbing & Electrical repair/replacements over \$500.
- Parking lot maintenance, lawn care and landscaping. (Tenant pays \$417/mo to LL as a reimbursable for this expense, this number increases with every renewal.)

**Tenant Responsibilities:**

- Rent (\$6,410/mo - \$76,920/year)
- Utilities
- HVAC Preventative Maintenance Work... To be serviced quarterly.
- Minor HVAC, Plumbing and Electrical repairs under \$500.
- Real Estate Taxes
- Insurance
- Snow Removal (This is separate from “parking lot maintenance.”)

**DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS**

- 16 (f) The duty to safeguard trust funds and other property held by the Firm or its Agents.
- 17 (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the  
18 advantages and disadvantages of the proposals.
