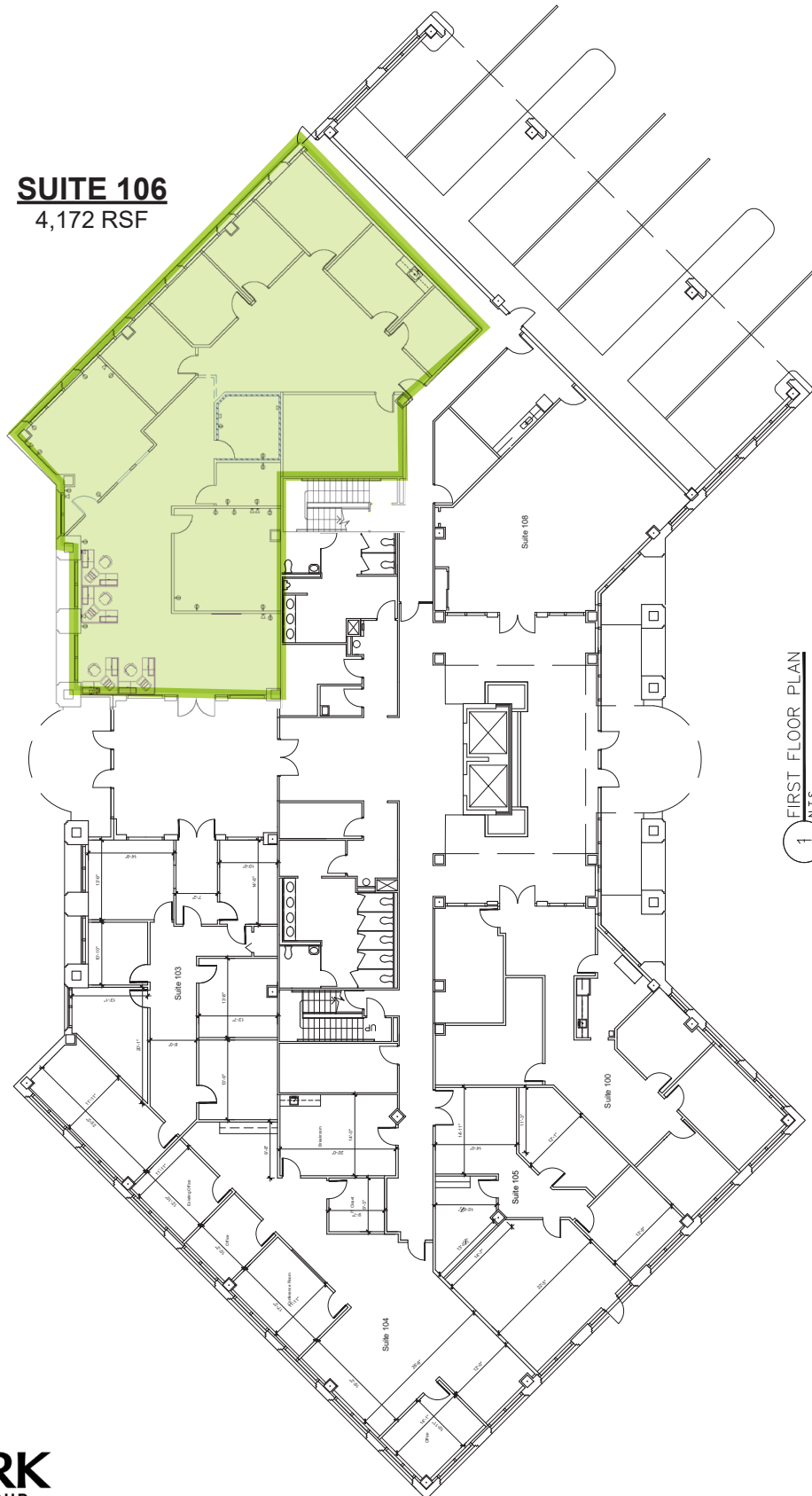

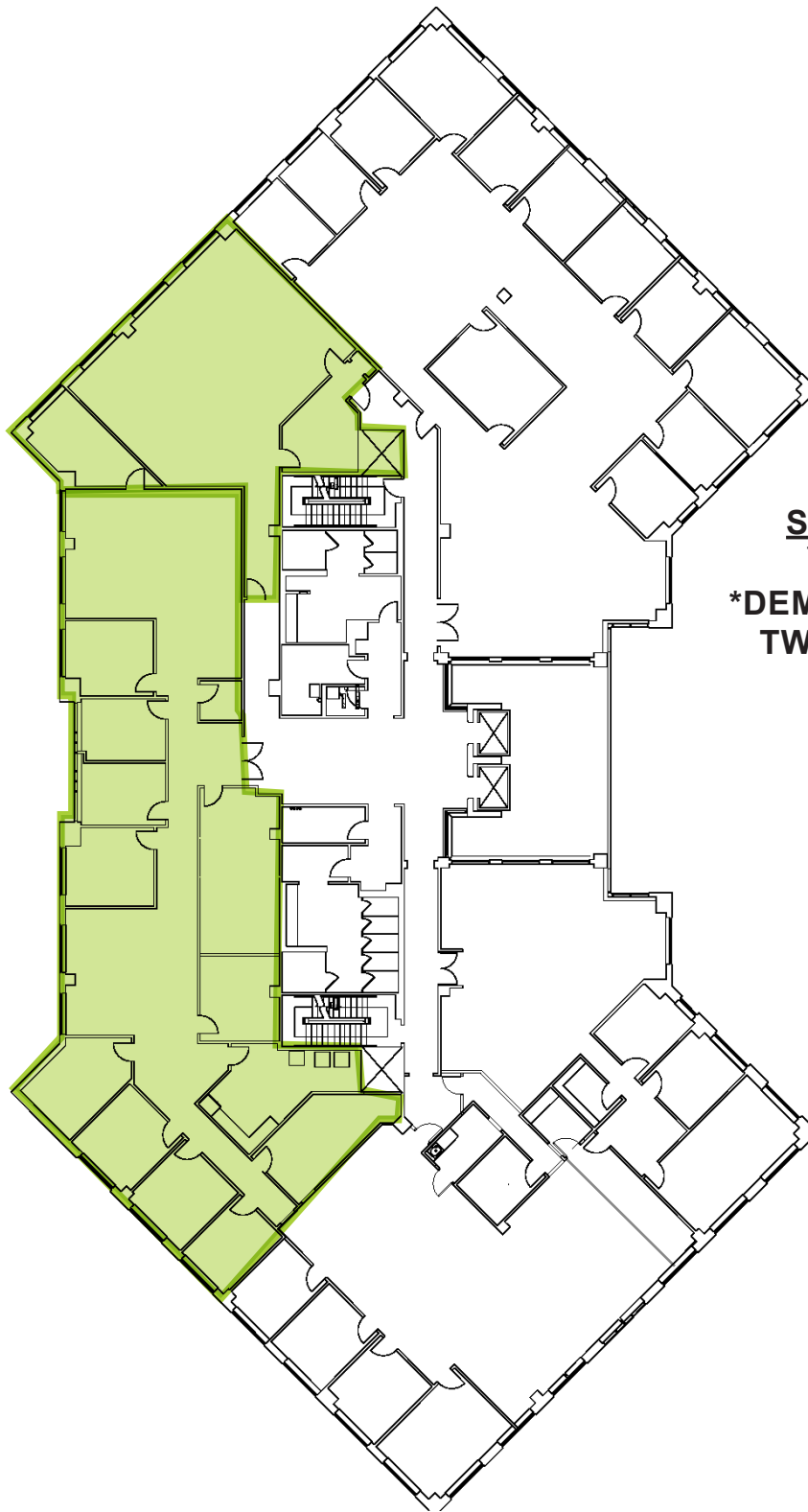
1 FIRST FLOOR PLAN

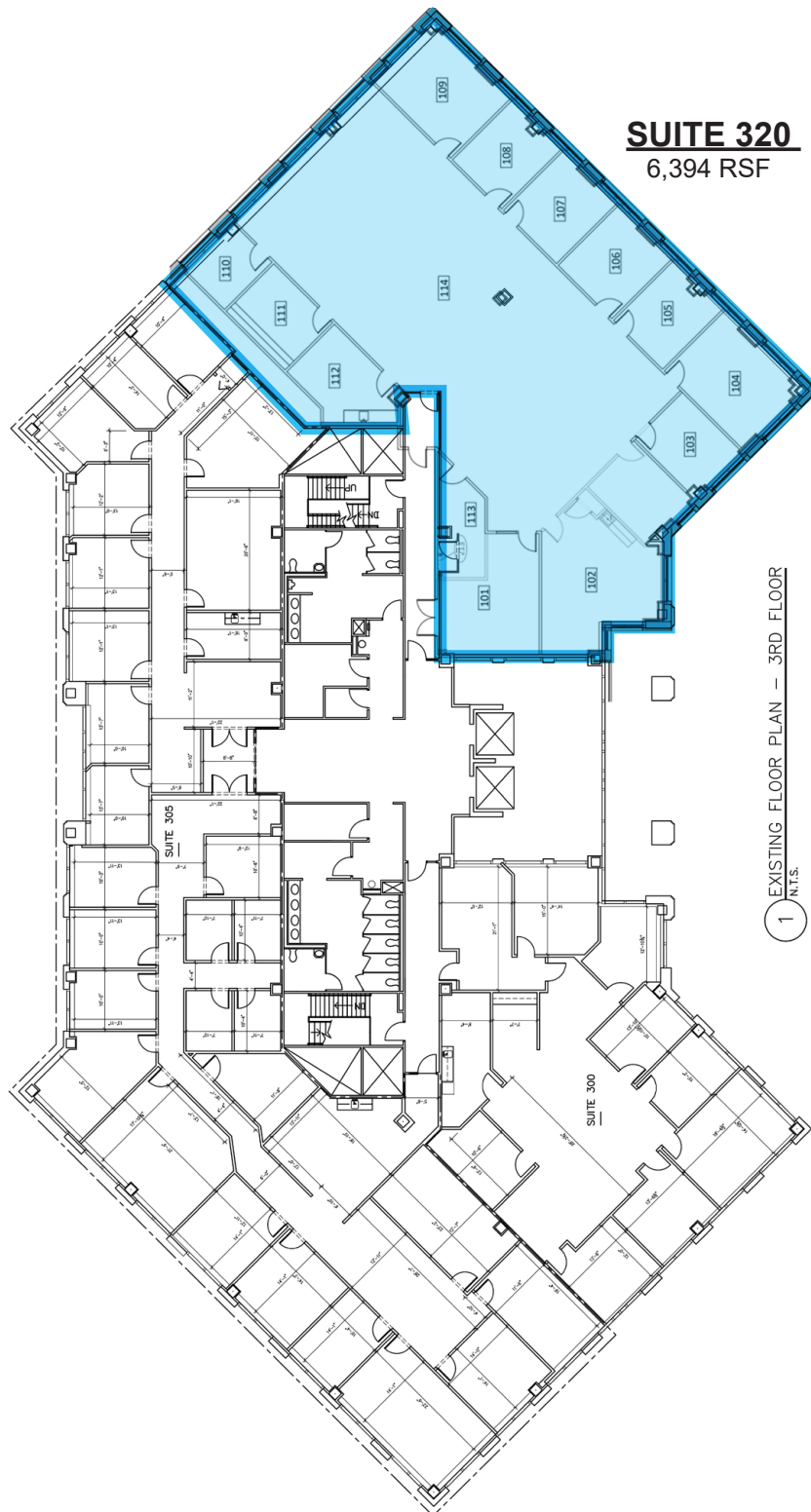
