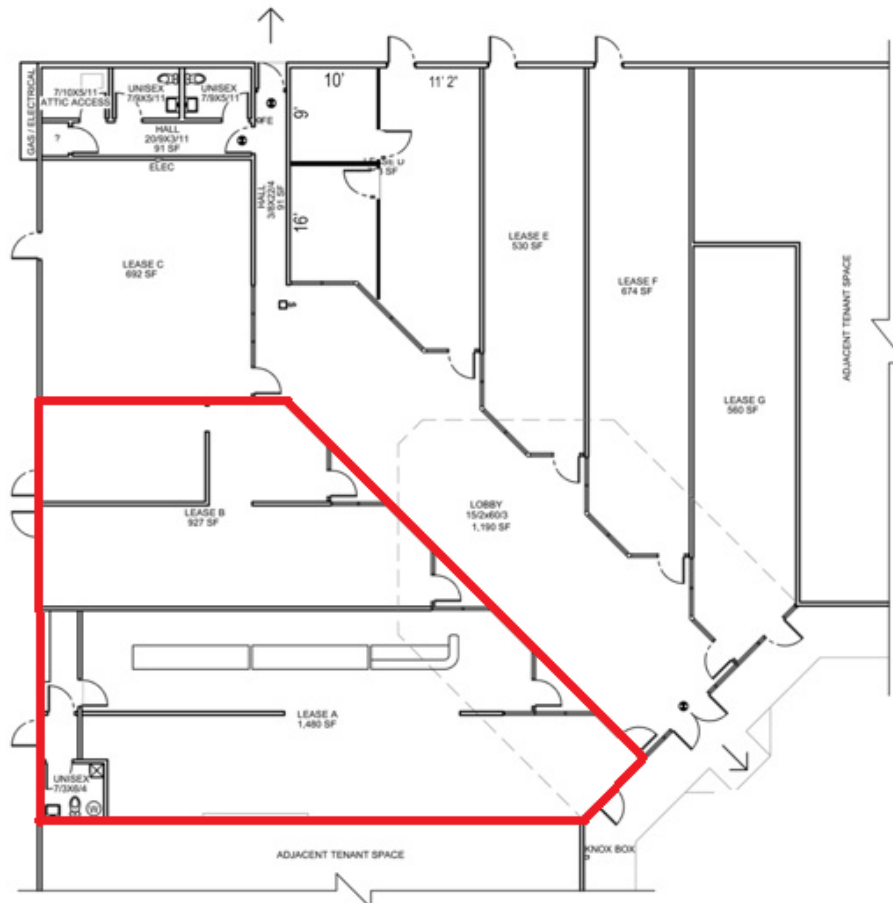
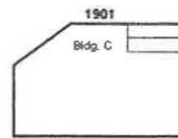
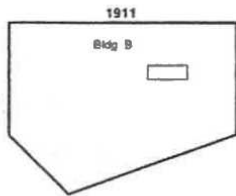


FLOOR PLAN
