DESCRIPTION

Unit 1, Churchill Court is one of only six self-contained two story office buildings set within this popular gated courtyard scheme within a short distance of the town centre.

The building provides flexible open plan space which has been enhanced by the current owners to include some demountable partitions creating a number of private offices.

The building has raised floors allowing for underfloor cable management, suspended ceilings with LED lighting, concertina security grills to the ground floor windows, an electrically operated security shutter to the entrance door, a ground floor kitchen/staff room, a smaller first floor kitchen and male and female cloakrooms. The property also has 18 car parking spaces.

LOCATION

Churchill Court is located in the established commercial part of Westerham just to the north of the town centre.

Westerham is a recognised and popular business location strategically situated on the A25 approximately 5 miles west of Sevenoaks and 4 miles east of Oxted.

The town is roughly equidistant from Junctions 5 and 6 of the M25 motorway via the A25. Mainline railway connections are available at both Sevenoaks and Oxted providing frequent services to Central London.

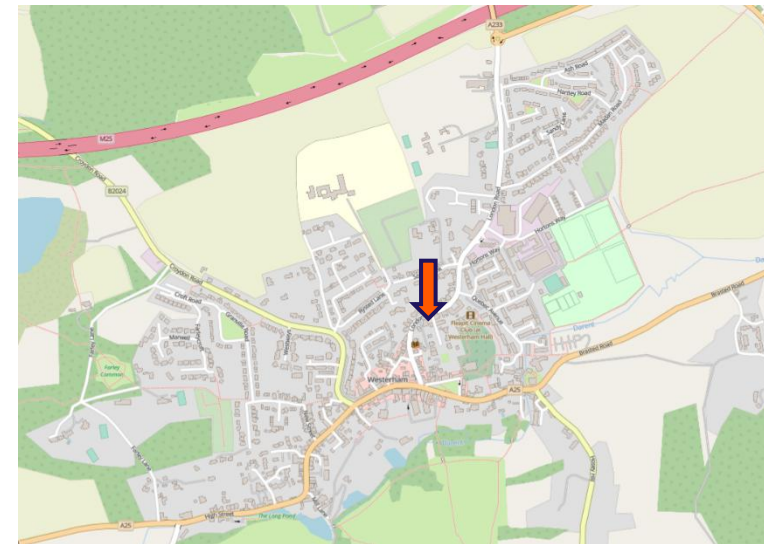
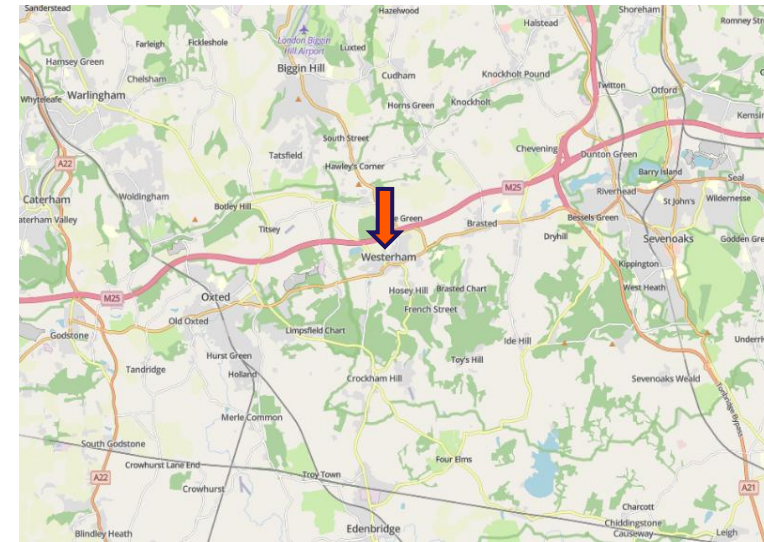
