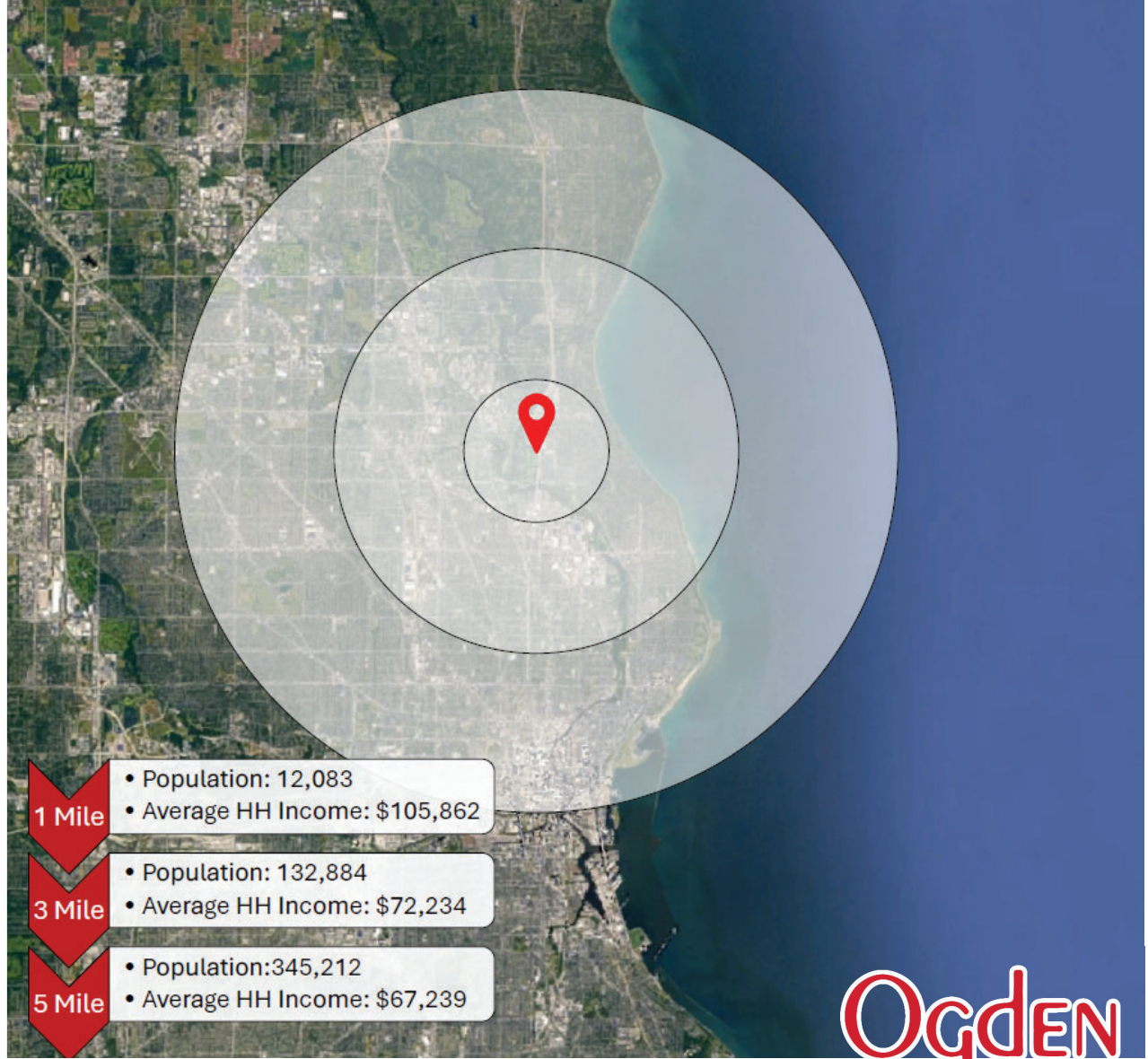


LOCATION MAP |

RETAIL MAP |

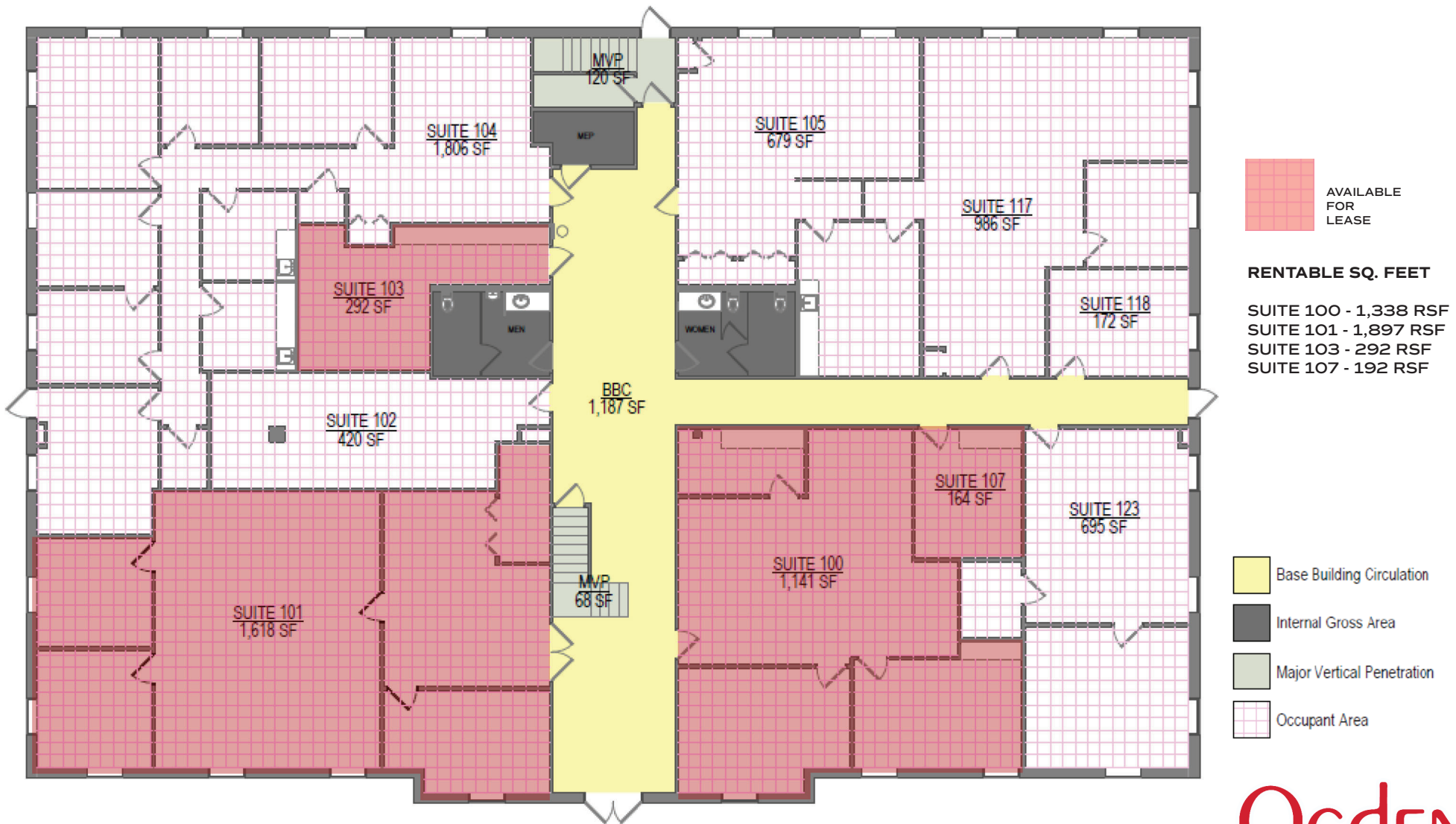

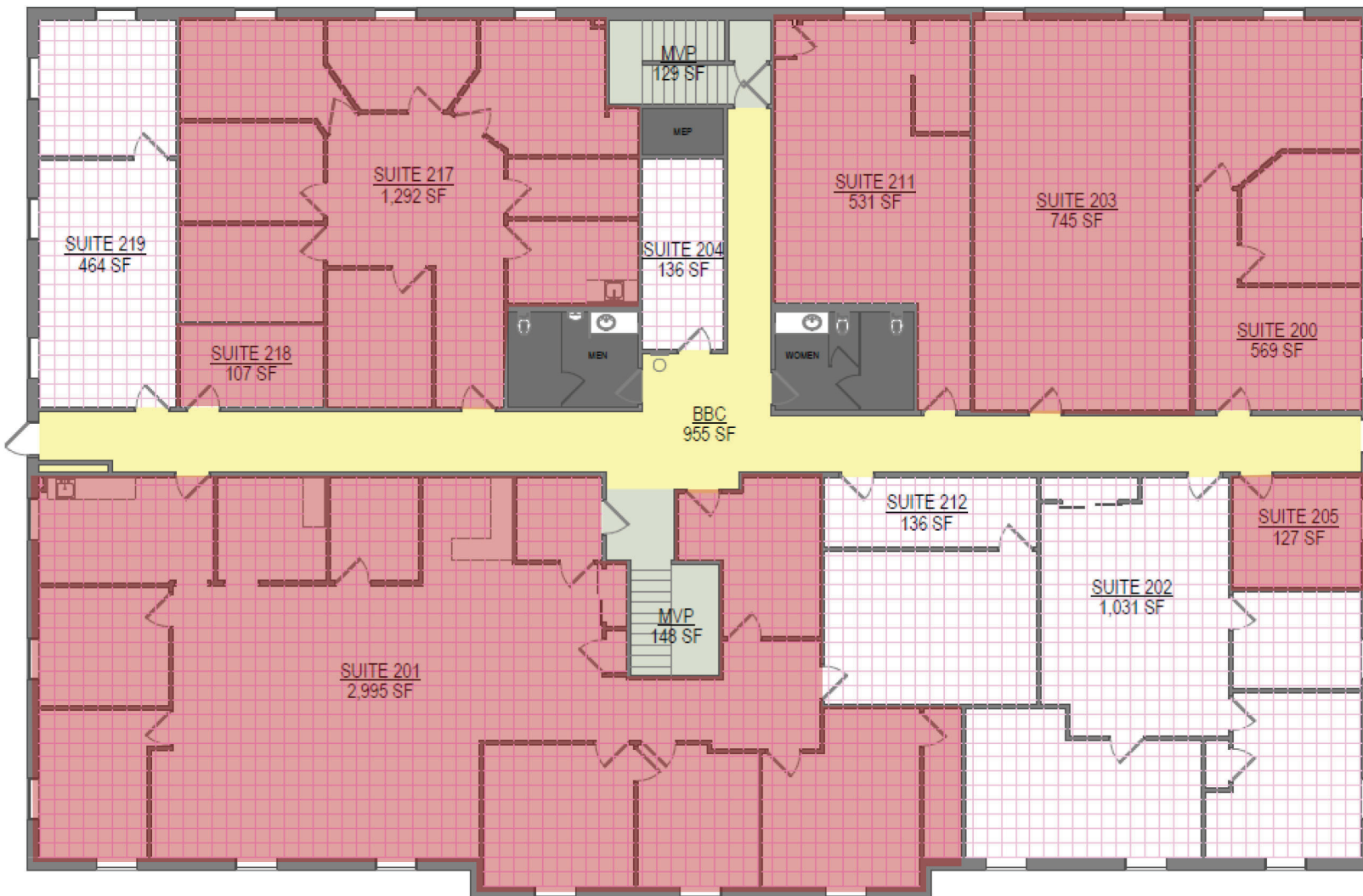
FLOOR PLAN | 5205 N. IRONWOOD RD. - FIRST FLOOR







FLOOR PLAN | 5205 N. IRONWOOD RD. - SECOND FLOOR

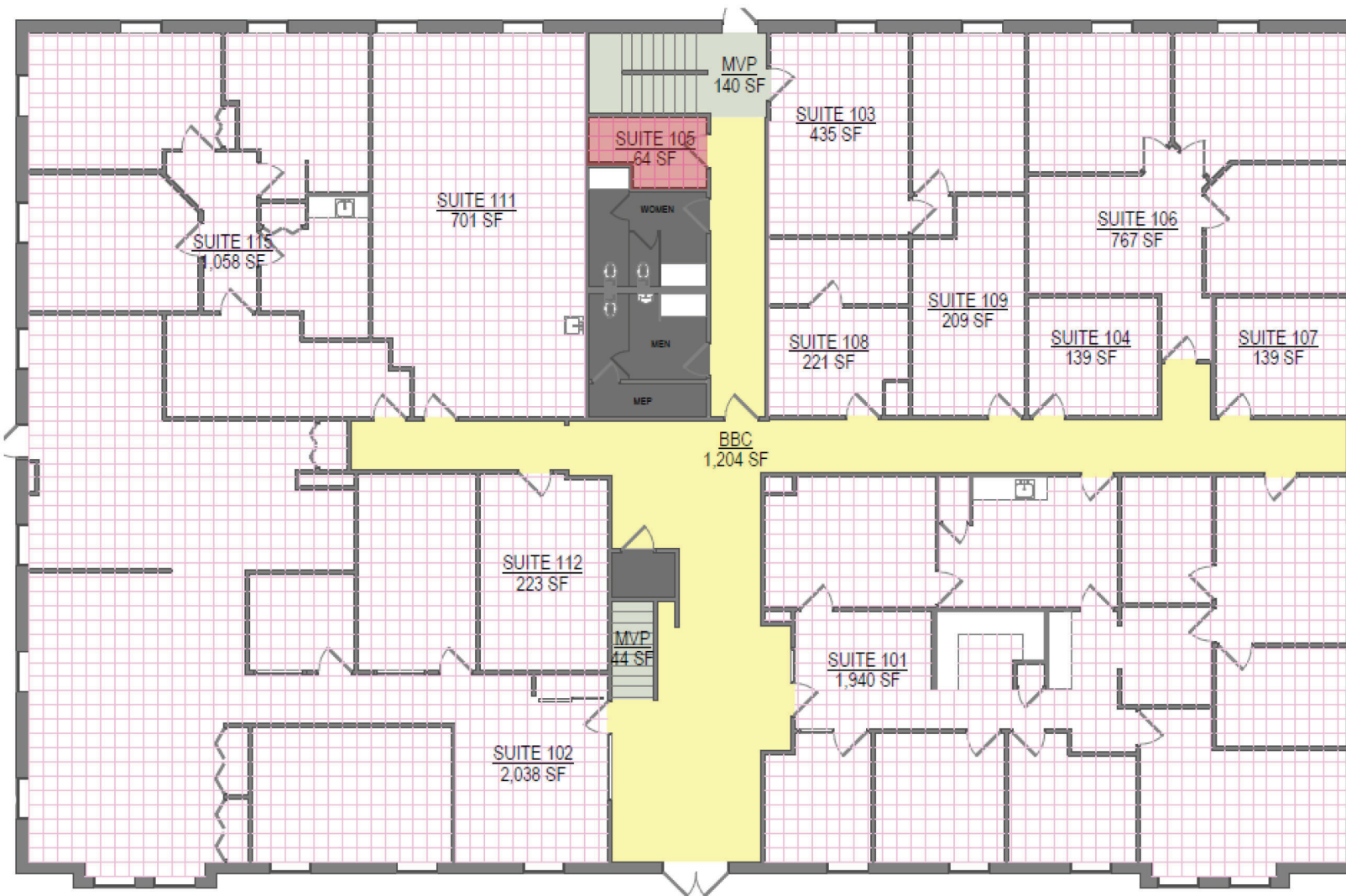

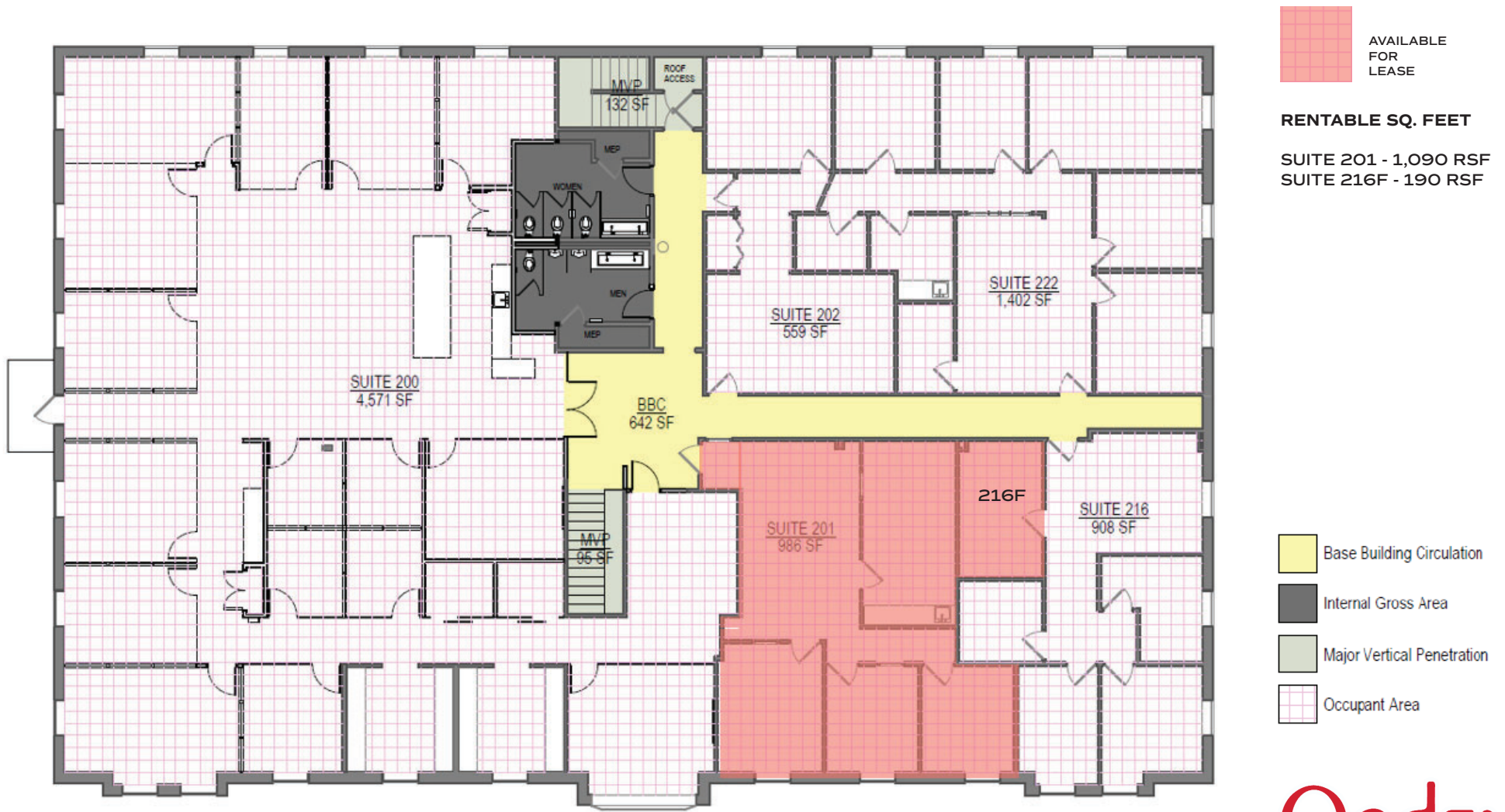

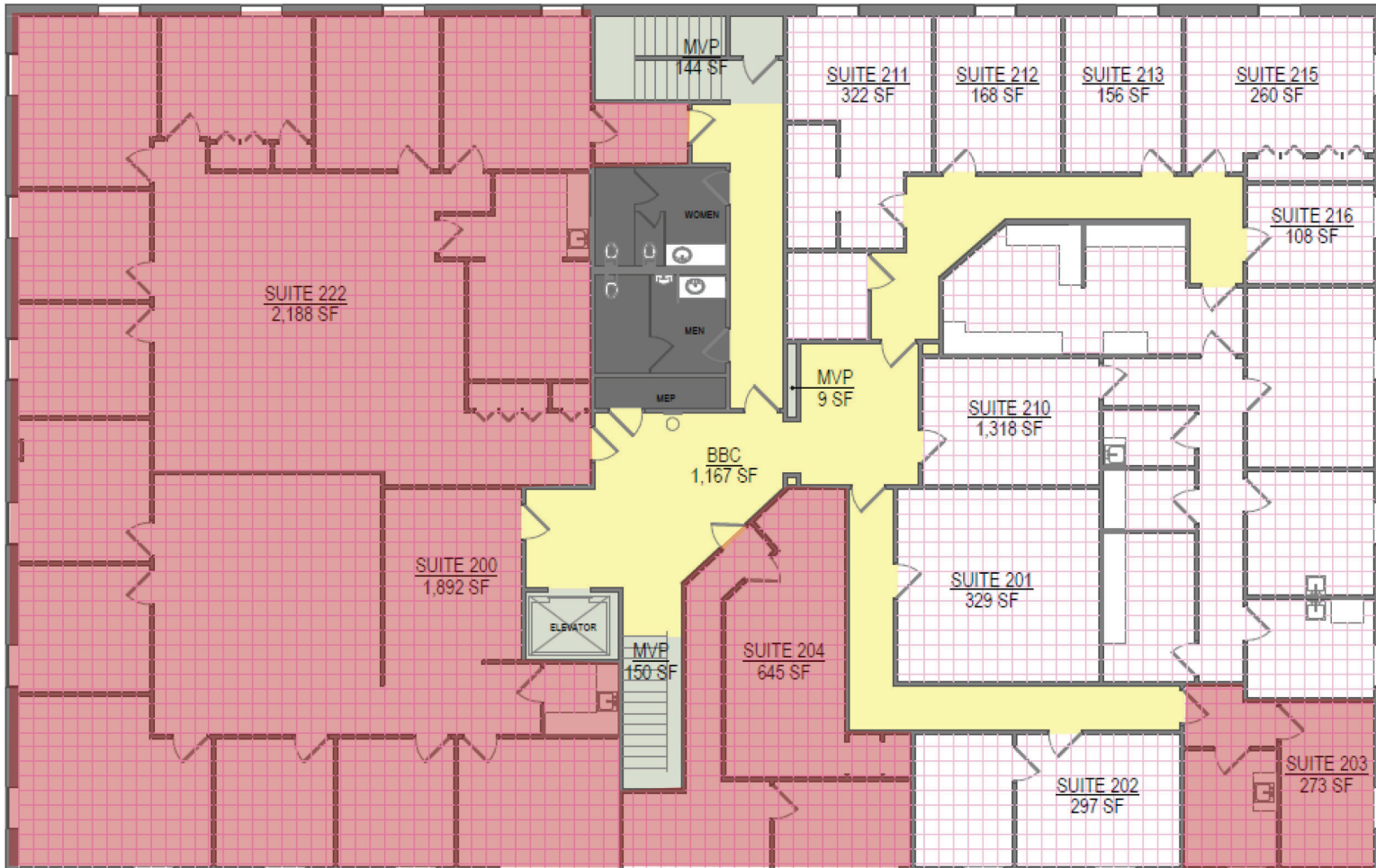
