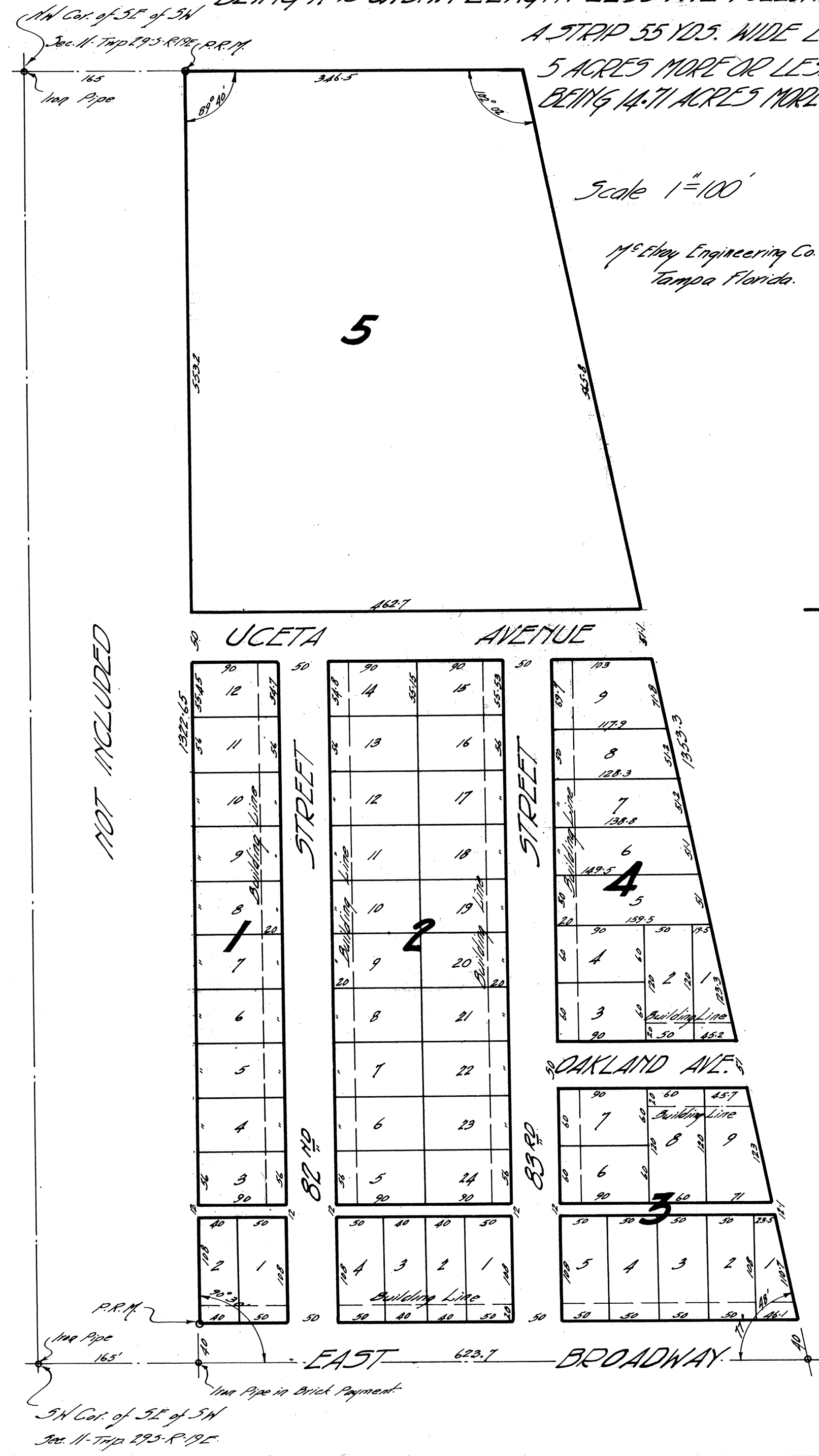


HELLEKES SUBDIVISION 25-36

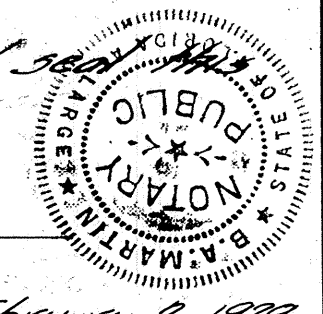
