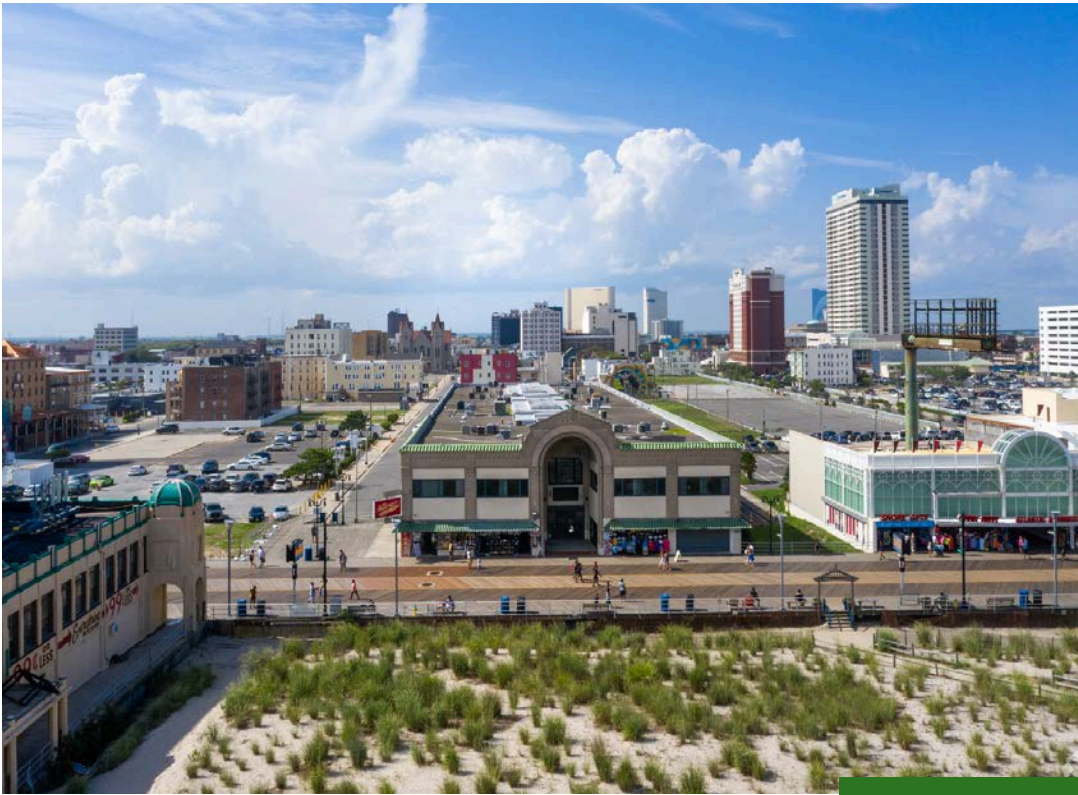

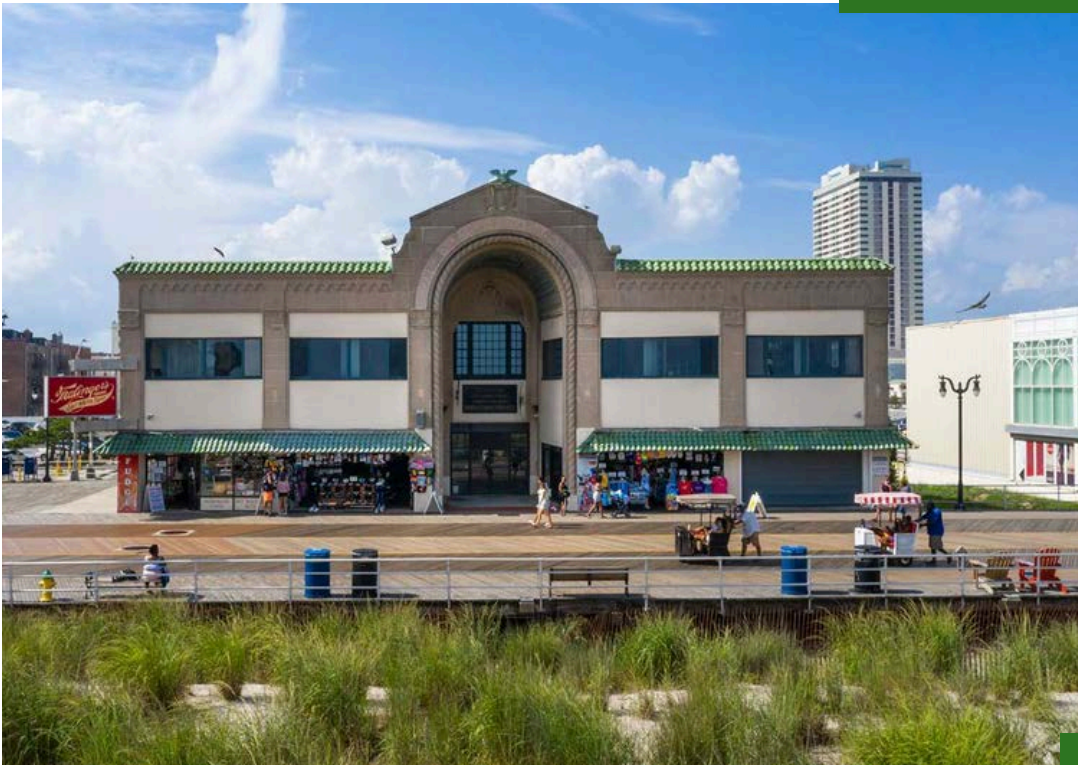

Tenate Overview

State of NY (Casio Control Commission, since 1989 the CCC has been primarily the anchor tenant for the office portion of the building (66,000 SF) Their 48-year operating history exemplifies their commitment to this site and commissions desire to keep the agency at the historic location. The State of NJ legislature just approved another extension of 4 years. Typically, the State extends 4-5 years out upon renewal. Their continued occupancy is essential to Casino operations given the proximity to the gaming sites.

Retail Tenants: The 4 retail tenants on the ground level facing the Boardwalk have been a staple for many years. They are reliant on the tourism trade and are seen as staple in the area. All rents are relatively low and affordable thus with any rollout, re-tenanting hasn't been an issue whatsoever. All retail tenants are replaceable with little to no Boardwalk vacancy.

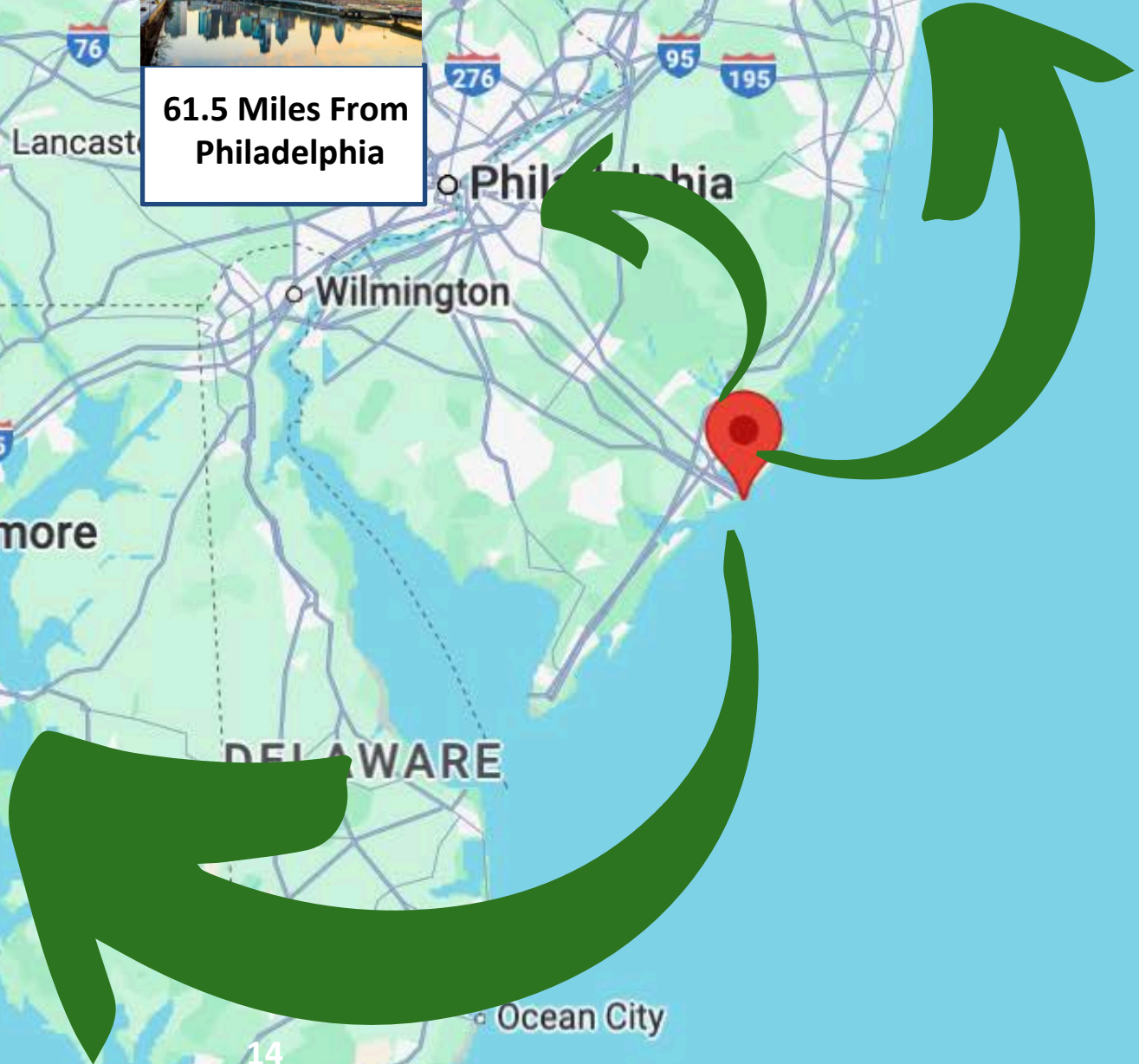

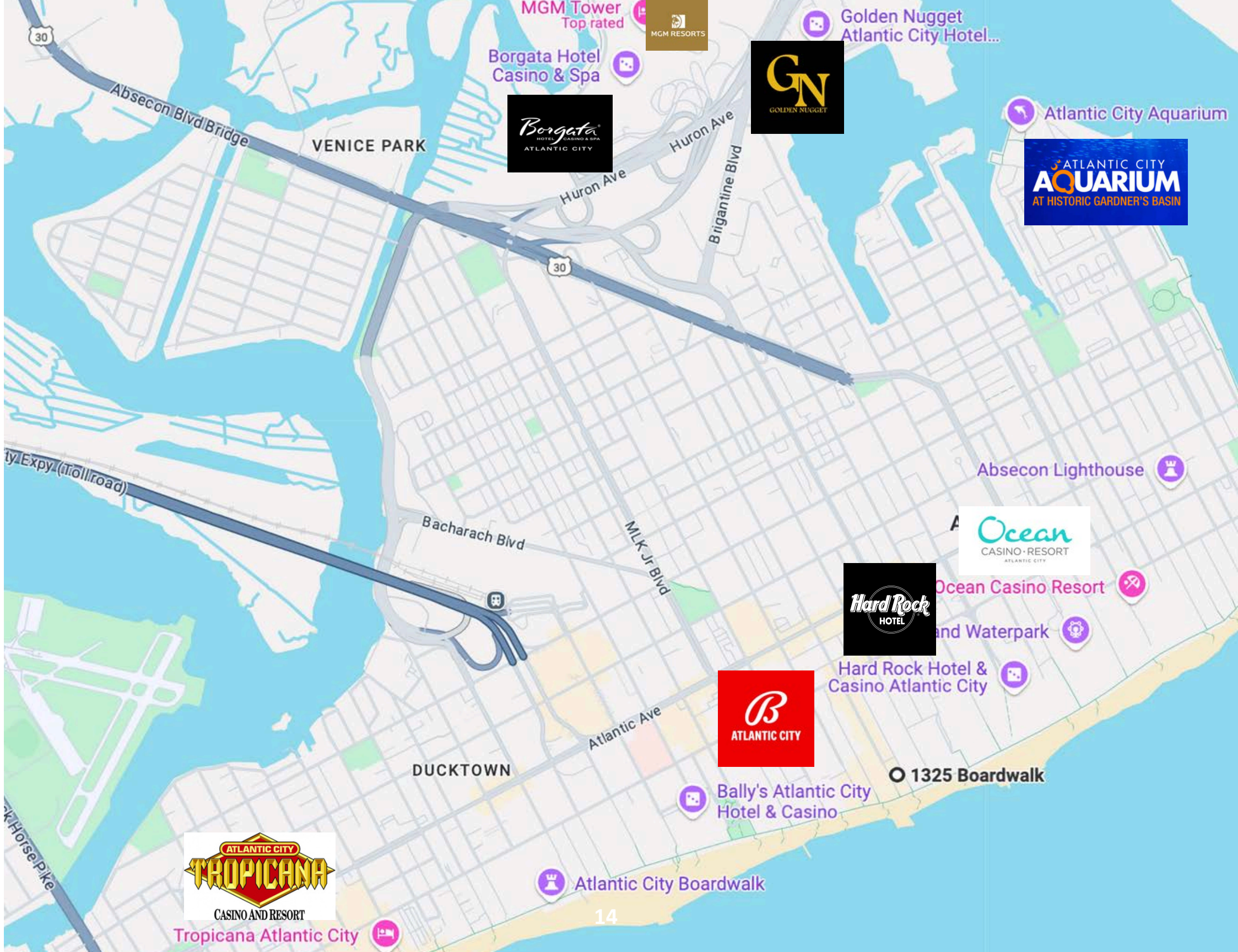
