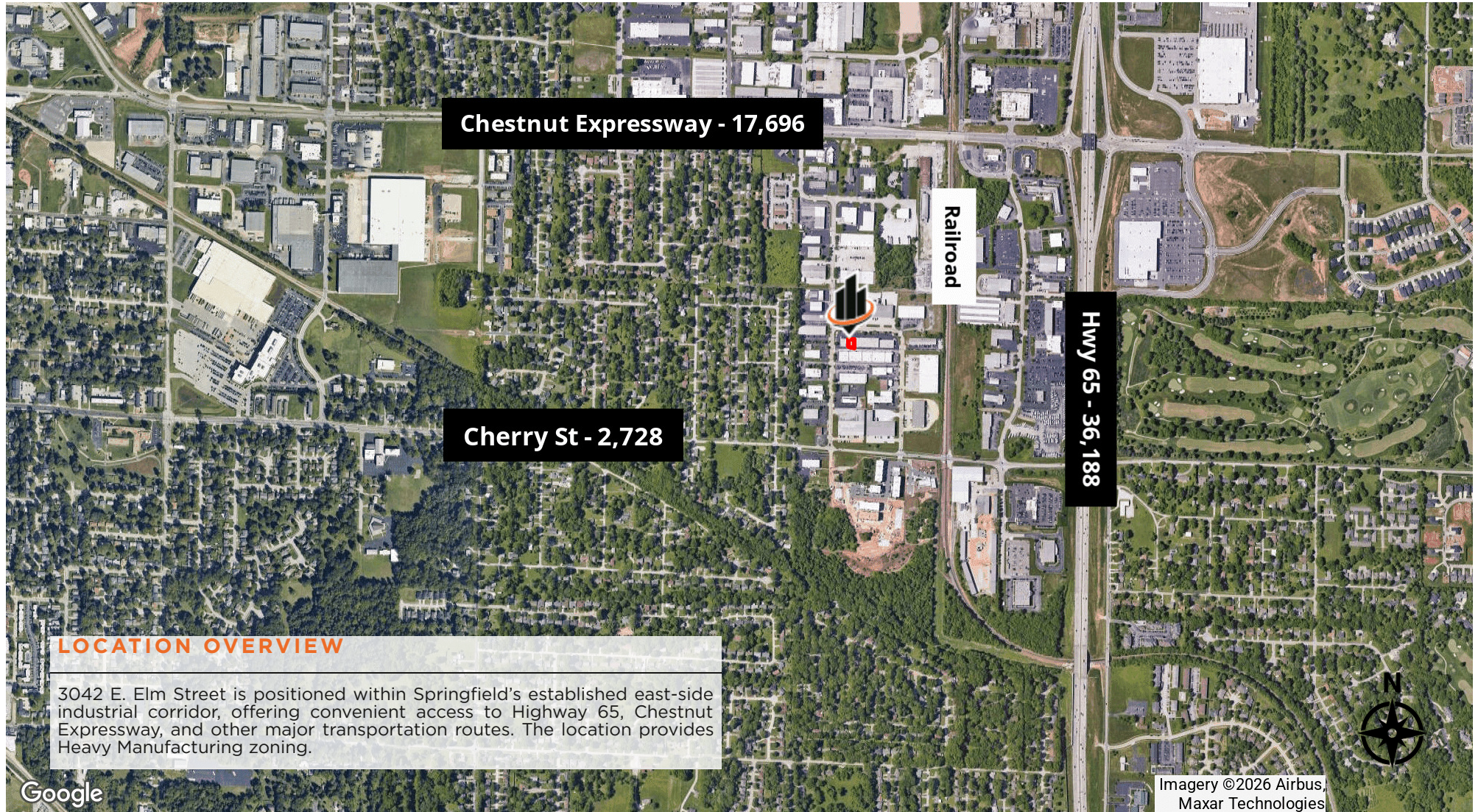

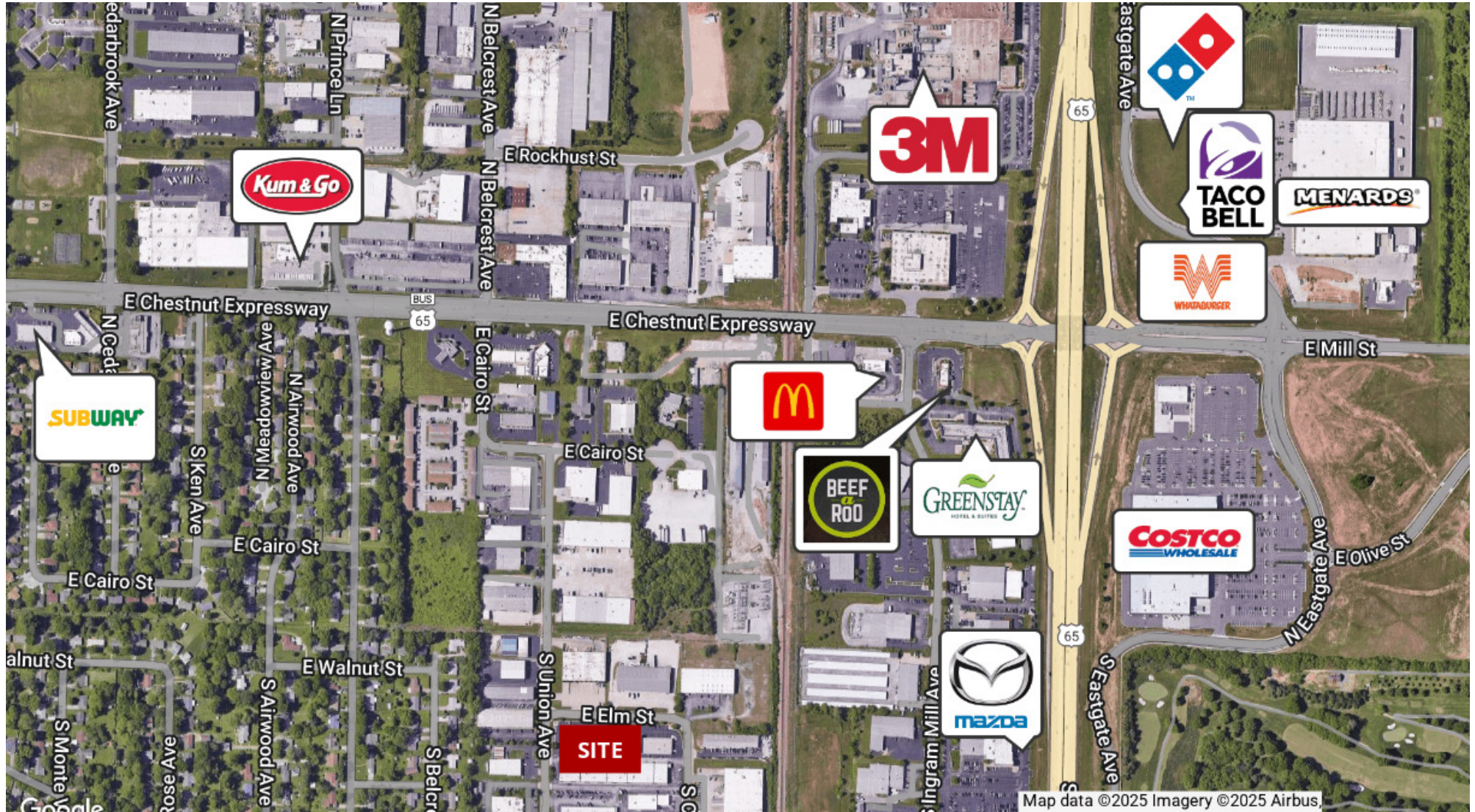
# LOCATION MAP & AAWDT TRAFFIC COUNTS
