LENTS COMMONS is a mixed-use building. There are 54 units of housing and approximately 7,389 square feet of ground-floor commercial space. Located in the heart of Lents Town Center, a priority focus area of the Lents TIF District. The building is zoned Commercial Mixed Use 3 (CM3). Three of the commercial spaces are available for lease. Suite A1 is an end cap (corner of Foster and

91st) and is in a warm shell condition, Suite B1 is an in-line space for a potential restaurant or cafe in gray shell condition, Suite B2 is an end cap (corner of 92nd and Foster) in warm shell condition. A great spot for active destination businesses to energize the street-level environment and complement the existing businesses in Lents Town Center.

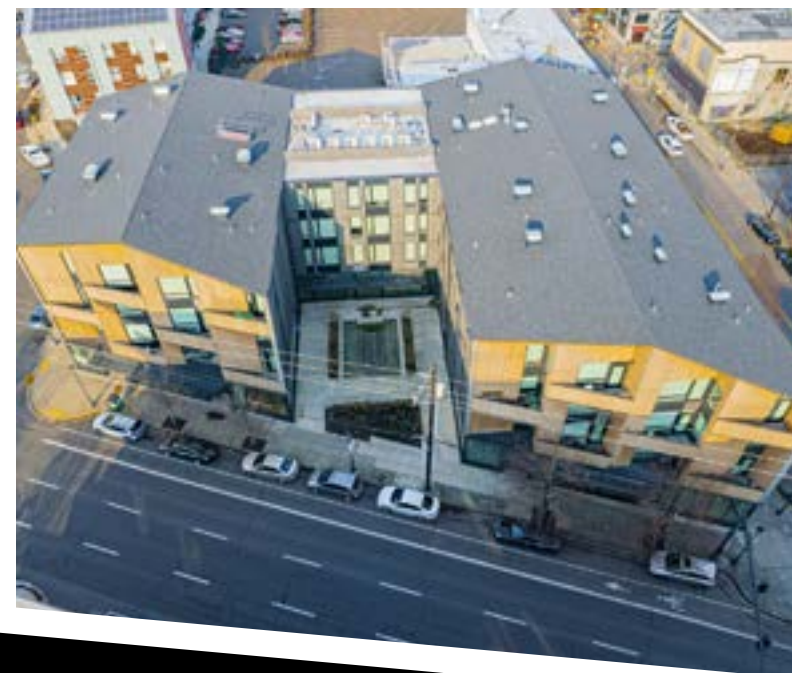

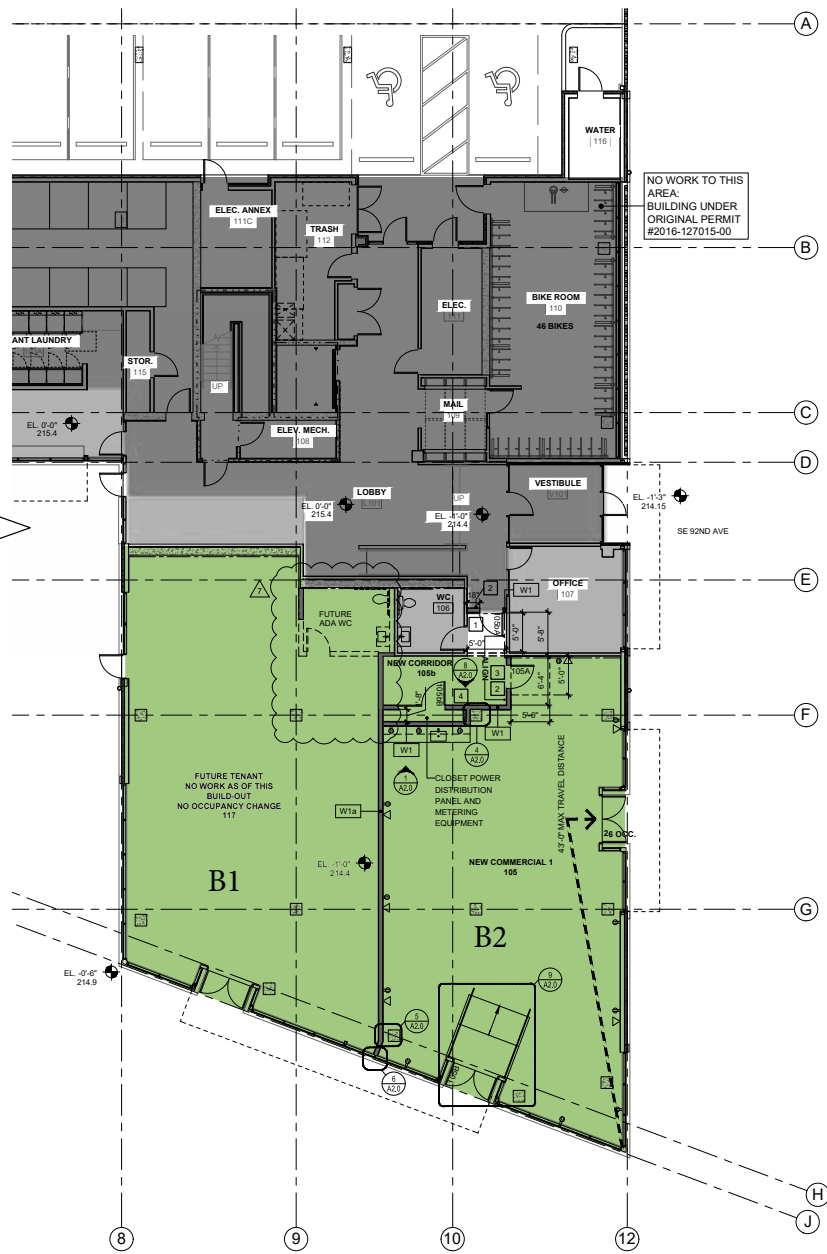

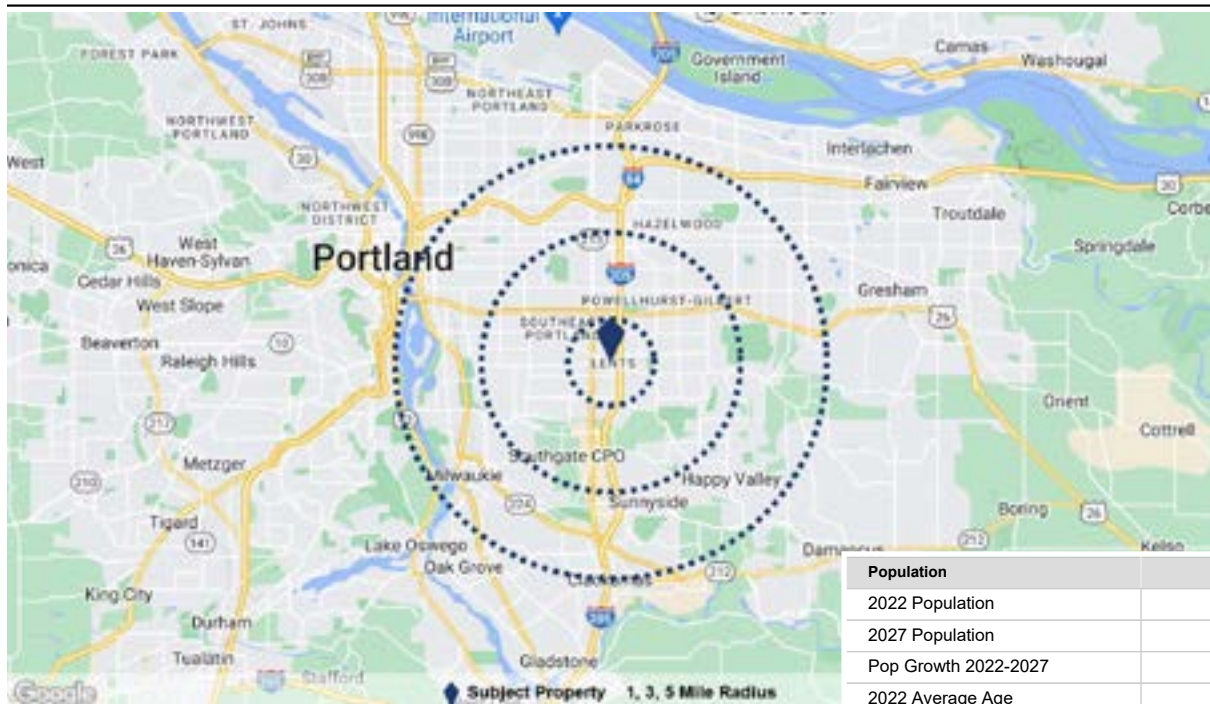
