### PROPERTY OVERVIEW

This Historical Medina Farmers Exchange building once was downtown Medina's local Feed and Farm store that has been repurposed into a mixed use building, blending modern layouts with raw historic charm.

The newly renovated (2019) 16 apartments are located on the 2nd and 3rd floors with open concept 1 bed/1 bath and 2 bed/2 bath layout options. On the West end of the 1st floor, is a restaurant which is locally owned and operated called "The Farmers Table". On the East end of the floor is "The Exchange Market" and this community driven idea is anchored by "Keller Meats", a local family butcher shop who has been raising their own livestock for 3 generations.

In the market you will find more local vendors selling everything from coffee to pierogis. On the West half of the Garden level, a craft brewery "Medina Brewing Co." they will be anchoring this level and help create the positive atmosphere in the entire building. Located on the East side of the Garden Level are several different layout configurations which will be perfect for small retail and office spaces.

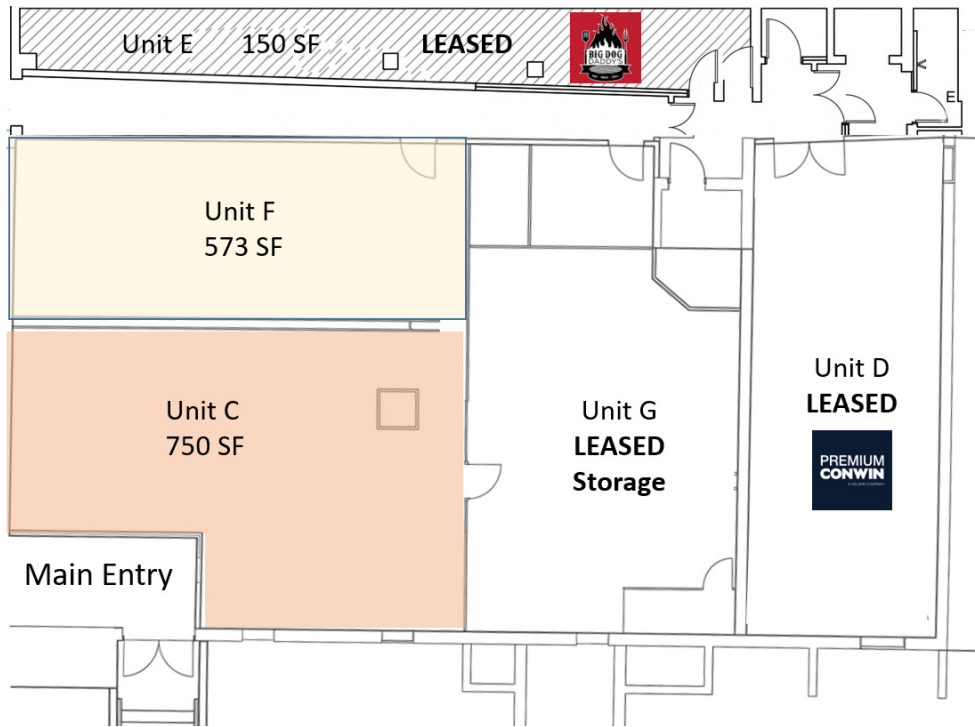

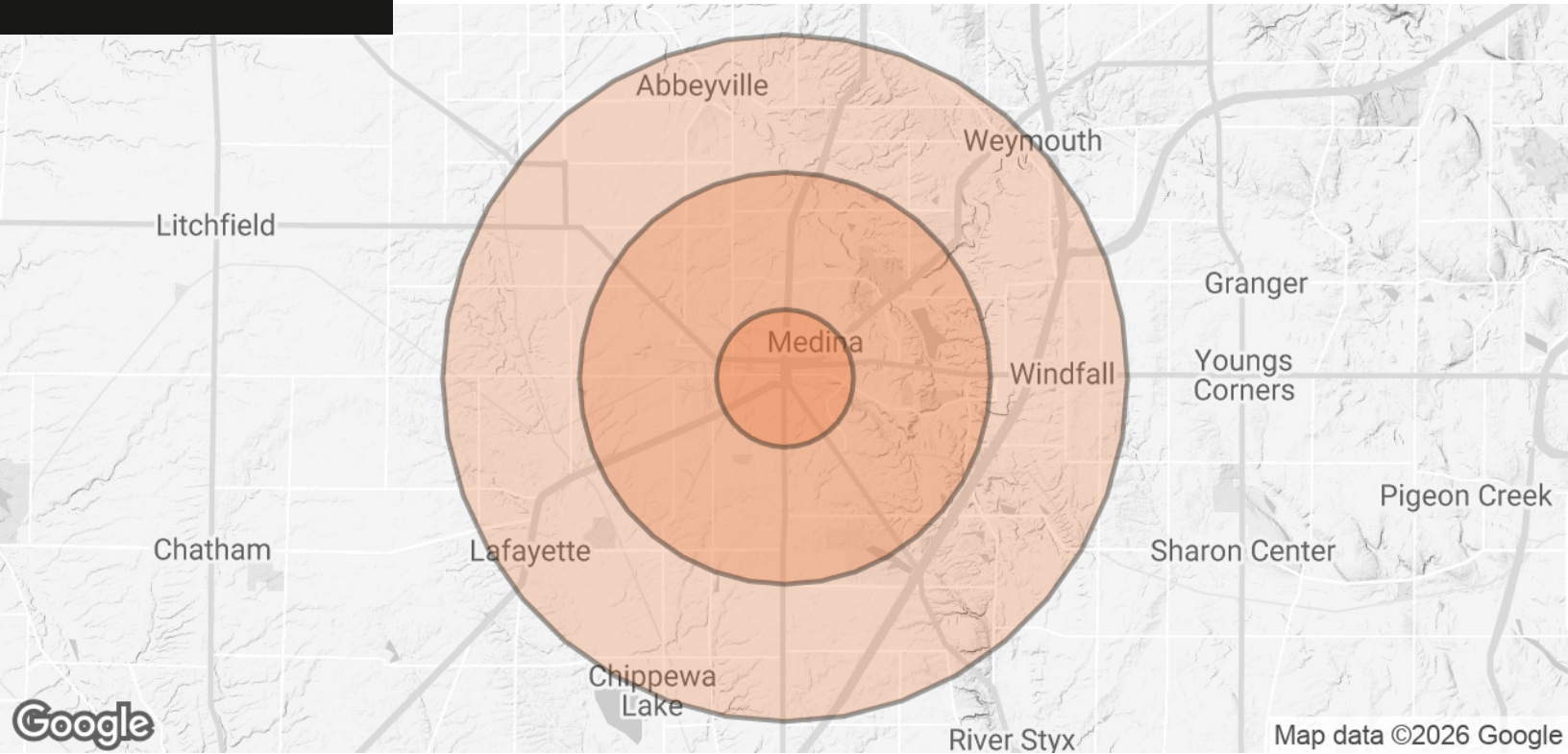
