A conceptual plan for up to 28 townhouses demonstrates the site's residential viability, while Commercial zoning provides significant flexibility for alternative uses, including mixed-use, hospitality, office, or future redevelopment strategies. This offering is ideally suited for land investors, residential developers, or mixed-use operators seeking waterfront value with optionality.

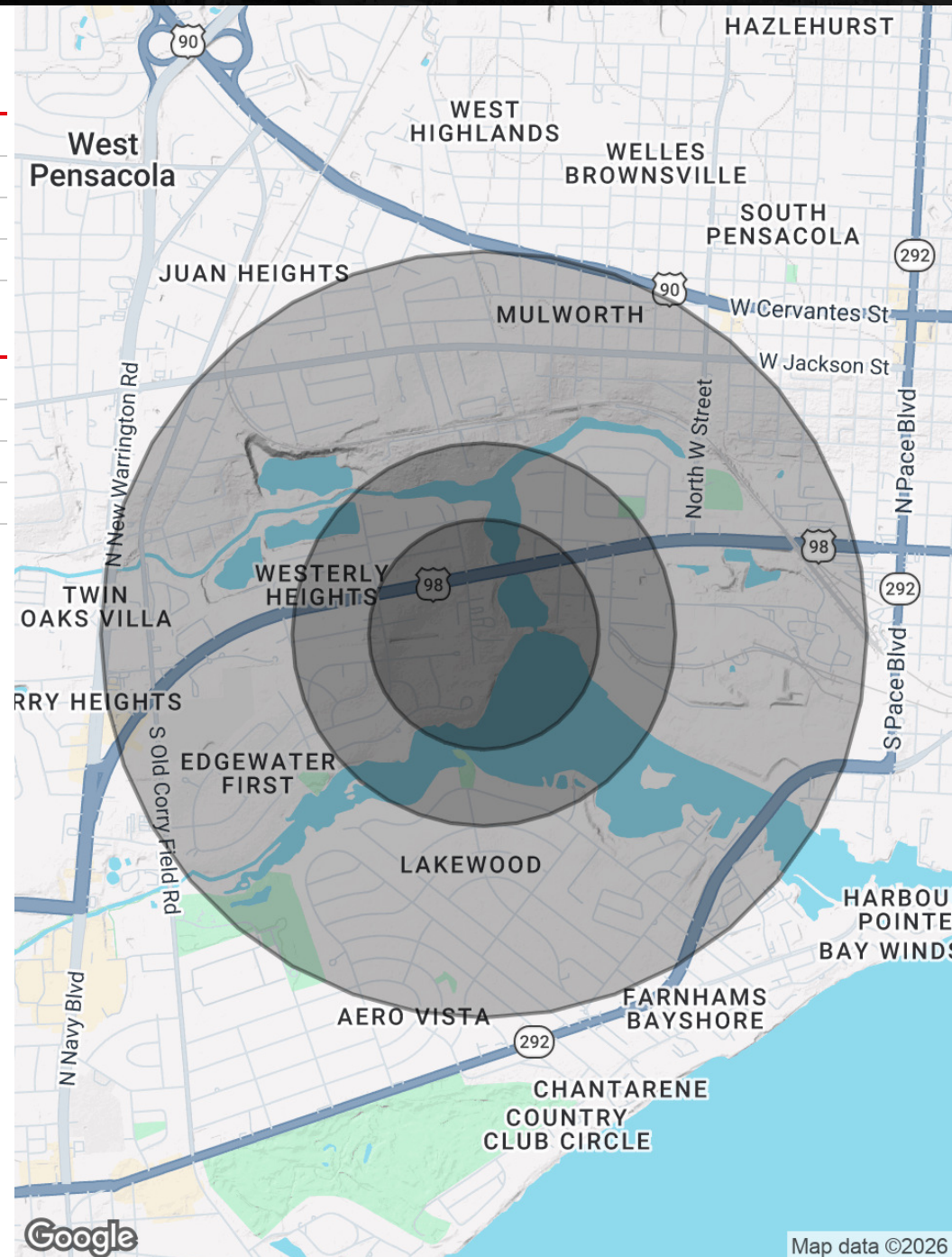
