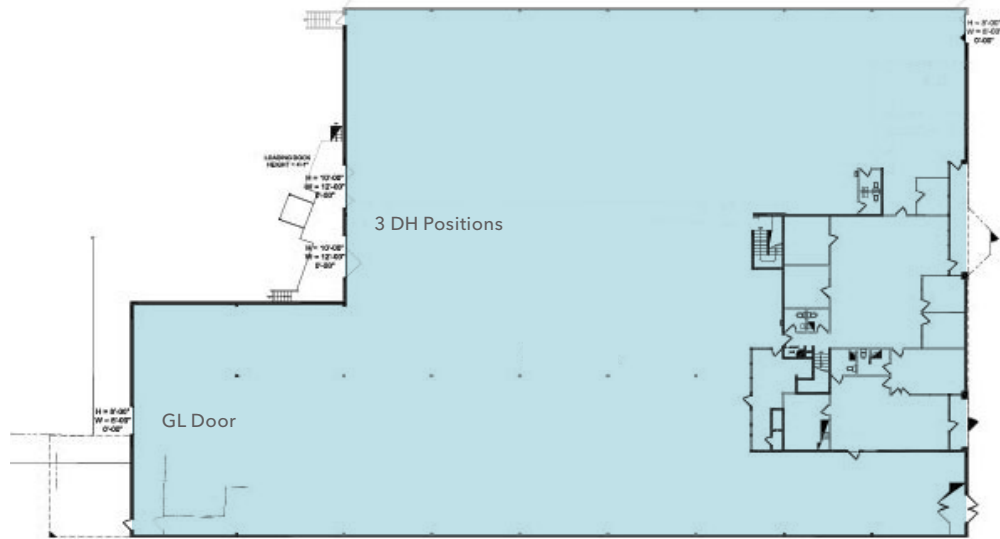

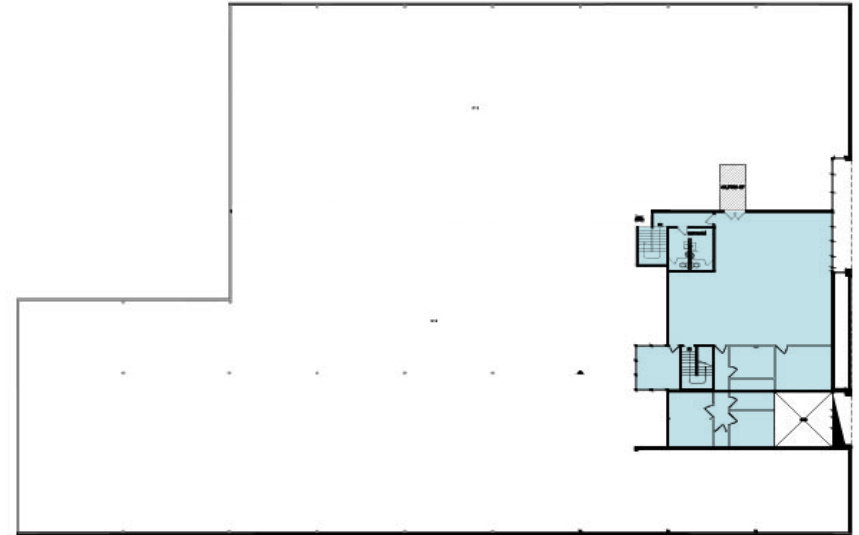


FLOOR PLAN

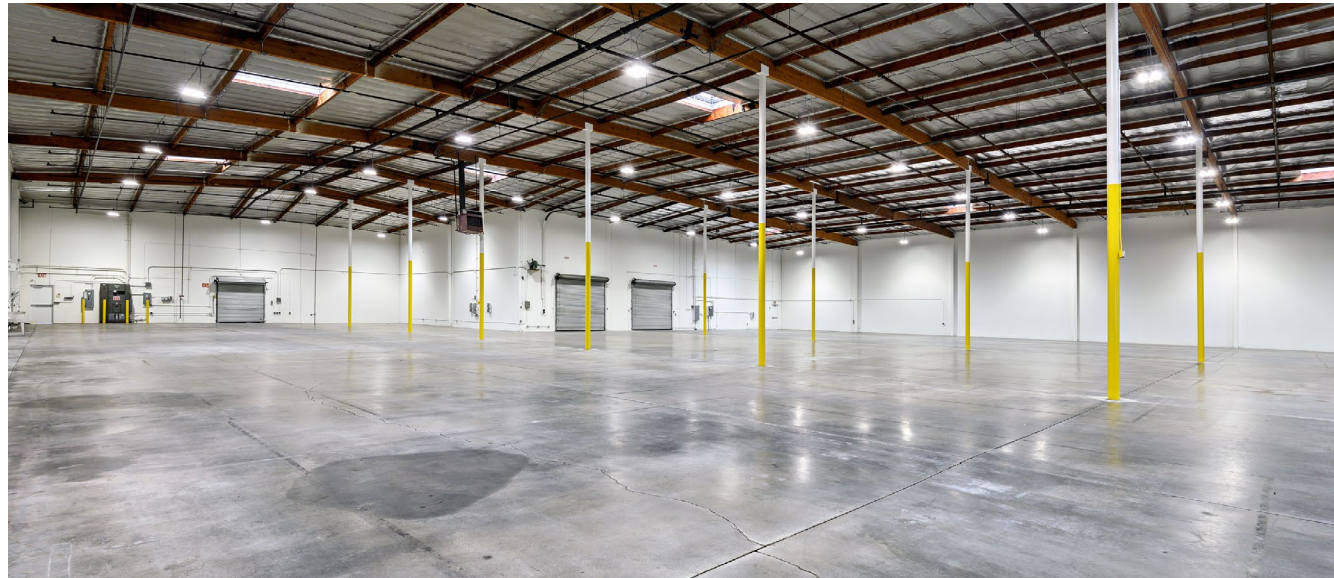

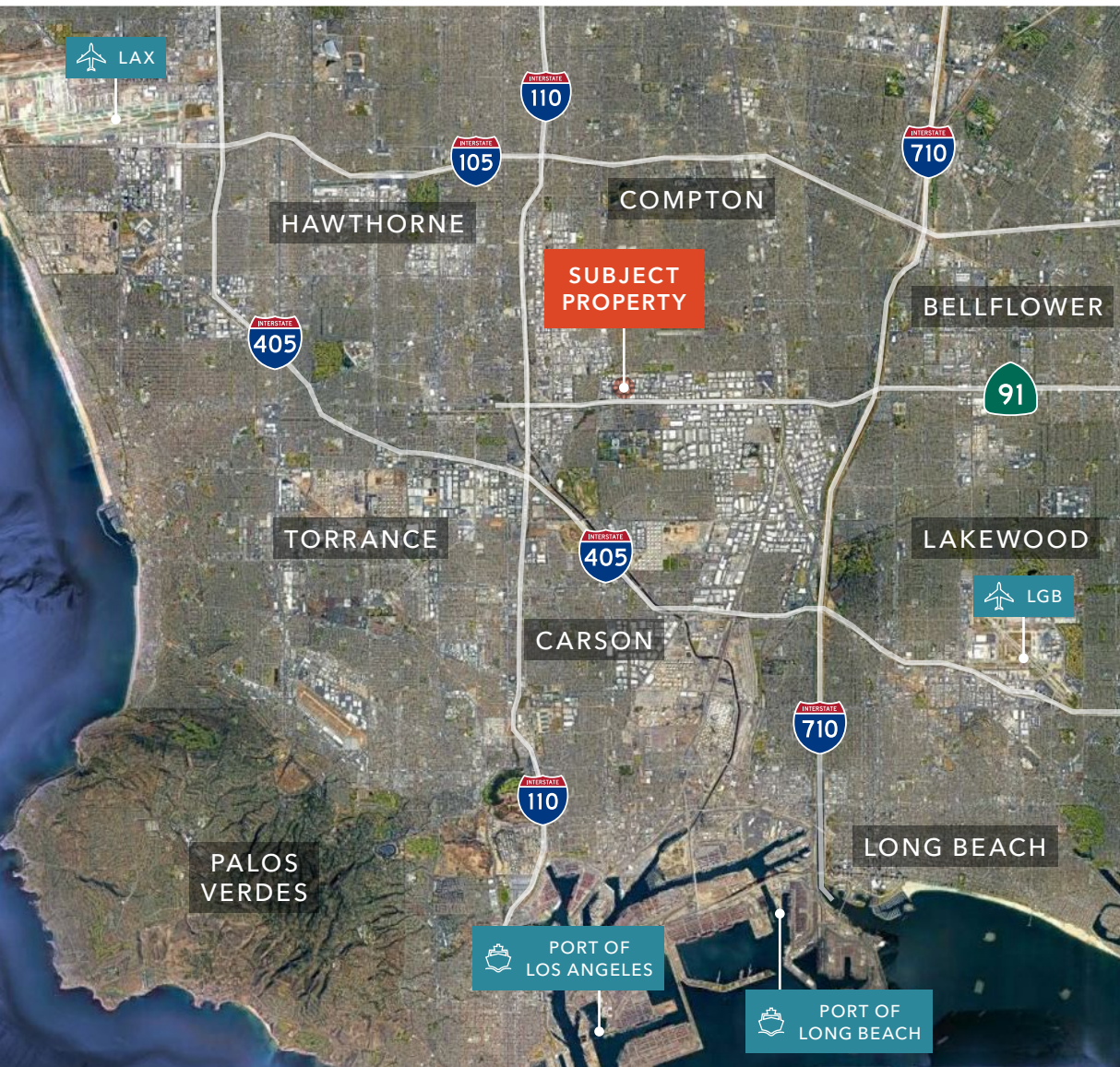
