The property is located on the popular business park of Manaton Close. There are six allocated parking spaces to the front and side of the unit.

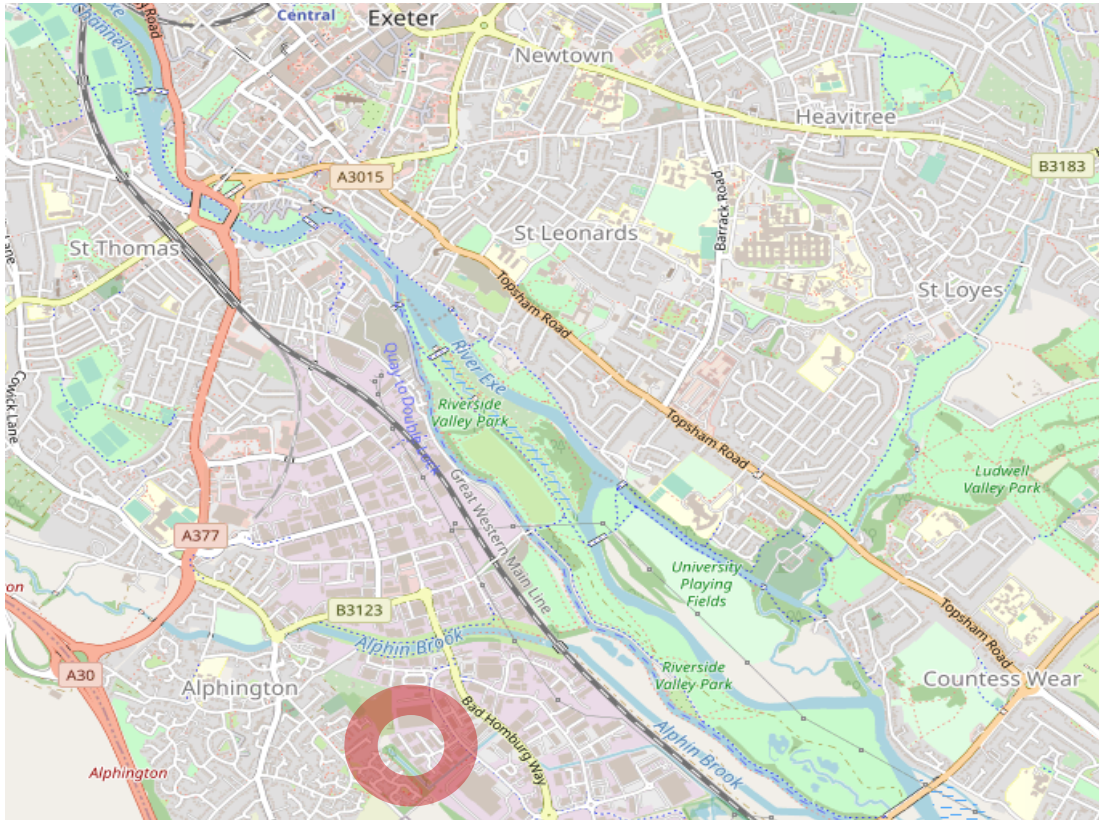
