Technology, software, Scientific Research + development, Financial Services companies signing leases and creating jobs can apply for the New York State Excelsior Jobs program. Tenants must apply for this program before the lease is signed.

Any company that has been in business for at least 24 months signing a lease for a minimum of 10,000sf and relocating employee to the office in Midtown can qualify for the RACE program. This should be the company's first location in NYS. Hotels, retail, not-for profit companies cannot qualify.

Companies signing direct leases can qualify for real estate tax abatement (CRP), commercial Rent Tax Special Reduction (CRT), Sales Tax Exemption, REAP , Excelsior + RACE. The companies must meet the eligibility requirements.

Not-for-profit companies in LM can qualify for only the CRP program.
