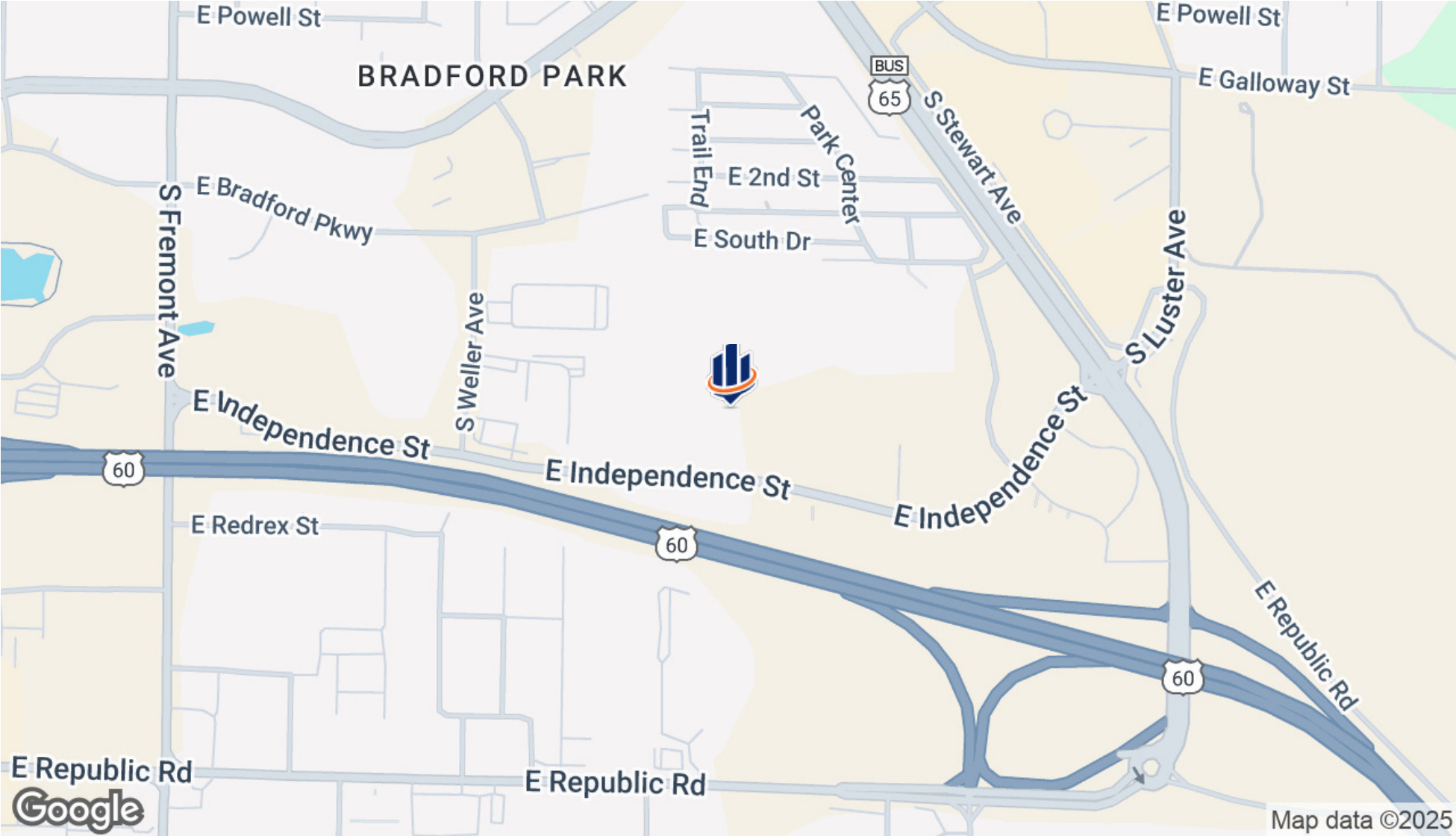

Location Map

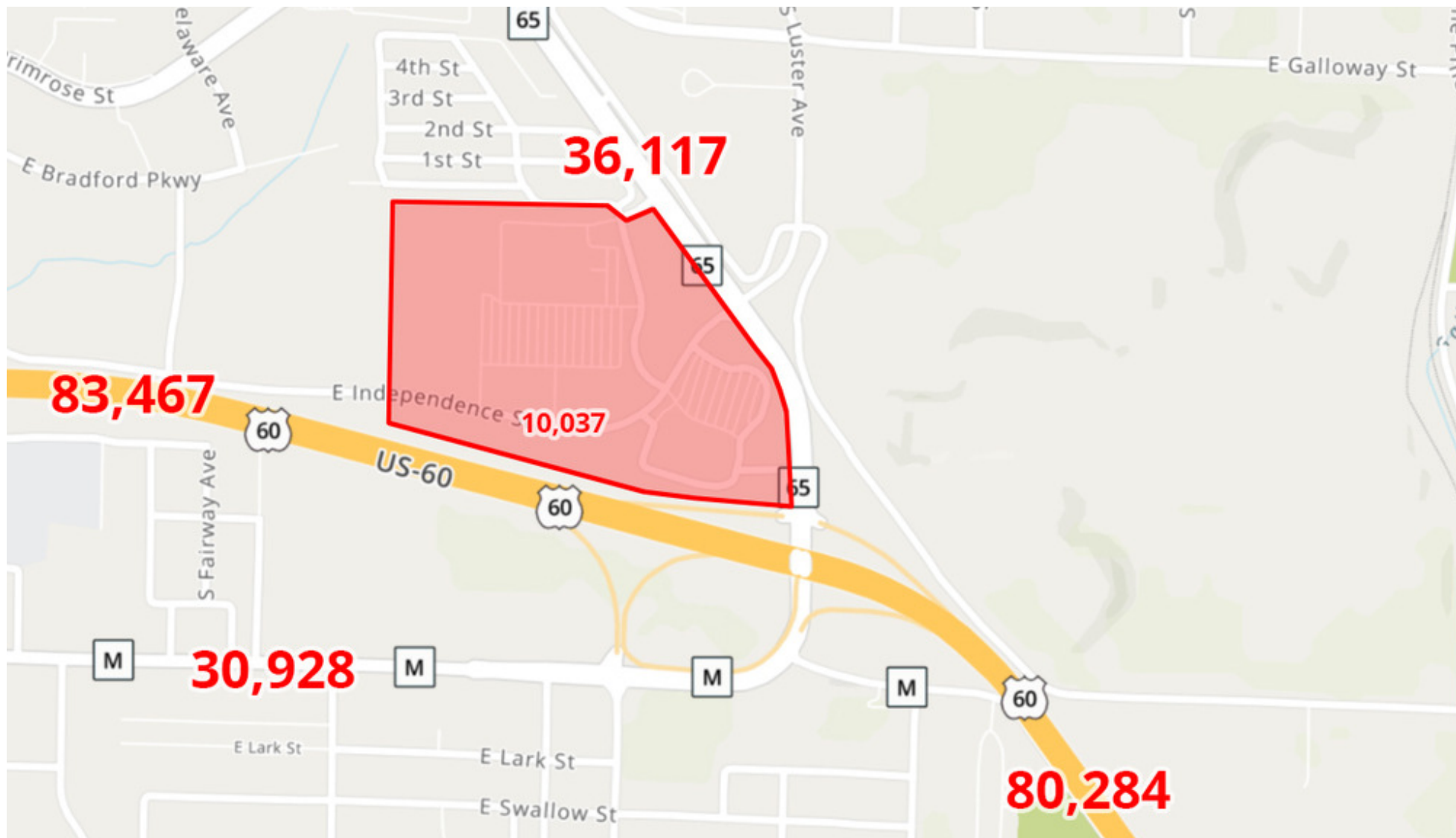

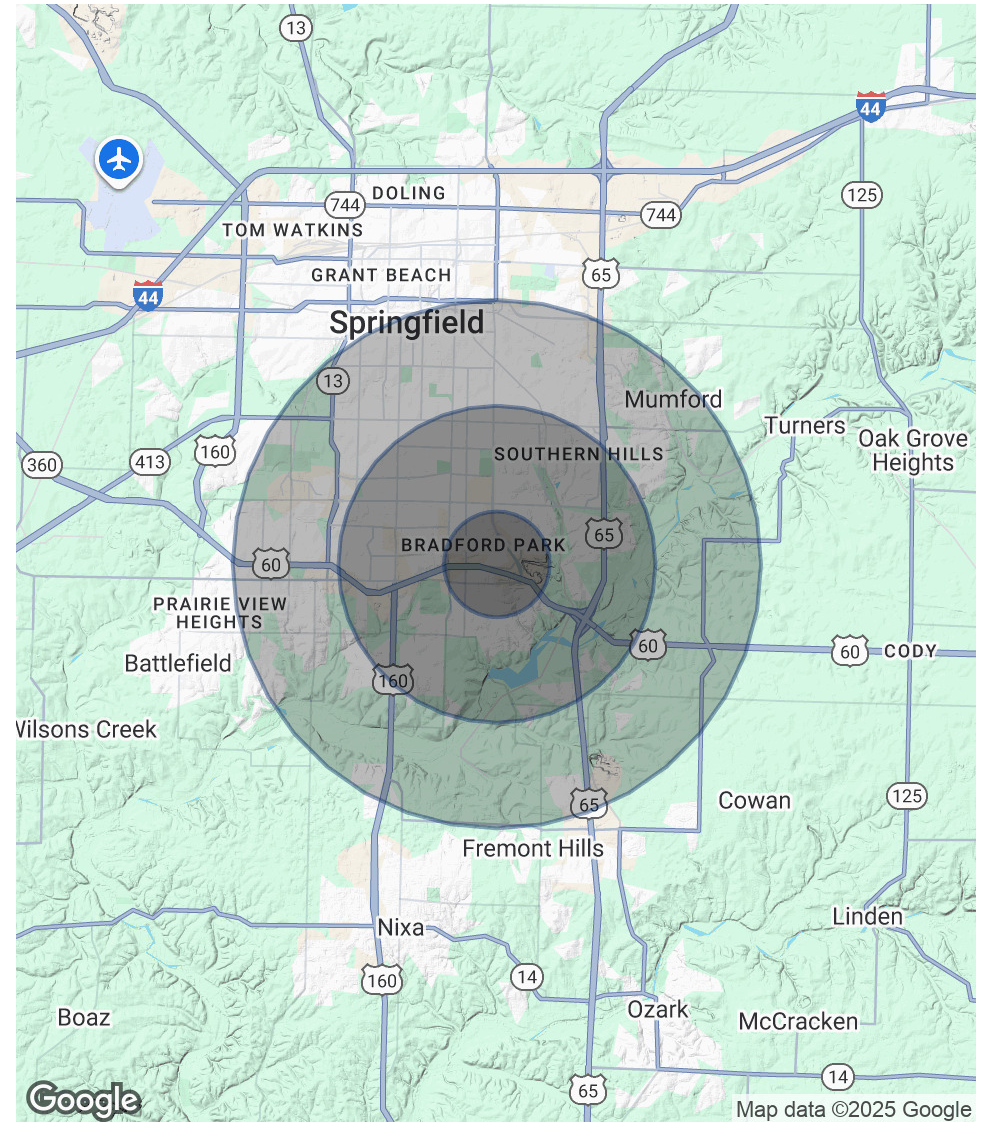
