## LOCATION

Located on the outskirts of Bangor, in close proximity to J11 of the A55, the Parc provides development opportunities from 0.91 hectares (2.25 acres) upwards.

The Parc's position provides a strategic location to access the whole North Wales corridor between Deeside and Chester, together with the Port of Holyhead in Anglesey.

Merseyside and Manchester regions are a 90 minute drive via the A55 North Wales expressway, with freight and passenger ferry links from Holyhead within 30 minutes.

## DESCRIPTION

Parc Bryn Cegin is a business park opportunity for B1 Office and B2/B8 Industrial uses.

The Parc has been landscaped to provide a series of plateaus accessed from a central service road, ready to satisfy development for a range of new employment uses.

## TIER 1 AREA STATUS

The sites are within a Tier 1 funding area. Under EC rules Welsh Government can offer additional financial support to qualifying projects.
