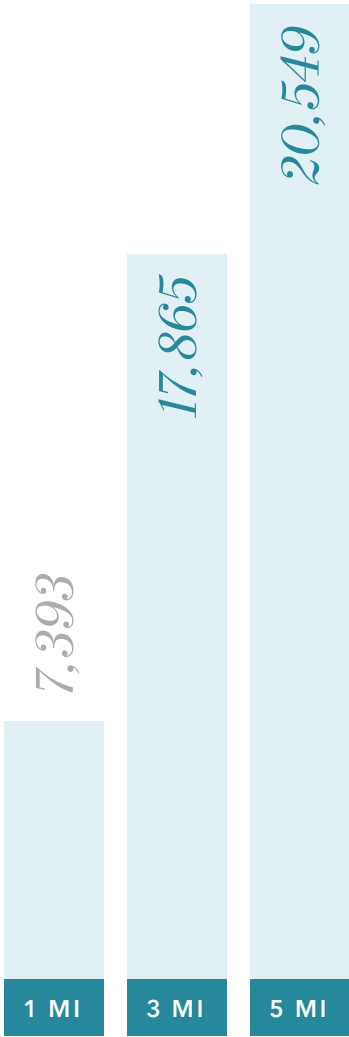

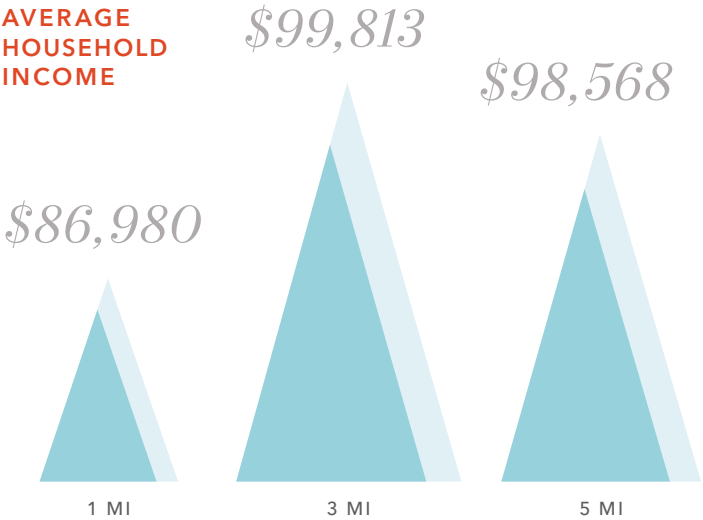

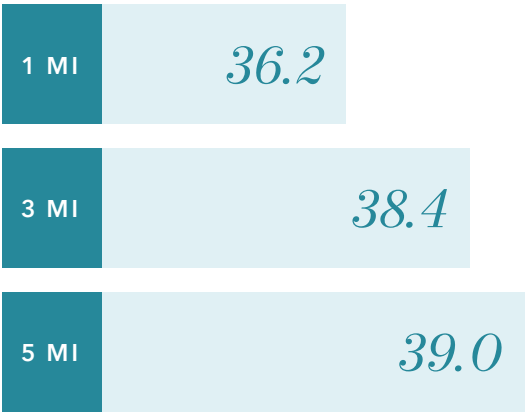
POPULATION
(EST. 2024)



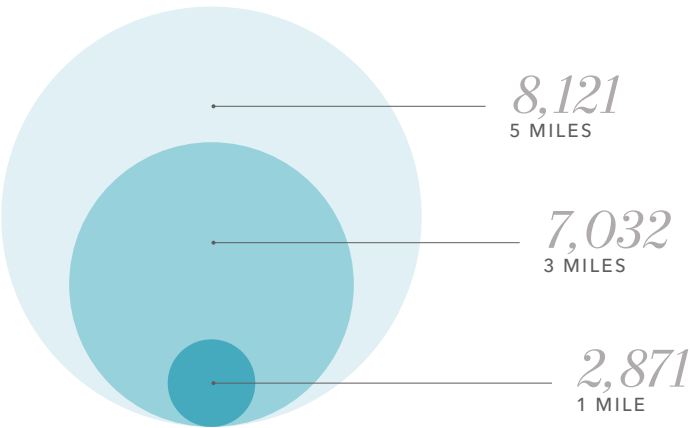
AVERAGE

INCOME



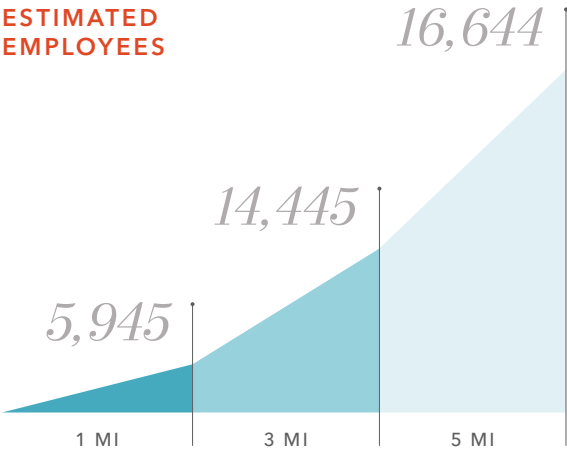
MEDIAN AGE
