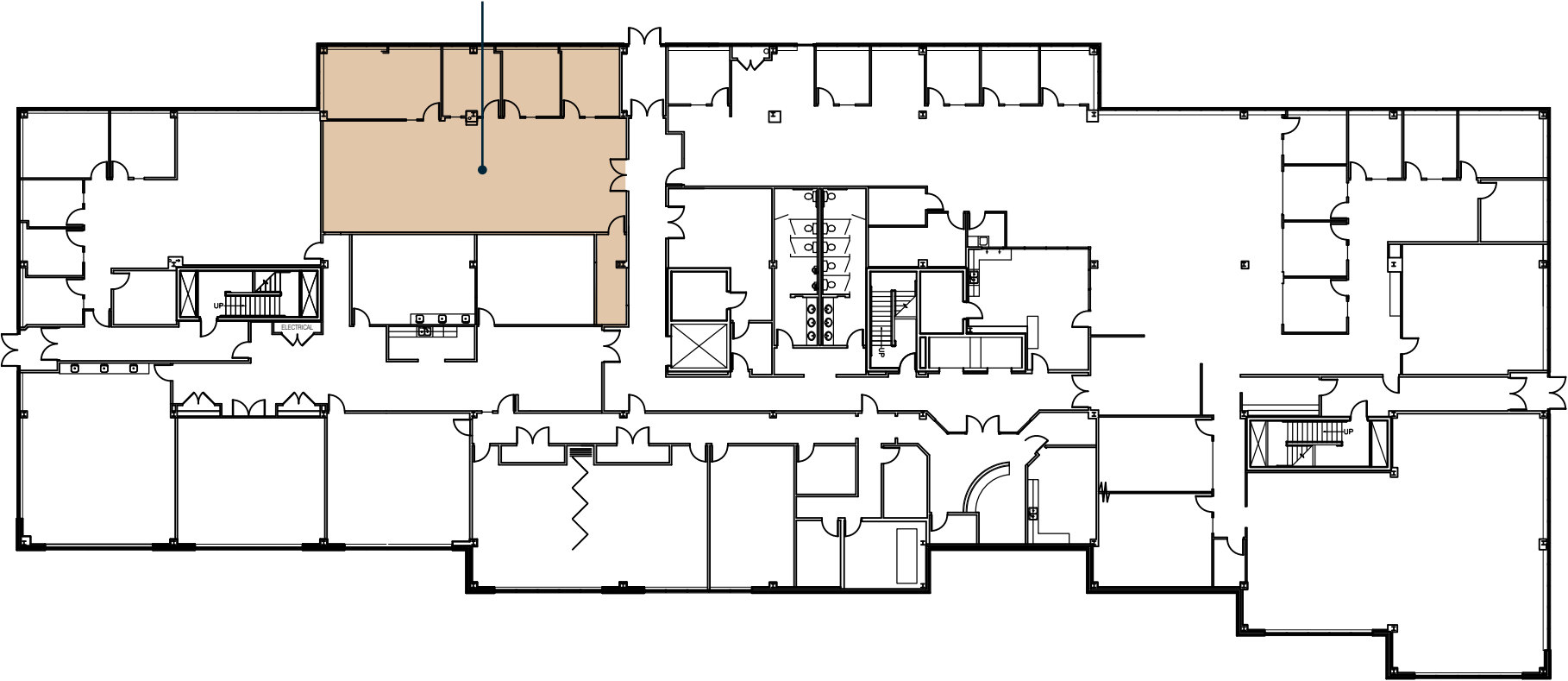

Floor Plan - Suite 120

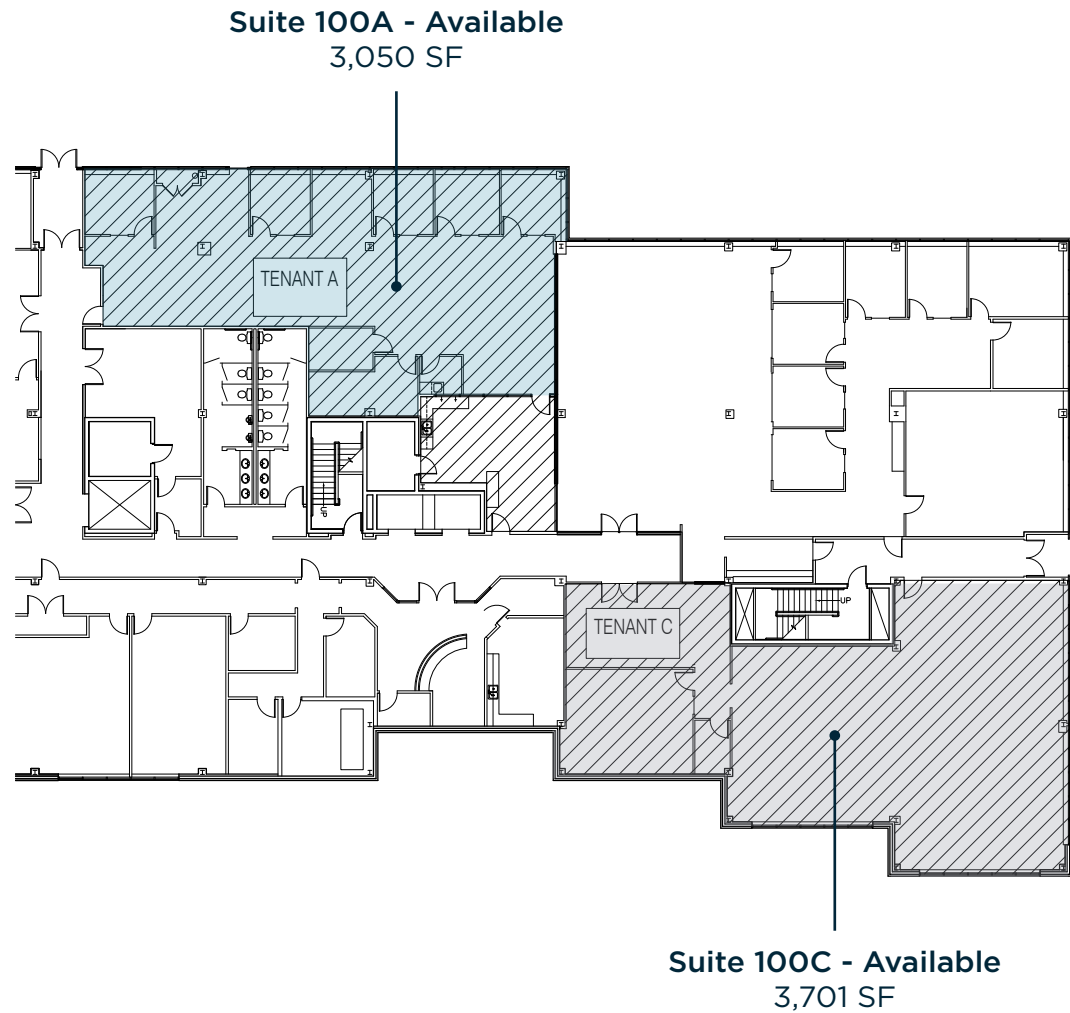

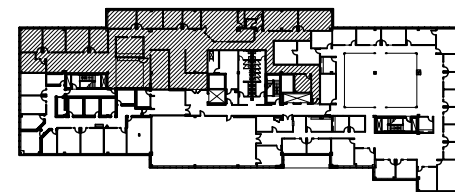
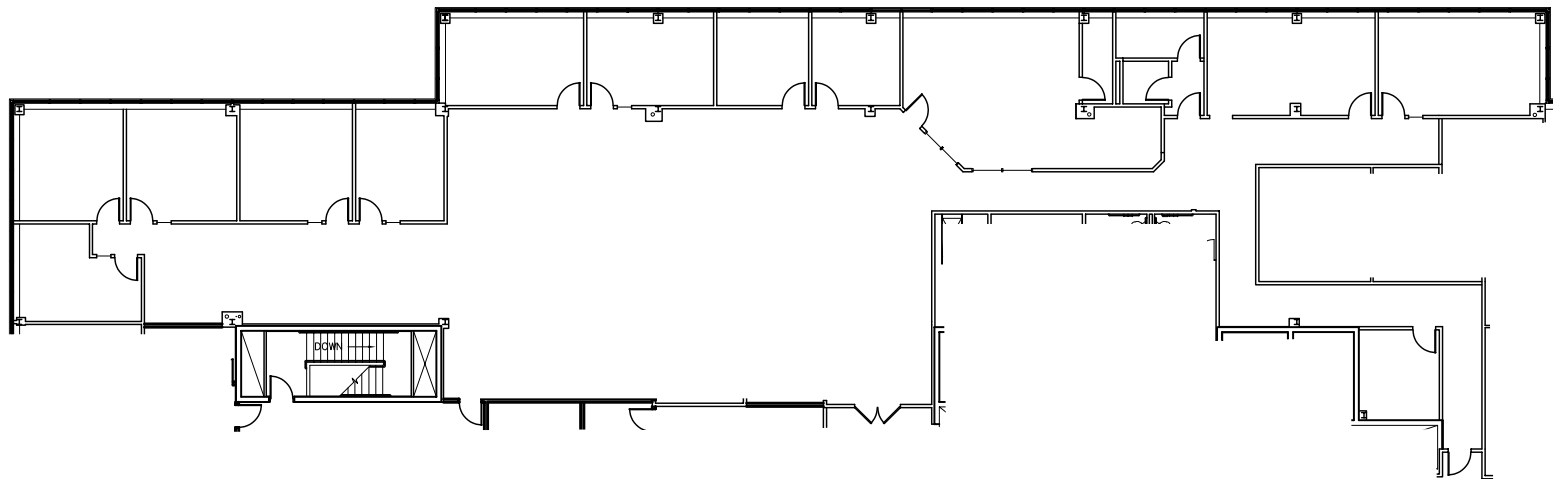


Floor Plan - Suite 400

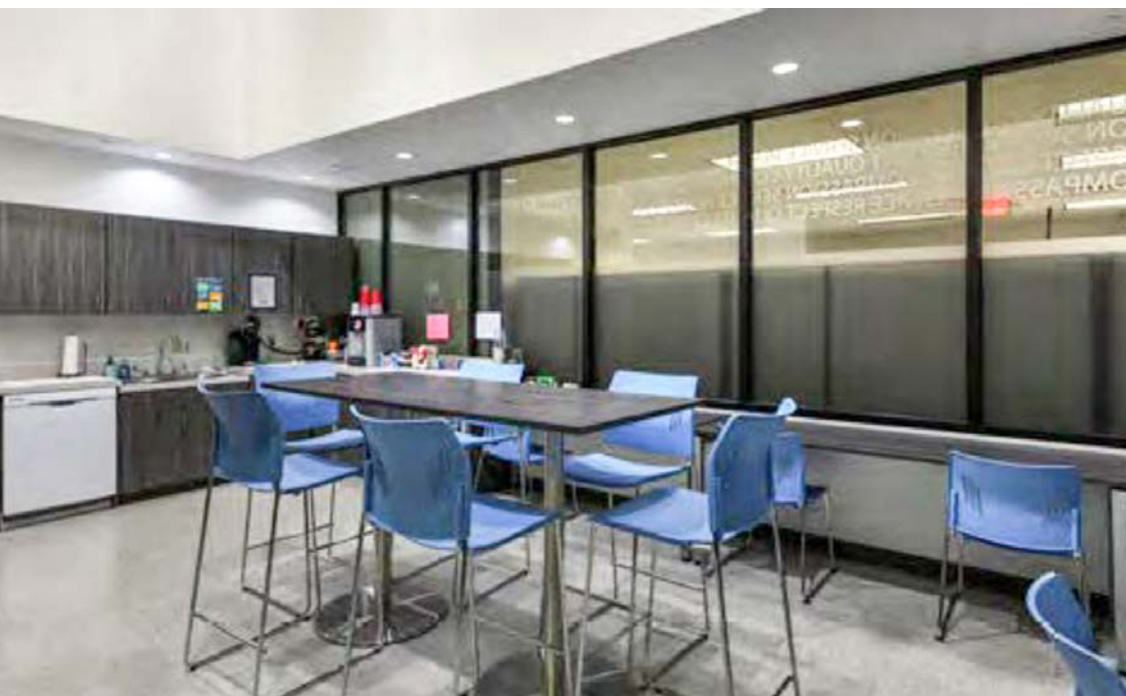
