## DESCRIPTION

The Pelham Centre comprises a prominent mixed-use building incorporating seven units and two-story offices over, surrounded by a large car park. Unit 6 has a full height steel framed shop front with steel profile fire exit door to the rear. The unit is suitable for commercial, business and service uses (Class E) including shops, offices, cafes, restaurants, GPs, light industrial, creches and gyms.

Lincoln Central Train and Bus Stations are situated 250 metres to the north west and the High Street 400 metres to the west.

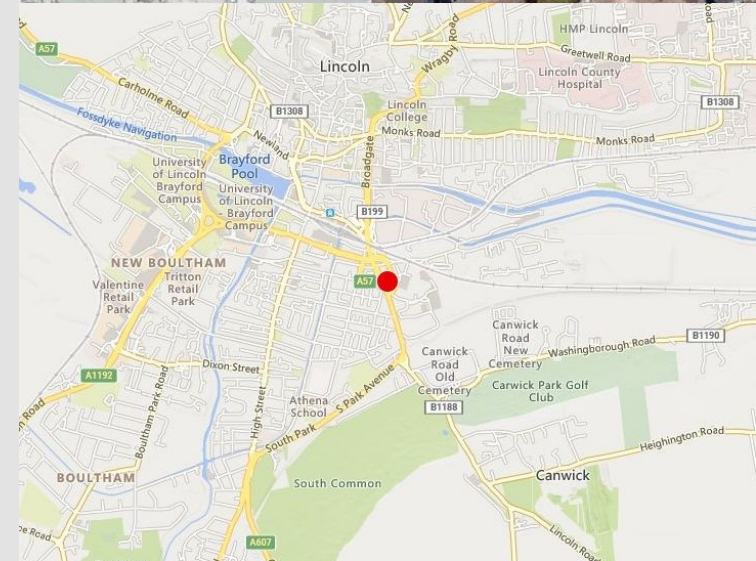
