PROPERTY DESCRIPTION

75 Gonzales River Rd

The subject property is located on Gonzales River Road near its intersection with Puente del Monte Avenue, within the Blomquist Industrial Park. It features a single driveway access from Gonzales River Road and offers approximately 94 linear feet of street frontage.

Improvements consist of a single industrial building reportedly constructed in 2002 by the current owner for use as an auto repair and towing facility.

The building is of metal industrial construction, with a concrete slab foundation, steel framing, enameled steel exterior, and steel standing-seam roof panels incorporating skylights. The interior layout includes a street-facing office of approximately 500 square feet, with three shop bays behind the office opening onto the driveway/yard. Two bays each have two 12' x 15' roll-up doors, and the third bay has one 12' x 15' roll-up door. Interior demising walls are wood-framed with sheetrock: the wall between the office/restroom/storage area and the first bay is standard ceiling height, the wall between bays 1 and 2 is full height to the roof, and the wall between bays 2 and 3 is a pony wall approximately 12 feet high. There are two restrooms serving the office and one restroom in the second bay, all appearing to be ADA-compliant, and the building is equipped with fire sprinklers.

Total building area is approximately 6,211 square feet, with about 500 square feet improved as office. Most of the parcel is asphalt-paved, with only a narrow side yard along the building and the rear yard left unpaved. The site is fully fenced, with a double gate at the driveway entrance. Overall, the improvements are suitable for continued service-commercial or light industrial use.

79 Gonzales River Rd

An undivided 1/8 interest, which includes a stormwater retention pond to receive runoff from Parcels 2 through 8 and Parcel B. A pipeline along the southeasterly boundary of Parcels 2 through 8 conveys stormwater into this pond. The pond, pipeline, and all related stormwater facilities are collectively referred to as the “stormwater retention system.”

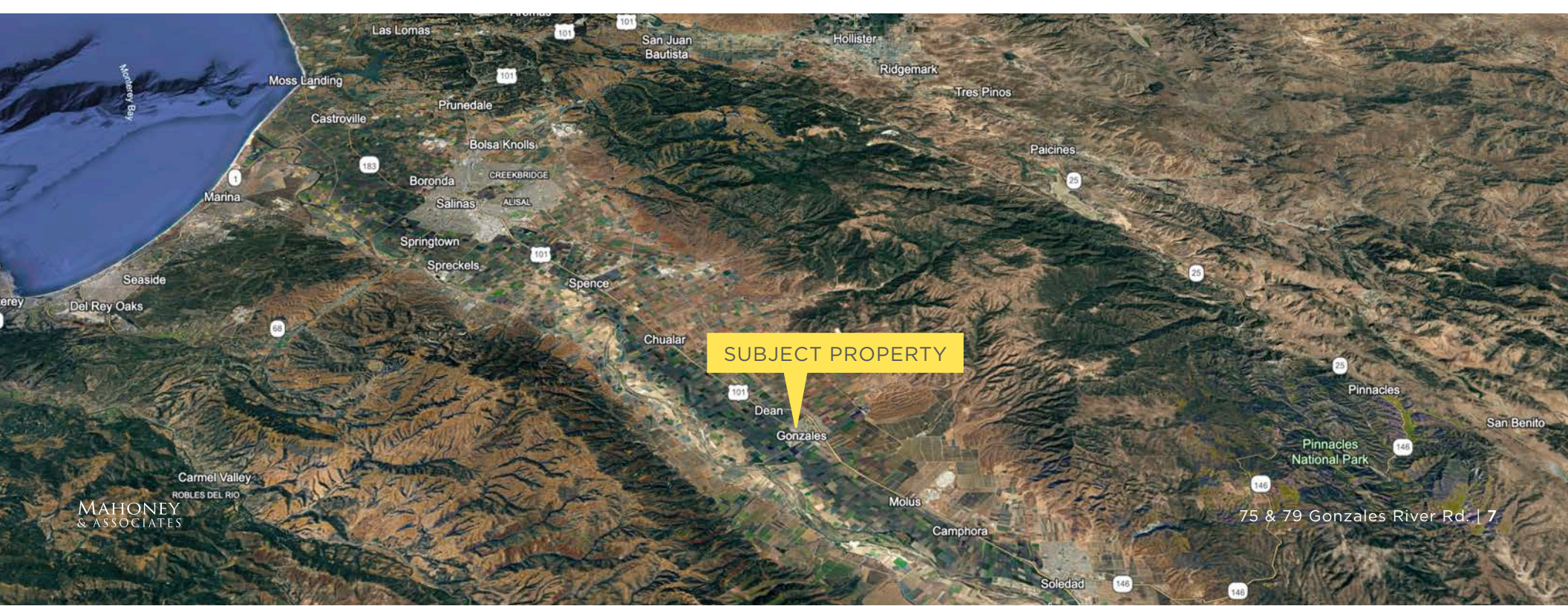

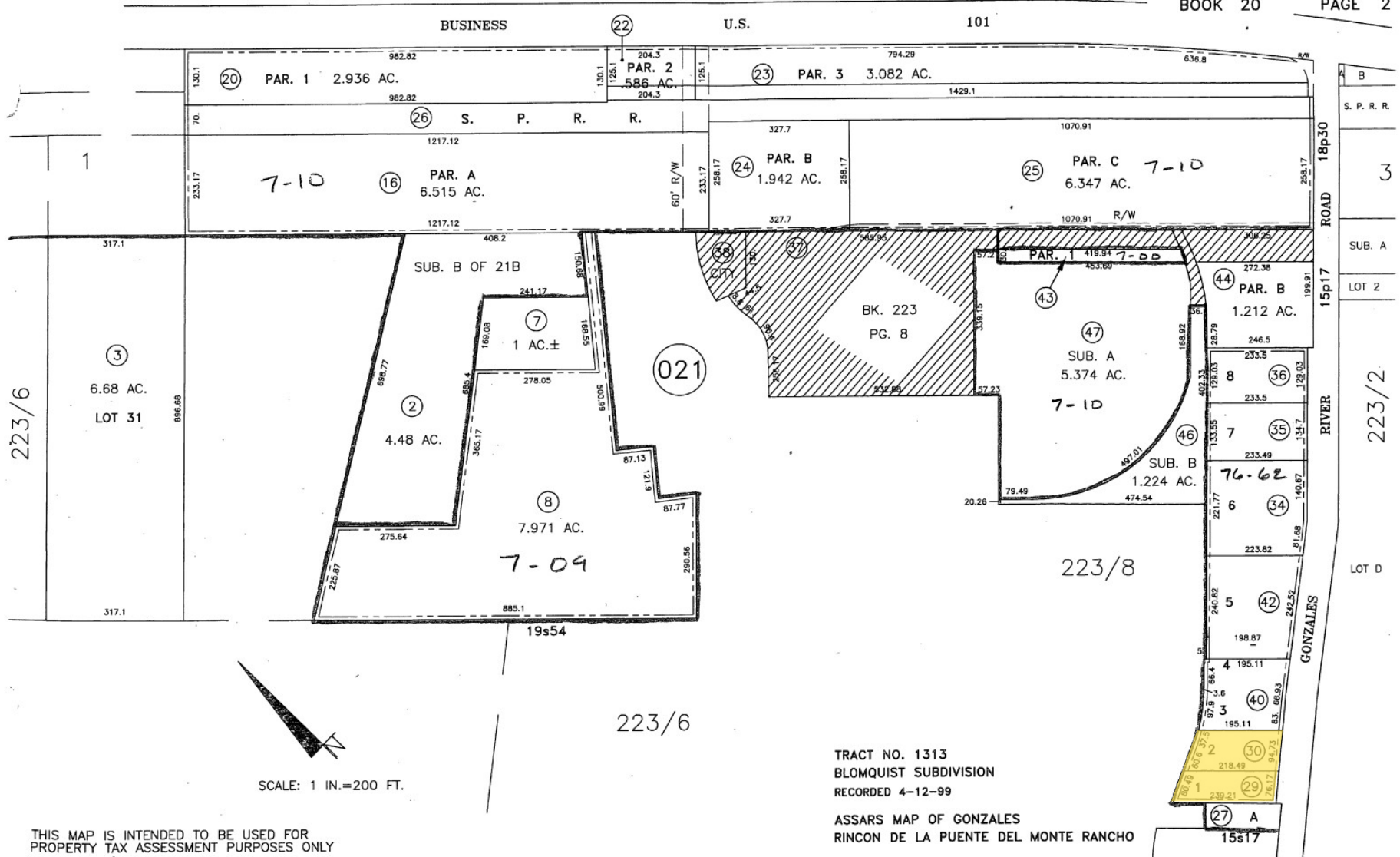

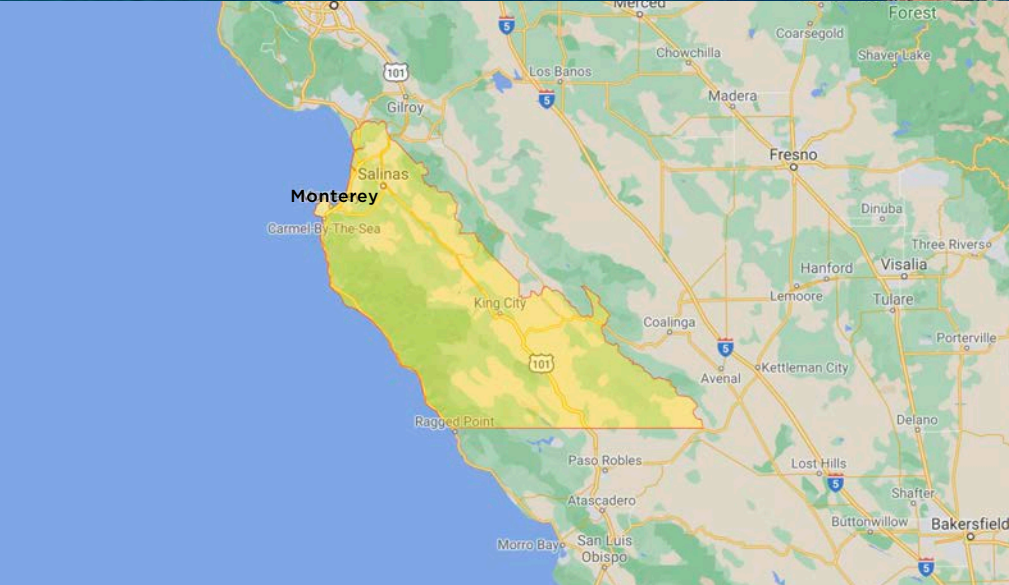
PARCEL MAP
