LOCATION

Heathfield Gatewayway is located approximately 1.5 miles to the north west of Milton Keynes town centre. The Estate is situated beside the A422 Monks Way (H3) approximately 300 yards to the north of Abbey Hill roundabout which provides access to the A5 dual carriageway.

Milton Keynes benefits from excellent road links with Junction 14 of the M1 Motorway approximately 5 miles to the east. An alternative route to the M1 Motorway is via the A5 and A508 to junction 15 at Northampton, approximately 10 miles to the north west.

The Estate is accessed via Erica Road and Heathfield which connect to A422 Monks Way and Great Monks Way (V5) respectively.
