Location

The property is situated within the residential district of Abington, approximately 1.5 miles northeast of Northampton town centre. The locality is predominantly characterised by Victorian terraced housing and benefits from swift access to Wellingborough Road, which is one of the principal arterial routes into the town centre and offers an extensive range of local amenities. Abington Park lies in close proximity, providing substantial public open space and recreational facilities. Strategic road links are readily available via the A45, providing convenient connections to the M1 at Junctions 15 and 15A and to the wider regional network. For rail travel, Northampton railway station provides regular services to London Euston and Birmingham.

Accommodation

The property is a substantial three-story, excluding basement, Victorian building of solid brick construction, originally built in 1894. It retains its period character while providing practical accommodation suitable for a range of commercial use.

To the rear of the main building is a single-storey hall, which may be suitable for a range of uses (subject to planning) and includes its own welfare facilities. Beyond this is a large walled garden with secondary frontage to Adnitt Road.

Pedestrian access to the principal accommodation is provided by a door fronting Whitworth Road, together with a gated entrance that leads to a hard-surfaced courtyard accommodating parking for approximately three vehicles.
