The subjects comprise a detached workshop of concrete portal frame construction with profiled sheet walls and roof. Externally the property benefits from a large car parking area.

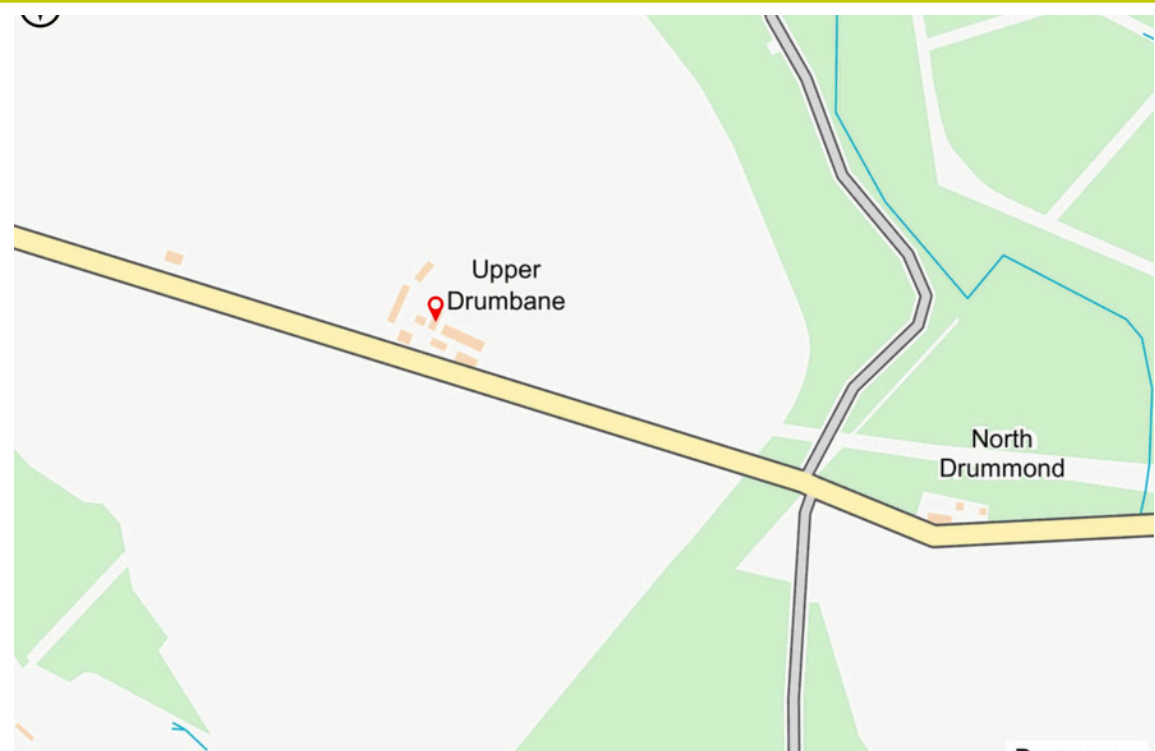
