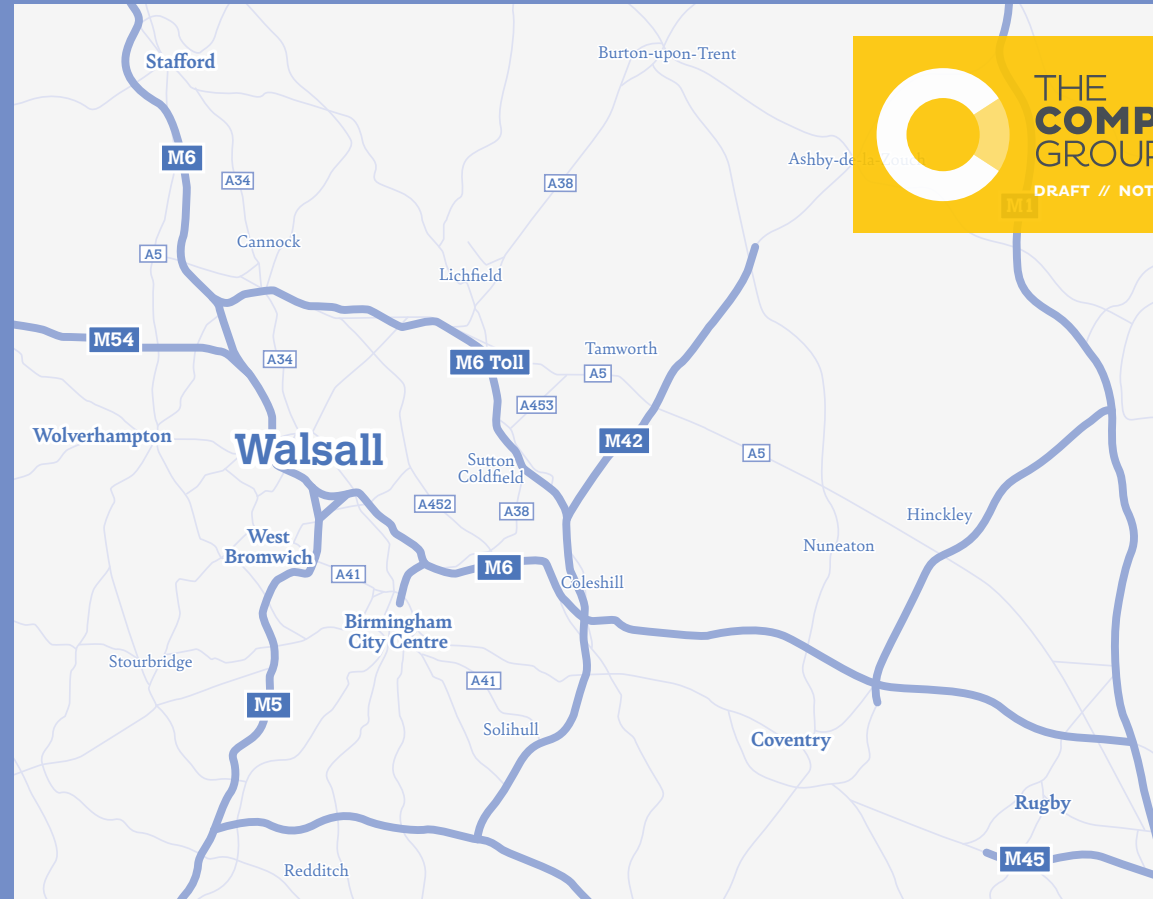
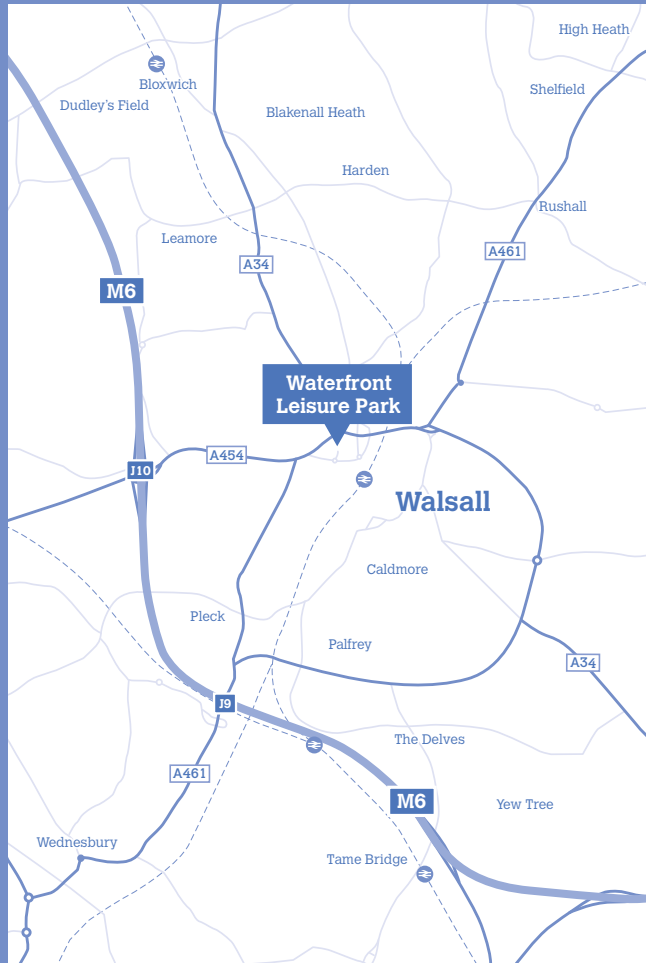

Location

Walsall is located 9 miles north-west of Birmingham and 7 miles east of Wolverhampton. It is accessed via junctions 9 & 10 of the M6 to the East and the A34 to the North and South.



Situation

Waterfront Leisure Park is located at the northern edge of Park Street and is accessed via the Inner Ring Road A454 and Blue Lane West (A4148). The Leisure Park forms part of the main out of centre retail and leisure offer within Walsall sitting opposite the Crown Wharf Retail Park

whose occupiers include Aldi, Tenpin Bowling, Ninja Warrior, Asda Living, Argos, PureGym, JD Sports and Smyths Toys. Adjacent to the Leisure Park is a Premier Inn and other nearby occupiers include Tesco Extra and McDonald's.

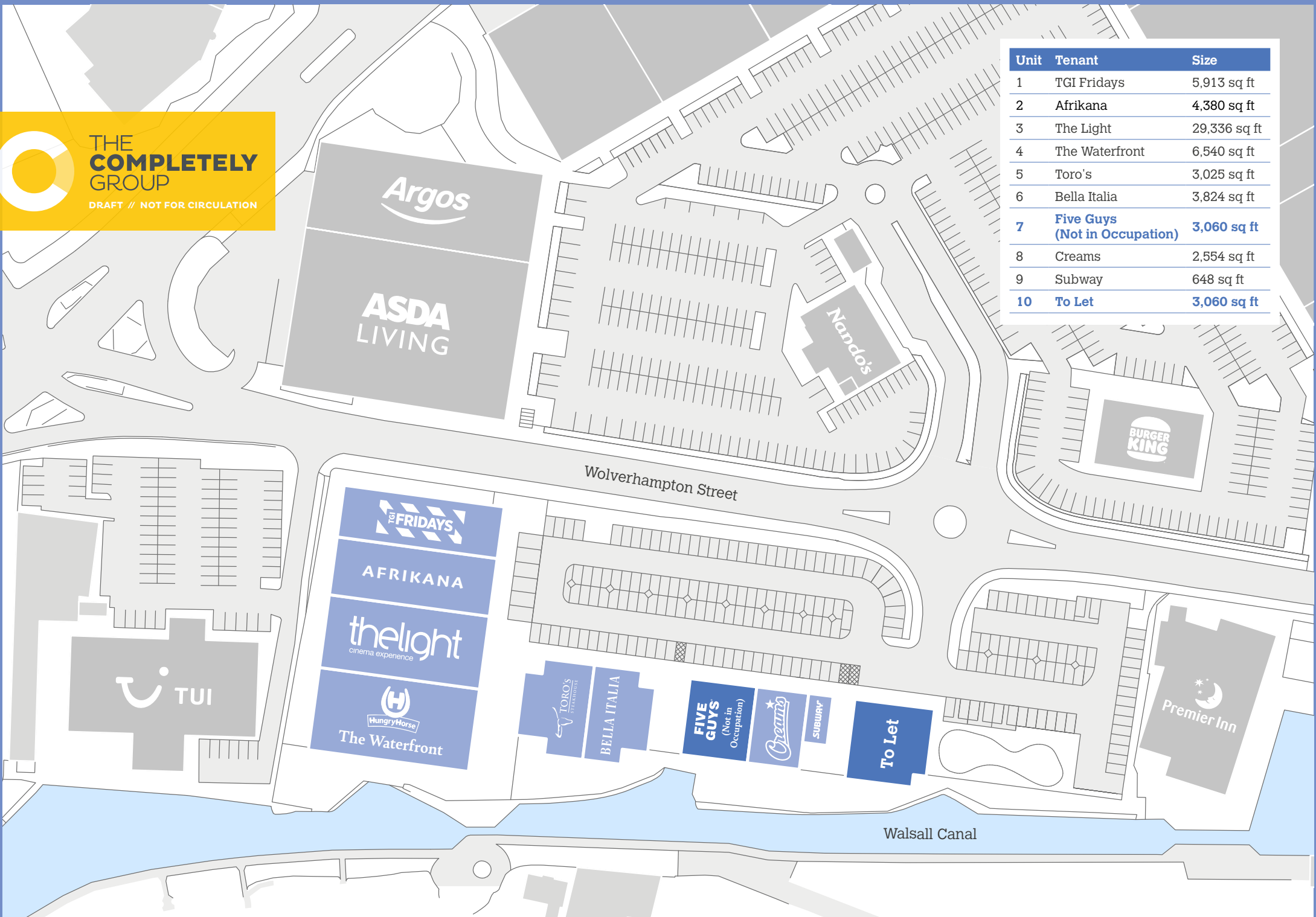
