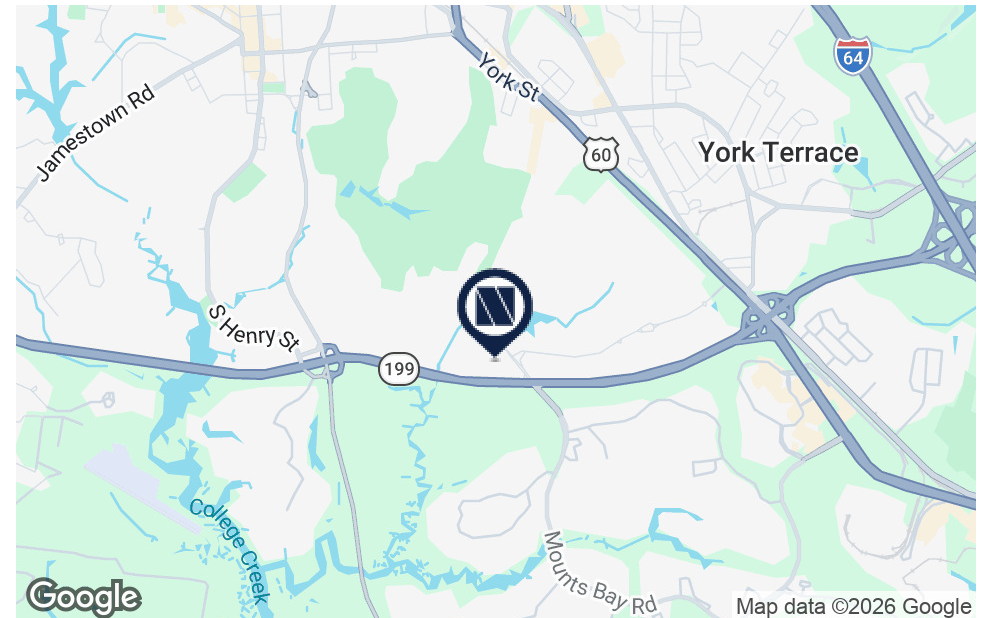

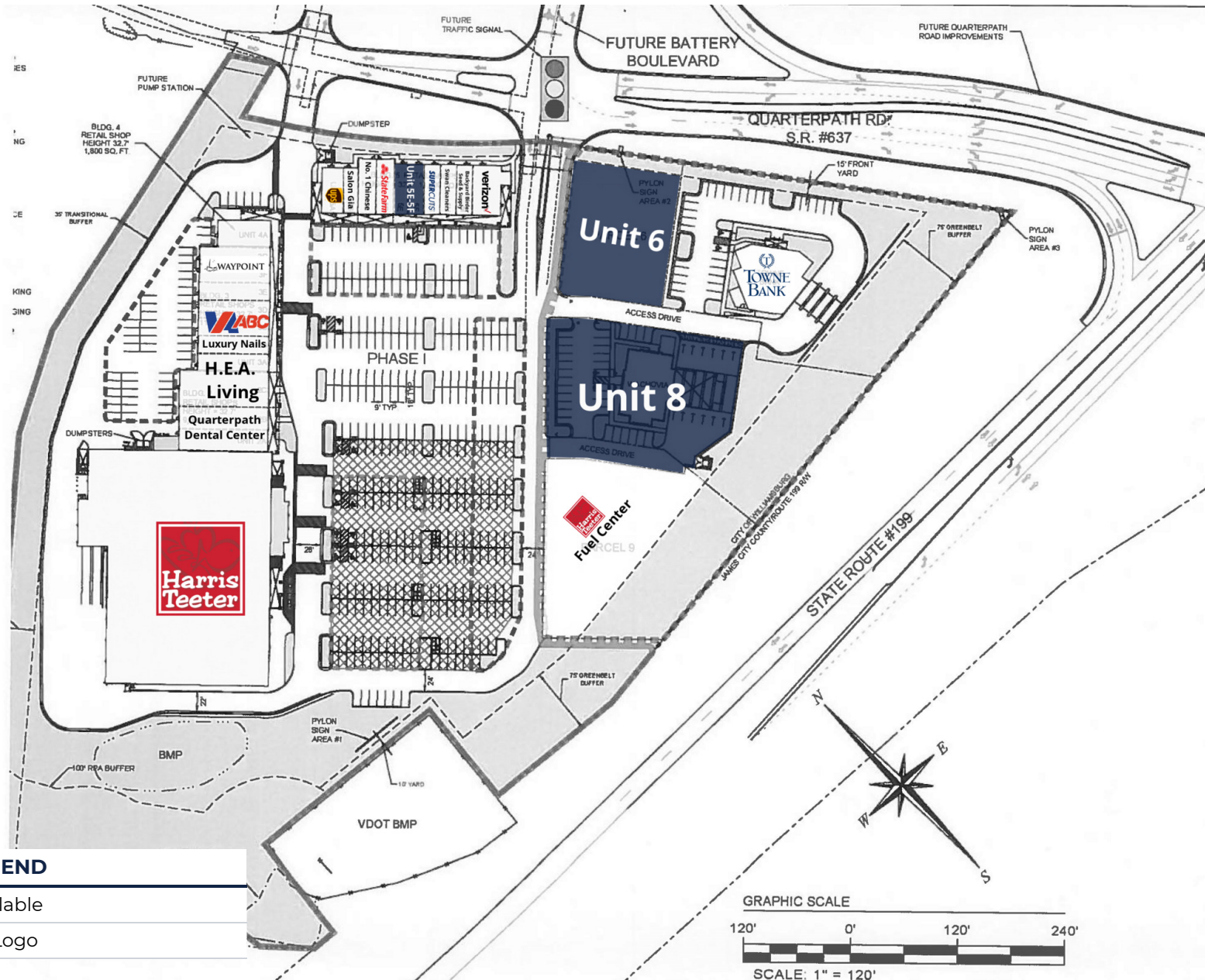
SITE PLAN

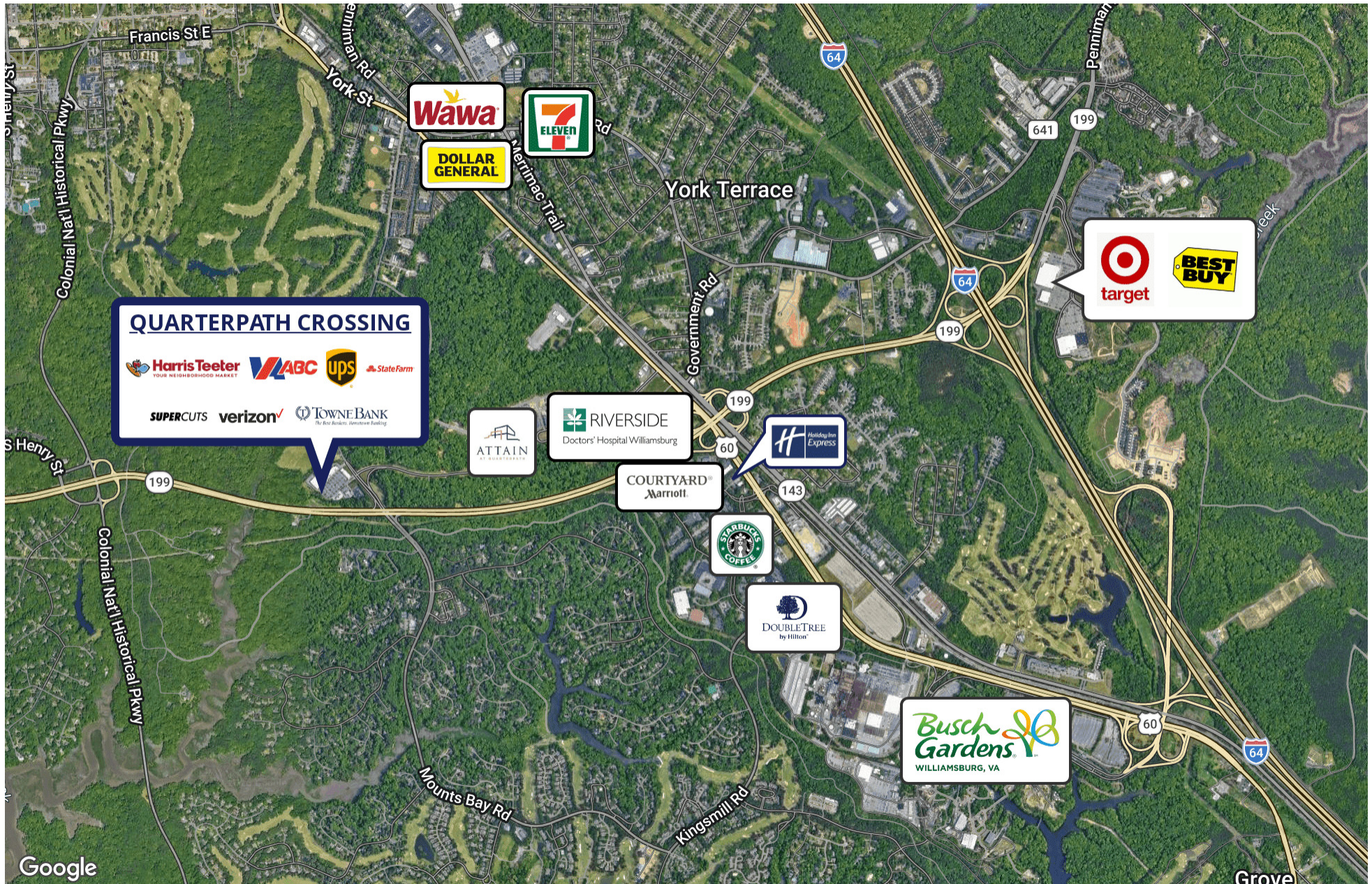
RETAILER MAP
