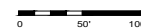
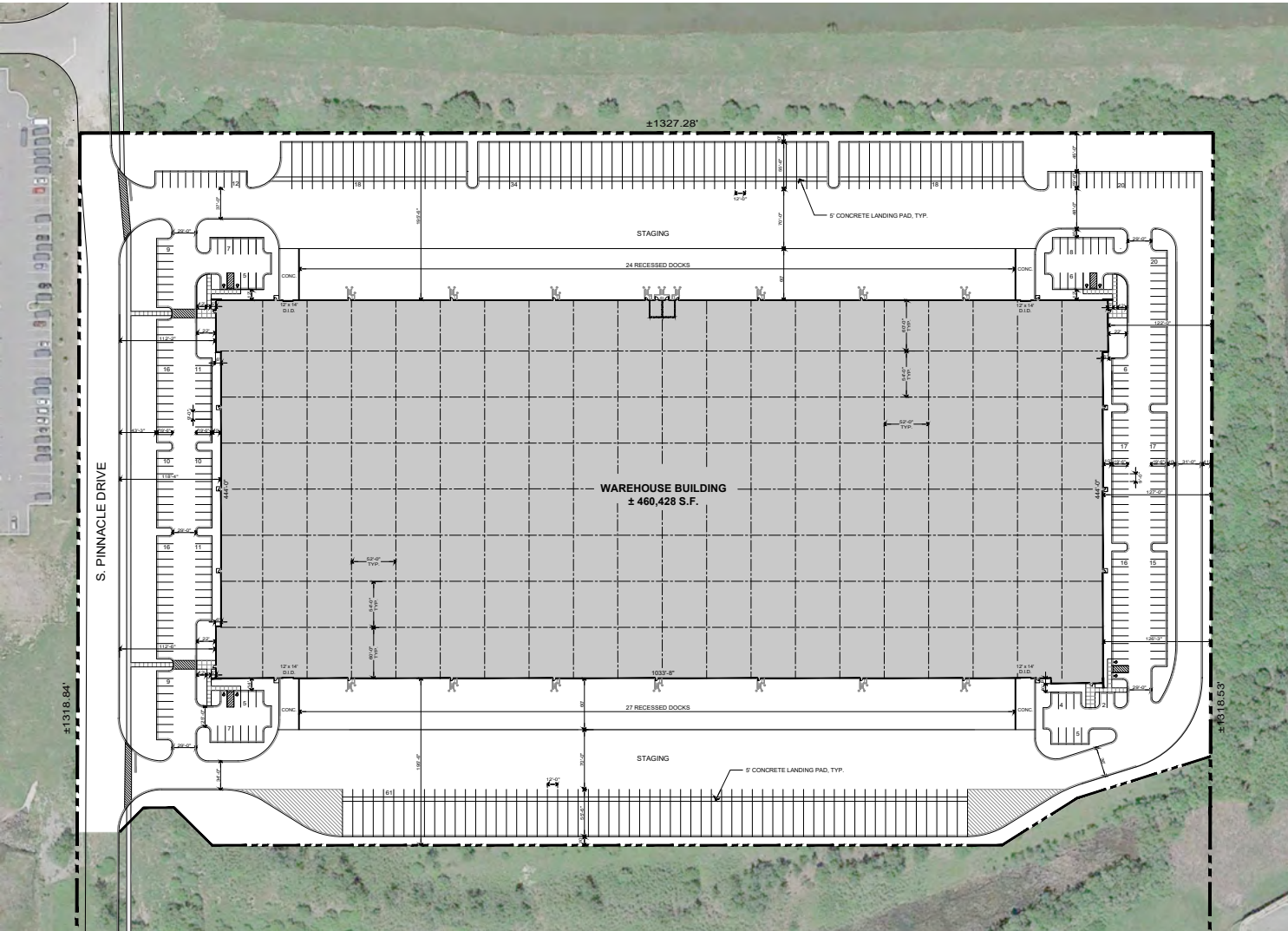

LogistiCenter® at Romeoville offers a prime location with convenient access to abundant skilled labor and a wide array of nearby retail amenities.

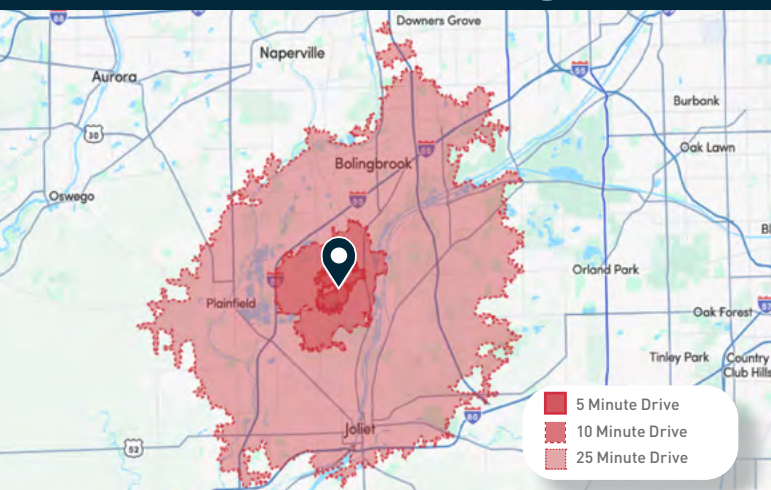


Labor Demographics
