LOCATION

Burgess Hill is located close to the border between East and West Sussex, 10 miles north of Brighton and 13 miles west of Uckfield. The town has a population of approximately 30,000 and is served by regular rail services to London Bridge/Victoria (50 mins). Burgess Hill is home to four business parks housing nearly 200 companies. The property is situated close to Burgess Hill mainline train station on Station Road, which adjoins Church Road, home to the main amenities & retailers in Burgess Hill including The Martlets Shopping Centre. The A23 is approximately 4 miles to the west and provides direct links to the M23 & M25 both east & westbound. DESCRIPTION

A self-contained retail/storage unit which is located in a prominent position on Station Road within a short walk to the mainline Burgess Hill Station. The property is split across two floors with ground floor laid out as open plan retail/office and ancillary space, with the lower ground formerly used as open plan store and workshop. 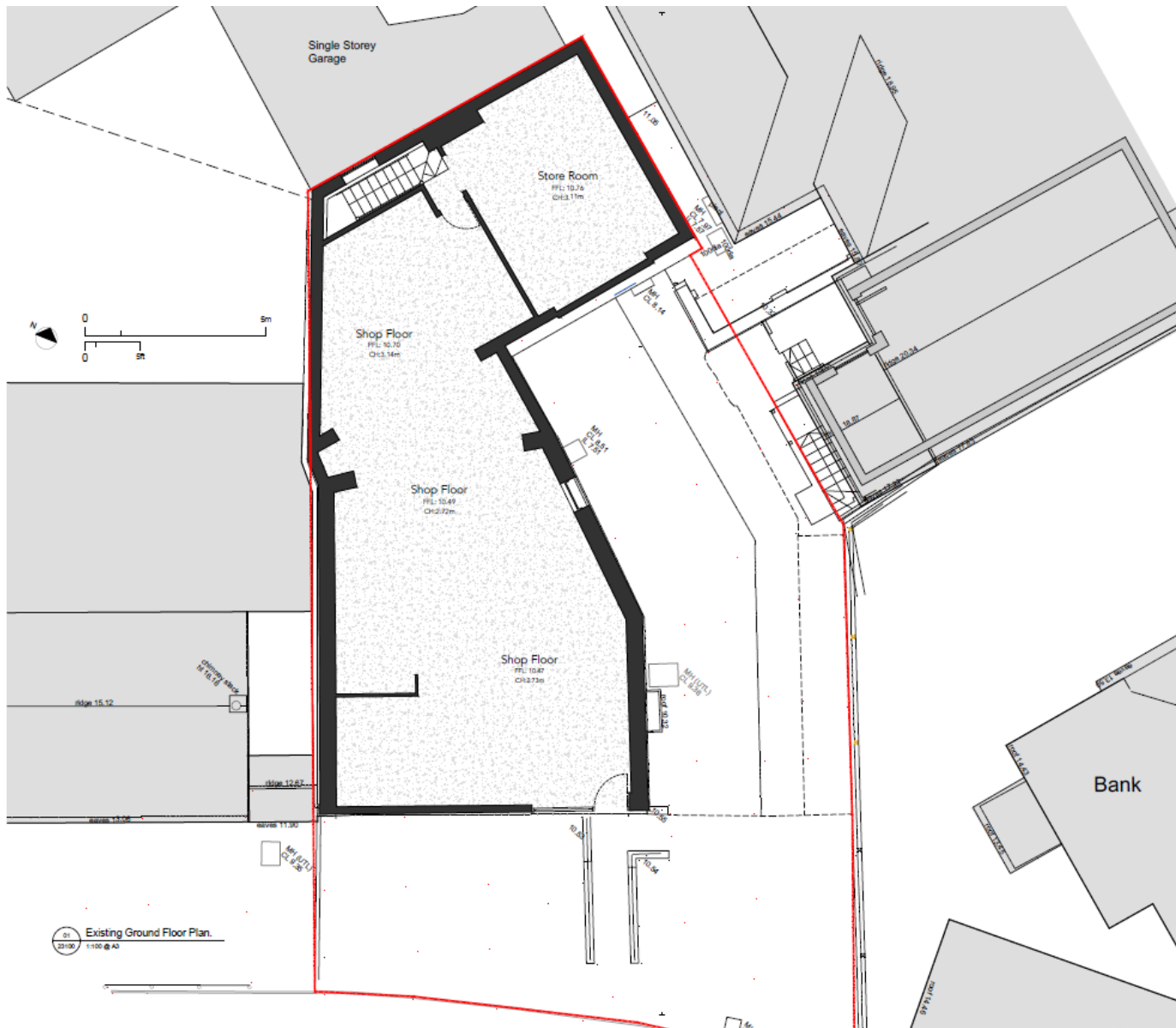

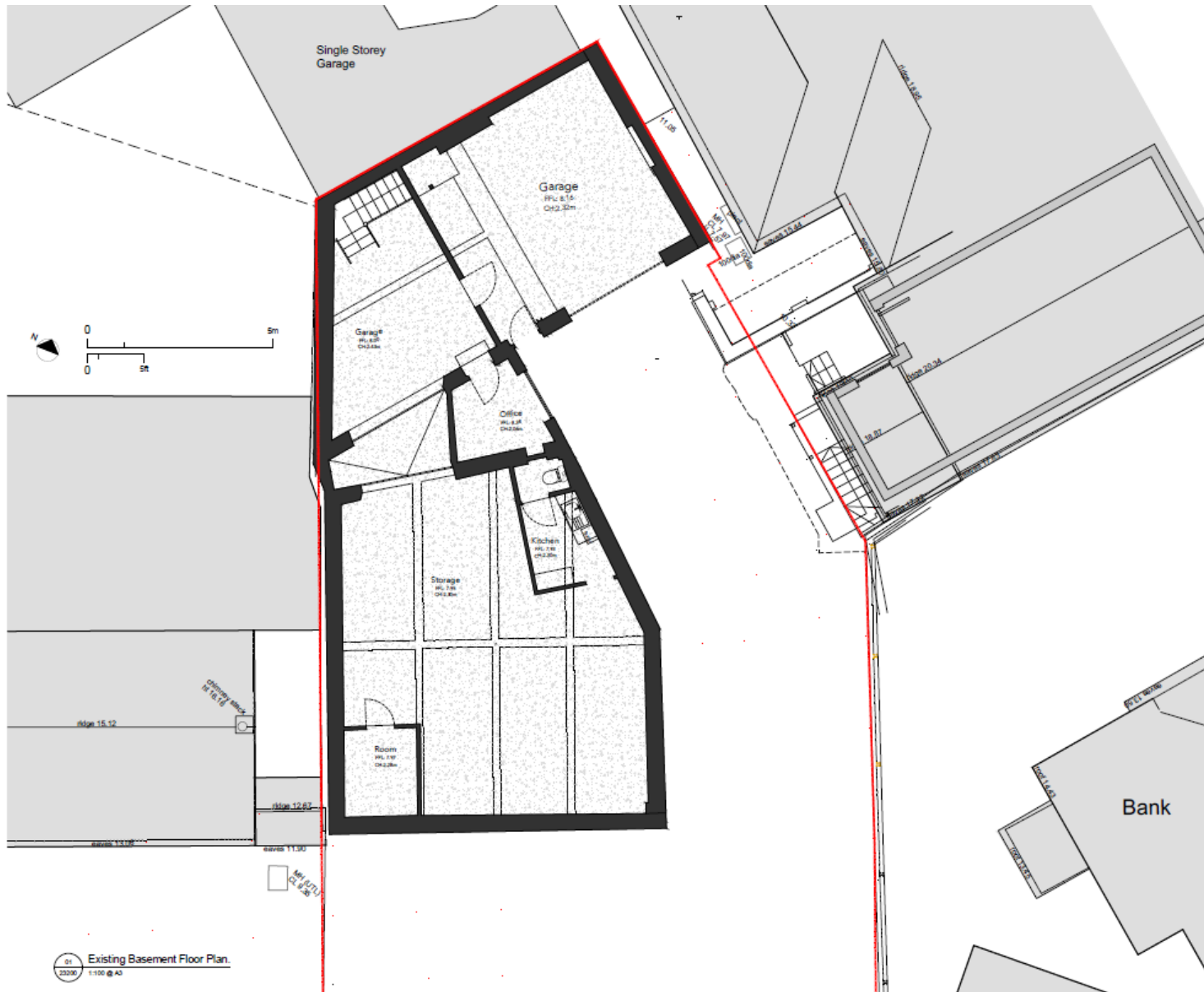
